The Fowlerville Senior Citizen Center contacted Michael Shafer, Director of Family Impact Centers, and asked if we could partner with them by hosting a food drive to benefit their pantry. He welcomed our effort to assist the Family Impact Center and our community as a whole.

Michael advised they have received great support from the community but they were still a little low on some items.

Over 15% of the families the Fowlerville Impact Center serves are classified as “seniors.” Even more interesting is the average age of regular volunteers that serve at the Family Impact Center is 71 years old.

If you can help us fulfill the Family Impact Centers request, bring your food donations to the Fowlerville Senior Center, at 203 N. Collins between 8:30A and 2:00P and help us fill our boxes and tables with food donations.

People have told us they don’t know where the Fowlerville Senior Center is located and many have driven by our building not seeing our sign above the door. To be honest, the sign was hard to see. We’ve taken care of our small sign issue by having W4 Signs design and install a new, larger, more colorful sign on the front of our building.

Fowlerville High golfer sets new school records with 9 & 18 hole scores

Keira Mahon, a member of the of Fowlerville High School Girls Golf Team, has set new scoring records. In this year’s 2024 season, Keira broke the all-time Fowlerville 9-hole lowest scoring record with a 40 at Oak Lane on Sept. 24th, and the 18-hole lowest scoring record of 82 at Wheatfield on Sept. 19th in Williamston.

The previous 9-hole record was held by two-time individual State championship competitor Annika Scott with a 42 in 2020 and the previous 18-hole record was 85 by Annika Scott in 2021.

Keira, a senior, has medaled, finishing top 10 or top 25 in three of her four 18-hole invitationals.

What are you sowing?

“Do not be deceived; God cannot be mocked. A man reaps what he sows. The one who sows to please his sinful nature, from that nature will reap destruction; the one who sows to please the Spirit, from the Spirit will reap eternal life. (Galatians 6: 7-8)

From these verses, many of us have used the short coined phrase “you reap what you sow”. There’s a lot of truth behind this short sentence that describes an outcome based on creating or planting—in the case of what Paul meant when he wrote this portion of his letter to the church of Galatia—is choices being made that fed a sinful nature versus those which originate in following the Spirit of God.

This past gardening season I was so excited to plant some spaghetti squash seeds that I had saved. We don’t have a large area for vegetable plants and I chose a spot where the vines could either climb a trellis I placed or spread into the yard. Imagine my delight as the vines began to grow, gain strength and flower, all that a plant is expected to do. In July I noticed I had a spaghetti squash as large as a ripe watermelon. It

was not the usual golden yellow color; it was striped like a watermelon. I didn’t think it would even fit in my oven so I discarded it. Several weeks later I was very pleased to find a nice size spaghetti squash on a vine. When I baked it, the beautiful flesh inside did not “produce” the common expected shreds of “spaghetti” strands, yet it tasted very good.

I also found a very large squash that turned yellow, and when I checked it a few days later, I noticed it was continuing to change color as it also was growing to the size of a watermelon. Thinking “what do I have to lose”, I let it go until one afternoon I checked on my “squash”, only to find it had ripened into a large bumpy orange fruit. Curious beyond any understanding, I used the app on my phone that identifies plants...I had myself a beautiful pumpkin!

I had planted spaghetti squash seeds. And while I DID get several beauties, they weren’t what I fully expected. Such is how we humans behave. We cannot sow seeds of discord and expect everyone around us to enjoy our company. We cannot plant bitterness and hope to be happy. We cannot get caught in vicious gossip only to want others to trust our secrets when we disclose them to a friend who actually has loose lips. We cannot ignore the commands of God which tell us earlier by Paul in Chapter 5 of Galatians: *“The acts of the sinful nature are obvious: sexual immorality, impurity and debauchery; idolatry and witchcraft; hatred, discord, jealousy, fits of rage, selfish ambition, dissensions, factions and envy, drunkenness, orgies, and the like”*. Ouch. Or should I say this is a painful spiritual “ouch” by what Paul is pointing to, listing here behaviors that do not please God and thus, a short time later in his letter, declaring that such behaviors will not reap eternal life.

One need not look too far inside our current culture to identify people who have fallen trap by any of the behaviors Paul warns about that will negate eternal life. In fact, if you and I can be totally honest with ourselves, a glimpse into a mirror will quickly reflect our own shortcomings which leave us with two choices. First, as a follower of Christ will we continue to pursue selfish sinful lives or two, will we make a U-turn and seek to embrace and understand that God’s way—His desire for us—is to thrive under sincere attempts walking on a path of holiness.

I like Paul’s boldness. I like how in the book of Galatians we are shown how much he loved this church, using strong words to admonish them when they strayed from the gospel (Ch. 1: 6)

Do you struggle being told what to do? While there may be authentic times to rebel due to personal convictions, I think Paul makes it very clear that for Christ followers there are two options. One leads to destruction; the preferred one delivers eternal life. Imagine our world if more of us truly chose option number two.

THAT would be a beautiful garden to behold!

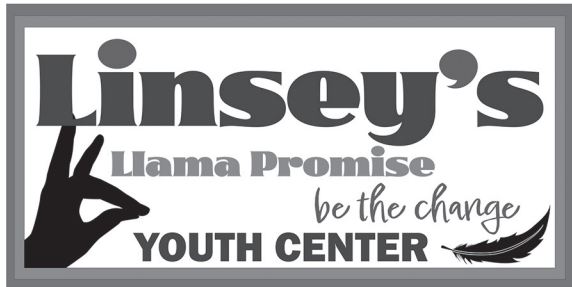

Critique of present-day mental health treatment in Michigan, plus the current debate on restricting guns

Commentary by Nancy Manson

(Editor's Note: This is a two-part look at mental health treatment by area resident Nancy Manson. She worked at a mental health facility as a young student-nurse and had first-hand experiences with those suffering mental illness during her long career as a nurse in the health-care field. She has kept tabs on this issue since her retirement. In last week's Part I article, she offered a history of mental-health care at some of the state hospitals that operated nearby before being closed and how the closures were due to a change in approach on treatment.)

Current Issues which Impact Treatment

According to data from the Citizens Research Council of Michigan published in 2020, Michigan has a total of 3,195 inpatient hospital beds spread across dedicated inpatient psychiatric facilities and acute care hospitals to serve adults and children. This was published in *Crane's Business Detroit*.

This number is not enough to serve Michigan's population of nearly 10 million. In fact, since 1993, the number of psychiatric beds available in Michigan has decreased more than 30 percent.

However, adding beds is not the solution because we do not have enough of the right kind of professionals to staff these beds and serve more patients. Michigan has 11.84 psychiatrists per 100,000 residents in the state overall, and 33 of the 83 counties do not have a single psychiatrist. As of 2019, Michigan ranked third in the shortage of mental health care professionals, surpassed only by Texas and California. This makes access to care in rural areas for behavioral health services nearly impossible.

Patients, particularly adolescents and children, have few places to turn for care after experiencing a mental health crisis.

Children and adults with intellectual and developmental disabilities are at risk for long stays in the emergency department of acute care hospitals. This setting is not equipped to handle complex behavioral health patients.

Bed availability for children and adolescents with complex needs is limited and providers are forced to hold patients in acute care settings, sometimes for weeks or months, while seeking appropriate placement for treatment. It is unacceptable for these patients, their families and the caregivers trying to manage their treatment and keep them safe. It also leads to violence against healthcare workers that is escalating at alarming levels.

Additional financial resources and cooperative planning dedicated to behavioral health could create transformational improvements to our current broken and fragmental system.

The Michigan Hospital Association believes an appropriation to fund additional support for pediatric behavioral health, a grant pool to improve behavioral health care in emergency departments, and recruitment support for behavioral health providers will have significant and lasting improvements in access to care and quality. This appropriation will help address a major barrier to improving access right now, which is the lack of trained and educated behavioral health providers. It would help modify the way emergency departments are prepared to temporarily care for patients in crisis, especially Michigan's children. These resources will not fix everything. However, they will start the process and provide critically needed relief to some elements of our care delivery system that is crumbling before our eyes, leaving patients in the rubble.

An estimated 1.3 million Michigan residents have a mental health condition (2019 research by the National Alliance on Mental Illness). About 38 percent of these individuals and 80 percent of those with substance use disorders are not receiving care. Nearly one in five Michigan youths had at least one mental health condition and in Michigan, where the prevalence of mental health disorders nears national figures, 13 percent reported having a depressive episode in 2017. Of those experiencing depression, fewer than half have been able to access care. As of March 2021, Michigan had a total of 389 in-patient psychiatric beds for children and adolescents. There were 729 beds in 1993.

Over 4.2 million Michigan residents live in shortage areas, a designation of areas that have a shortage of health professionals. A capacity of 40 to 60 beds per 100,000 population is recommended by some professionals, but more research is needed on that issue. The dearth of psychiatric hospital beds is not happenstance but, rather, the result of past policy decisions in Lansing which closed the state's inpatient psychiatric hospitals without providing the necessary infrastructure and funding to build and maintain adequate alternative and community-based sources of treatment. Therefore, without adequate capacity for inpatient psychiatric care, many patients linger in hospital emergency rooms or jails without receiving needed treatment.

Even with the passage of mental health parity laws (meaning insurance must provide comparable treatment for mental health conditions as for other health issues), many individuals cannot afford or find covered treatment. Fifty-three percent were unable to afford treatment with their insurance. Over 300,000 privately insured went without treatment and about half of the Medicaid-enrolled Michiganders received the treatment they needed. Some are told by their insurance companies that treatment is not medically necessary and won't be covered.

Current Societal Issues of Concern Caused by Inadequate Diagnoses and Treatment of Mental Health Conditions

In 1958, I completed my three-month psychiatric nursing rotation at Northville State Hospital as a requirement of my three-year hospital nursing program. I was in a group of 10 students assigned to one of the back, chronic male units called M Building at Northville. This building housed about 110 men (as I recall) who were severely mentally ill. The greater majority had diagnoses of schizophrenia (mixed or

paranoid in type). The few left, as I recall, had a diagnosis of organic brain syndrome (generally caused by brain injury). Our building also housed a psychopath and a sociopath, we were told (with accompanying warnings). They were both charming men. Essentially, the 10 of us were the activity directors for the unit.

Thorazine and Haldol were the main medications used for treatment of our residents. Today, the medications are much improved (if only the patients would reliably take them).

During those three months, I felt as if I were totally immersed in schizophrenia. Our residents were constantly hallucinating and speaking to their voices. Some were totally inactive and wouldn't move out of their chairs during the day. Occasionally, you would see them talking to someone who was not there.

Our unit also had two pleasant, fit, male attendants in addition to a female head nurse. Once a patient began to lose control of his behavior, the attendants were immediately on each side of him to escort him to the locked unit in the main building where the psychiatrist would monitor him and change his medication program if necessary. When his behavior stabilized, he was returned to his building.

Each month there was excitement in our building. The residents kept checking the head nurse's office to see if their monthly allotment of tobacco and papers had arrived. They had to roll their own cigarettes. The state provided that "benefit" to all the residents who requested it.

I was living out of state when I heard about the governor's decision to close the state residential mental hospitals. My first thought was, "This will not end well." There are mentally ill individuals who are too unstable (and dangerous) to live in society. Also, there are mentally ill, harmless souls, who are unable to care for themselves in society. They are the vast majority and the ones who are sleeping over steam vents by large buildings or in makeshift tents on the street. Often, they are unmedicated or improperly medicated and use street drugs.

We have children with years of history of maladaptive behavior who, as they mature, become killers. Think of the school killings in Colorado; Sandy Hook; Florida; Oxford, Michigan; and last month in Winder, Georgia. The Florida killer had known behavioral problems since preschool and was seeing a psychiatrist and psychologist by age three. With all that was known about that young man, he should have been in a locked facility, before he saw an opportunity to kill.

This most recent killer in Winder, Georgia, was flagged to the police and the FBI last year as a 13-year-old. His father allowed him to have access to an AR-15 hunting rifle

Personally, I believe we should start making some of these parents, who do nothing to obtain proper treatment and cause these horrible killings by their own inappropriate actions. I do believe they should be charged in the legal system. Who, in their right mind, with a child with known mental and emotional instability, would provide them with a gun—or any weapon?

For those who think guns are the problem, not people, I would like to disabuse you of that thought. It is more difficult to obtain firearms in Europe and the British Isles. Over the past several years, knife attacks have been escalating in those countries. The British Isles' worst attack occurred in 1996 when a 43-year-old man shot and killed 16 kindergarten pupils and their teacher in Scotland. The United Kingdom subsequently banned the private ownership of nearly all handguns.

Not long ago, a 17-year-old boy entered a children's dance and yoga class near Liverpool, England. With a knife, he killed 2 children and wounded 11 other people. Two adults and six children were critically injured. There have been several other knife and machete attacks across Europe and Great Britain in recent years.

In conclusion, I would like to refer back to the law concerning Michigan's responsibility to its residents with regard to mental health treatment.

The 1919 Michigan Mental Health Act stated the Department (of Health) shall support training, studies, and research as part of its overall responsibility with regard to the prevention of mental and emotional disorders, and the care, treatment, and support of individuals with mental and emotional disorders and disturbances.

I, for one, have come to believe that mental health treatment is the unwanted stepchild of the physical healthcare system. These people are every bit as sick as those requiring traditional medical healthcare and their needs are not being met at all.

The lack of available inpatient and outpatient treatment for these people in this affluent western democracy is a national disgrace and has been for many years. We have trillions of tax dollars to waste on foreign aid, questionable Green New Deals and billions to spend on illegal immigrants in the form of food, housing, education and medical care which are not available to poor American citizens.

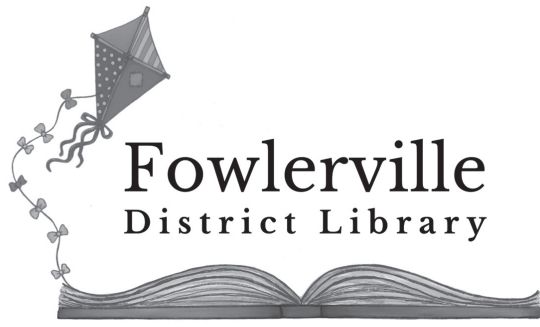

Michigan Governor's Report

Lower costs for teachers, supporting students

I know that a high-quality public education is the foundation every Michigander needs to build a great life, and that starts with investing in our students, educators, and schools.

That's why I am proud that, this week, my partners in the Michigan Legislature passed commonsense legislation to lower costs for qualifying teachers on every paycheck and free up additional resources for local school districts to invest in classrooms, computer labs, and libraries, expand on-campus mental health, or shore up campus safety.

Lowering Costs for Teachers

Our educators work hard. We must ensure they are supported now, and in retirement.

This new legislation will permanently end the state's 3% tax that many public school teachers pay into a health care fund for their retirement, putting money back in their pockets to pay bills and build a life here in Michigan.

This increased cost was imposed on tens of thousands of our veteran educators over a decade ago under my predecessor. This past week, my partners in the Michigan Legislature made it right. I am grateful to Senator Darrin Camilleri, Representative Jaime Churches, all my partners in the Michigan Legislature, and the countless allies and organizations who worked so hard to get this done.

This package of legislation also includes a supplemental education budget providing \$125 million in additional funding for school safety and student mental health.

--The new balanced, bipartisan budget for fiscal year 2025 increases per pupil funding by 4%, representing an average \$400 more per student. Local school districts will have the flexibility to invest these funds where they are needed most, such as supporting student mental health, enhancing school safety, or strengthening the educator workforce.

The new budget also lowers costs for teachers, continues support to help current teachers pay back their student loans, and supports aspiring educators with the MI Future Educator Fellowship.

We are making record investments into classrooms without compromising the retirement or health care benefits of a single public

school teacher or retiree.

Improving Outcomes in Our Classrooms

To build a brighter future for Michigan, we must ensure our students have the skills they need to succeed, including literacy, which is directly tied to lifelong education, income, and health outcomes.

This commonsense, bipartisan package will allow teachers and tutors to use proven science of reading strategies to improve literacy. It will also strengthen professional development for our educators and provide more support and screening for dyslexia and other learning challenges.

I am grateful to Senator Jeff Irwin, Senator Dayna Polehanki, all my partners in the Michigan Legislature on both sides of the aisle, and the many stakeholders who prioritized this issue.

Together, we will help even more students read at higher levels and move our state forward.

Michigan High School Coaches Association recognizes Dan Coon as the ‘Girls Coach of the Year’ for 2023-24

Girls wrestling is recognized as the fastest growing sport in the United States. The Michigan Coaches Association ran the pilot Girls State Championship in 2018 to get things started. Covid slowed it down for a year and it’s been multiplying since then. The MHSAA adopted Girls Wrestling as an individual state championship in 2021.

Fowlerville Wrestling has always included girls but only as individuals up to the last couple of years. We’ve had girls like Megan Williams, Paige Rife, Tia Kingsley and Kinner Philburn (all maiden names) in the past come out for the sport of wrestling because they had brothers in the program and the parents saw it as a worthwhile adventure.

More recently we’ve had girls like Gabby Damerow and Hannah Arledge-Teran that were ready to step away from the normal stereotypes of girls sports, at that time, and give it a try. All have gained confidence and a “go get em” attitude from the sport. We are proud of our wrestling history with both the girls and guys.

This Award/Honor has Dan Coon’s name on it but it is truly a team effort. Our High School staff of Craig Zube, Sean Harvey, Aaron Davis, Sam Blyveis, John Jelken, Caleb Medina, James Testerman and in the past Jarod Philburn, all offer a different viewpoint that relates to different people. Our coaching staff cares and is willing to work with anyone that wants to put in the effort. We are basically on the same page and want the girls to be successful. For different girls success means different things. It might be for some, winning a match. For some it is the physical conditioning improvement. For others, it is the study hall time that we spend to improve the grades. For others it is that state championship and proving to others you are the best at your weight that particular year. Whatever the goal for success is, we as a staff and a team try our best to help the girls reach their own goals.

Beside the adult coaches in the room, we have about 50 guys ready to help train the girls team. Girls have the option in our room to choose their partners to practice with. The girls can choose other girls to practice with whatever weight they may be. They can choose to wrestle live with the more experienced guys, or the less experienced, in some cases. The guys team, about 90% of them, have learned that when you are wrestling, it is not a male or female opponent, it is an opponent. It’s off the mat experience that we treat each gender differently. We have a good group of supporting wrestlers.

In the 2023-24 season, we were blessed to have the most girls ever show up. We had 12 to 13 regular girls and a couple of those were recruited to fill in the missing weights but most were spaced out among the 14 weight classes. Girls weight classes range from 100 pounds to 235 pounds. It’s kind of interesting that we have had two of the best girls in the nation the last couple of years in our county: Eliana Bommarito from Hartland, a four-time national champ, wrestled at 235 and Sabrina Nauss from Brighton, a four-time state champ, three-time national champ and Wrestler of the Year for Michigan, wrestled at 195, but Fowlerville wrestling has had troubles filling the top three weight classes of 175, 195 and 235. You do not have to weigh that exactly, you just have to weigh below that weight to wrestle there. A girl weighing 190, for example, could wrestle at 195 or 235.

We were not just blessed to have the quantity of girls but also the quality. That may be one of the reasons for the program award last year. We had five state qualifiers.

Maggie Buurma won her third state championship. Little sister Anna placed as a freshman. Hannah Blyveis placed for

her third time at the state meet. Morgan Jenks (basically a first-year wrestler) and Kiely Davis both almost placed at the state meet. We had a couple of others knocking on the door at the regional level. Good girls in the program and ready to help others. We won the conference meet (first ever offered by the CAAC conference) by a landslide and won every one of our duals despite giving up some weight classes.

From Hannah and Maggie: “There is a certain understanding about barriers that women’s wrestling is thought to have. Certain things like weight checks, uniforms and practice partners/opponents scare high school girls away from the sport of wrestling. However, through accepting coaches and an inclusive team atmosphere has broken the barriers and made the wrestling environment more welcoming to the girls. Things like uniforms have been made to be more comfortable for everyone. Girls have the option of wrestling only girls, which many of the current girls choose to do. Weight is not as scary as many make it out to be. We do separate weigh-ins from the guys and you do not have to share your weight if you are not comfortable sharing. Improvement is necessary in a growing sport and the Fowlerville community is still learning and improving as we go. As a whole, our wrestling community is one of the best around for female wrestlers.”

Fowlerville Wrestling’s future is bright. Our youth club, WOW, has great boys and girls coming through the program. We have some parents that are great as coaches and supporting parents that are doing the right things for the kids. Kids are not miniature adults and they do make mistakes, but what better way to learn how to get in better shape, learn the right foods to eat, learn that school work is important, and time management is a learned skill all though the sport of wrestling. WOW sign-ups are Nov. 11

This year, our girls team is faced with the challenge of a state championship. This is the first year MHSAA will be keeping track of team points to determine a Girls State Championship. Not like the guys who have a dual state championship, girls will get there, just not yet. This state championship is based on our individual placement at the state meet and a team championship will be awarded. Last year we finished in the Top 5. This year with three returning placers, another state qualifier, as well as several high regional pacers, we will be ranked high to win the title this year. We need more girls to reload for the great girls that graduated: Morgan Jenks, Leah Clark, Lissy Williams and Ikbol, our exchange student, and of course to fill those upper weights. We are challenging others to beat us as we earn the first-ever girls state championship.

I did not get this award because I did something new or different in the 2023-24 Wrestling Season but because I’m surrounded by some great coaches, wrestlers and parents that other people took notice of what we did last season.
