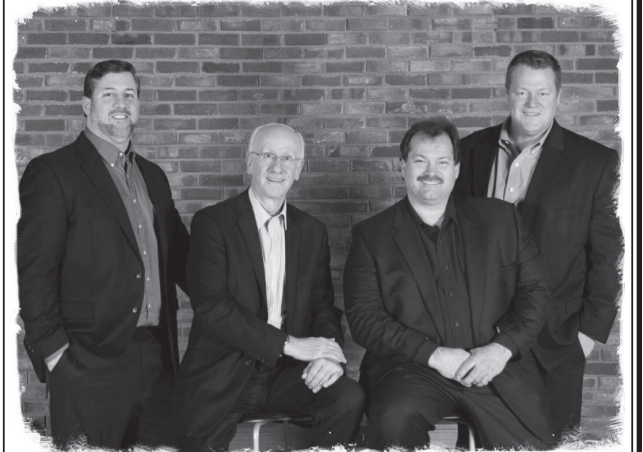

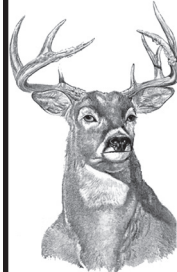

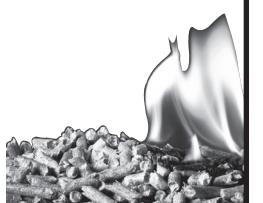

## Memorials & Markers

Definition of memorial: *Anything intended to preserve the memory of a person or event; something which serves to keep something else in remembrance; a monument.* (American Heritage Dictionary)

Last week I wrote about an upcoming trip we'd be taking to the state of Pennsylvania, with intentions to visit Gettysburg, specifically their National Military Park which commemorates the battles that took place during the Civil War. With much gratitude, we were successful and spent the majority of last Thursday touring the grounds. We had the privilege and comfort of our vehicle to listen to a narrator via the National Park "app" on a smart phone at each spot along the route which took us about three hours to complete. Our day in the park was wrapped in a slight breeze under sunny skies with a very comfortable temperature in the high 70s—perfect for getting out at our leisure to take in all the views that many of the locations offered, especially those that were atop a tall hill or ridge.

A very brief look on the Wikipedia site for information about the Gettysburg Battlefield revealed there are 1,320 monuments and markers. Some of them are on private land near the battlefield and around the town itself. Stopping to read each one would have been very time consuming, yet as we did,

and especially as I stood on Little Round Top, looking down on the land below, I couldn't help but feel a heaviness in the air as I tried to imagine the events that took place 161 years ago.

I think studying history and remembering events from long ago are important to a person as we each grow and mature, cultivating our belief systems, establishing in our hearts and minds what is good and worthy of honoring and applying lessons from events to help form our character traits. Woven into world history is that of our own nation. Also included in world events are those from our ancient world or what some may refer to as "biblical times".

Memorials can be traced back to the time of Moses. When given his mission from God to go deliver Israel from Pharaoh, Moses asked God His name so he could tell the people. In Exodus 3: 15 God answers his question "Thus shall you say unto the children of Israel, The Lord God of your fathers, the God of Abraham, the God of Isaac, and the God of Jacob, has sent me unto you; this is my name for ever, and this is my memorial unto all generations". A newer translation of this verse drops the word "memorial", using the word "remembering" instead.

Other memorial events in Old Testament history include when the Israelites placed a "marker" when God did something significant for them such as when crossing the Jordan River. After crossing, they carried 12 stones obtained from the middle of the river and stacked them as a tangible reminder of what God had done.

In our own lives, we too can place a "marker" when God does something for us. It may be the time we recall becoming His child by placing our faith in His Son, Jesus Christ. Perhaps you went through a very difficult season of life and can identify that God was present in those tough circumstances. Maybe He provided for you when doubt weighed heavily on seeing a way out from underneath the pressure of worry. Whatever the problem, whatever the outcome, we can place a faith marker in our lives to remember God's goodness. How do we do that? Do we stack a pile of stones after crossing over a tough situation? Practically speaking, no, but what we can do is write it in our hearts, or perhaps keep a record of it in a personal Bible or journal.


In past years our grandparents and great grandparents kept a list of significant events in the family. I have copies of such a list from our Jewell family Bible that show births and marriages dating back to the early 1800s. It's very intriguing to read the names and try to imagine what each earlier ancestor was like as a person and what their lives entailed.

I'm happy we visited Gettysburg. I'm inspired that no matter where my mind takes me into a variety of adventures through history—whether it's events of our nation or the accounts written about in the Old and New Testament—memorials and markers have been placed by those who have gone before me to remind me that "something happened here". I think that's excellent instruction for me to pay attention every day to look for God's presence in my life and later reflect on how He "showed up and answered a prayer or worked out a situation".


I hope that you'll think about memorials and markers in a new light. I pray that life doesn't throw more than you can handle, but if it does and you come out on the other side victorious—you'll place a "marker". Doing so will increase your faith and leave a legacy for future generations to glean from, just like I did at Gettysburg and in the pages of our Jewell family Bible.

## Seats on Fowlerville School Board, Village Council & Township Boards being decided in Nov. 5<sup>th</sup> Election

While the Presidential race between Democratic nominee Kamala Harris and Republican Party standard bearer Donald Trump understandably have created a good deal of interest this election cycle, dominating the news headlines and TV advertising, there are other races being decided in the upcoming Nov. 5<sup>th</sup> General Election.

Among them are open seats on the Fowlerville School Board, the Fowlerville Village Council, and the township boards of Conway, Handy, Iosco, Cohoctah, Howell, and Marion.

Both the school board and council seats are on the non-partisan ballot, while the township board races are part of the partisan ballot with candidates from the Republican and Democratic parties listed as well as No Party Affiliation.

Of those area races, the Fowlerville School Board is the most competitive with seven candidates vying for the four open seats. All of these seats are for four-year terms.

On the ballot are Justin Braska, Susan Spagnuolo Charron, Tony Coln, Bob Hinton, Lindsey Redinger, and Amy Sova, with Luke Downing running as a write-in candidate. Braska, Charron, Hinton, and Sova are currently on the board, while Coln, Redinger, and Downing are the challengers.

None of the Fowlerville Village Council members are opposed in their election bids. Carol Hill, the longtime president, is seeking another two-year term, while Craig Curtis and Kathryn Heath are running for re-election to four-year terms. Jamie Hernden, who was appointed to fill the seat held by the late Jerry Bell, is also running for a four-year term. The other council seat is held by James Hardenbrook who was appointed to fill the vacancy created when Jane Mills resigned. Village officials had thought this seat would not be up for a vote until the next election in 2026. However, under state law, it needs to be voted on as a partial two-year

term. Hardenbrook having missed the filing deadline due to the misunderstanding, is running as a write-in candidate for this vacancy.

The six area township board races are a mixed bag. All of the board positions have Republican candidates. However, there are Democratic Party candidates running for a trustee seat in four of the townships and two independents (No Party Affiliation) on the ballot in two of the townships. There is also a write-in candidate seeking a trustee position in one of the townships.

Conway Township has a contested race for the two trustee positions. The three candidates are Mike Miller, a Democrat; George Pushies, a Republican; and Sarah Porter, a Republican. Unopposed are Mike Brown, supervisor; Rachel Kreeger, clerk; and Tara Foote, treasurer, all three of them are Republicans.

Cohoctah Township also has a contested race for its two trustee positions. The three candidates running are Phillip Charette and Mark Torigian—both Republicans—and Mary Anne Stankov, a Democrat. Unopposed are Mark Fosdick, supervisor; Barb Fear, clerk; and Tami Bock, treasurer. All three of them are Republicans.

Handy Township likewise has a contested race for its two trustee positions. The three candidates running are Carol Elliott, a Democrat; Gordon Munsell, a Republican; and Bradley Redinger, a Republican. Unopposed on the ballot are Republican candidates Linda Hinton, supervisor; Laura Eisele, clerk; and Connie Shear, treasurer.

Iosco Township does not have any contested races for the five board positions. Running unopposed on the Republican ballot are Joseph Parker, supervisor; Julie Dailey, clerk; Amanda Bonville, treasurer; Erin Harman, trustee; and Matt Miller, trustee.

Howell Township has a contested race for the four trustee seats with five people on the ballot and one write-in candidate. In 2020, I advocated for in-person learning and for our kids to be allowed to play sports, speaking at the second Let Them Play Rally.

I am running for my current position as trustee on the Fowlerville School Board to continue advocating for our students and families. With the support of our strong community, I aim to enhance education and curriculum while also improving student participation in after-school activities. This includes providing programs that meet student interests and ensuring they have the necessary training and equipment to thrive.

In May 2023, I was chosen out of 13 candidates to join the Fowlerville School Board. We were close to picking a K-5 reading curriculum, which we voted down. For me, the curriculum focused on using children's emotions to get them to read, without clear direction as to how to use these emotions. This curriculum also used incorrect information such as the president is selected by popular vote instead of electoral college (most recently in 2016) and also included outdated maps for geography from the 1980's. Additionally, the curriculum used social justice subjects that went back to back and required heavy reflection from the children which is not appropriate.

I voted for I-ready K-5 reading curriculum which shows each family where their child is performing compared to expectations. This curriculum also gives us suggested books for each child based on current reading level and past performance. No outdated books and no pushing using emotion to get them to read. Pure education and curriculum, the focus of the current Fowlerville School Board.

I also voted for:

- The flag and display policy to help keep our focus on education and curriculum.
- The best and most durable play equipment for our students.
- Voted against enforcing the Title IX overhaul before August 2024. The Supreme Court later issued an injunction to block enforcement of this overhaul as well.

As chair of the asset management committee, I have been directly involved with the construction of our new Elementary School. Unfortunately, it is two months later than we planned. Our construction company spoke at a board meeting and took the blame for the delay. There is nothing the board could've done differently to prevent the delay.

I am committed to continuing to put our students and families first. We need to continue investing in our youth and providing them with as many opportunities as possible to succeed. As a parent, coach, volunteer and board member, I have been at the forefront and directly involved with our students and stakeholders alike to hear directly from them

what it will take for continued success and improvement. This includes keeping our excellent staff by providing competing benefit packages and retention items. Also providing the proper equipment and venues, whether this be curriculum used across the district properly or needed equipment/fields for after school activities. We need to continue planning maintenance of our buildings and grounds to ensure longevity. We need to plan to secure funds in time to replace items such as our asphalt parking lot and driving structures, sidewalks, repairs to our play equipment and fixing our athletic fields.

Four board seats are up for vote. If you think I am one of the four best candidates, then please vote for me. Also consider voting for the incumbents, Sova, Charron & Hinton. We're running together because we want to continue the positive work we've already accomplished. Go Gladiators!

**Projects:** The Village of Fowlerville has received over 6 million dollars in grant funding and

completed the following road and infrastructure projects: North Benjamin, Devonshire and Pinewood Streets, South Grand Ave., and North Grand Ave. Recently, Frank Street, Veterans Drive, and the park & ride on Van Ripper Road have been completed with additional grant monies. North Ann Street will be completed this Fall.

We have received the Federal grant for the water treatment plant and continue to work with the government in order to receive the monies. We have money put aside in the budget for our share of the project. Therefore, with the grant money and our budgeted money, there will be no increase in tax dollars in order to build the facility.

The community park grant has been approved. A citizens committee has been formed to decide what facilities will be included. Hopefully, a ground-breaking will take place in the Spring of 2025.

The council members and I would like to continue working on improving the infrastructure of our community, encourage new business in Fowlerville, and making sure all employees have tools to do their job efficiently.

The president and trustees were entitled to a wage increase over 3 years but have elected, again, not to increase our wages. Further examples of trying to cut expenses include canceling meetings where there is no agenda and lawyer fees are canceled for the meetings we choose for him not to attend.

Having lived in the community all of my life, I am aware of the various needs of Fowlerville residents and would like to continue my efforts in making Fowlerville a great place to live.

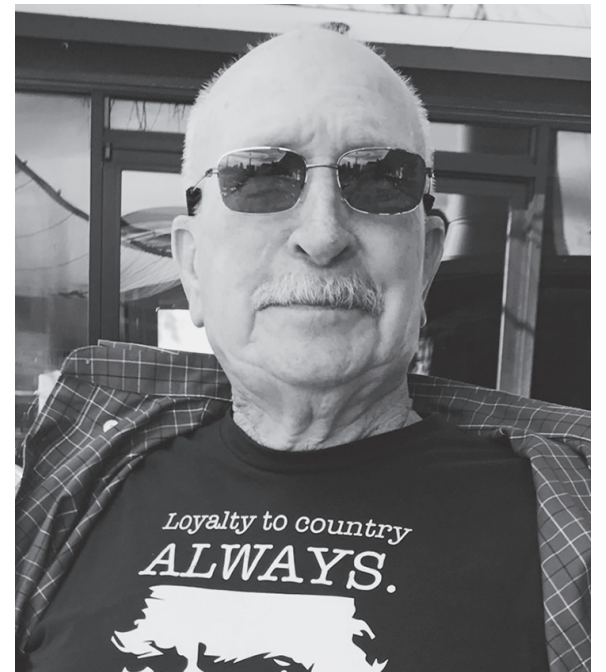

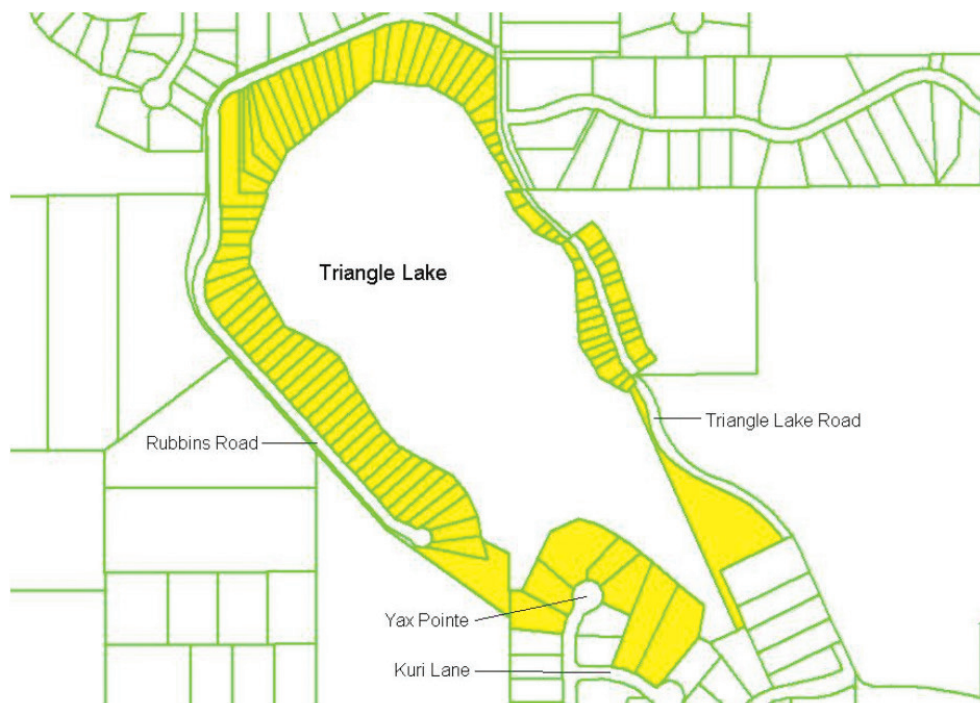

## RULES FOR A STOPPED SCHOOL BUS

### Safety Reminders for Motorists

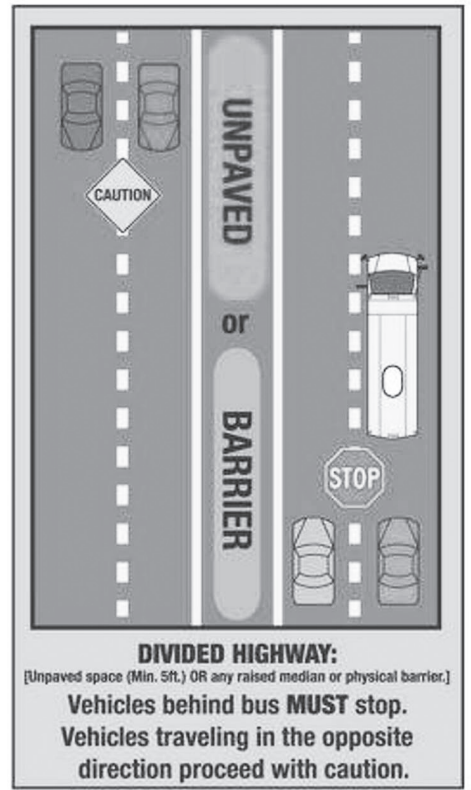
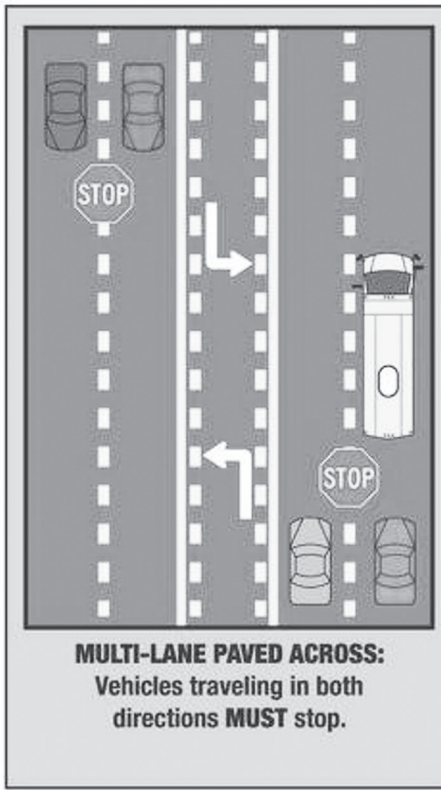
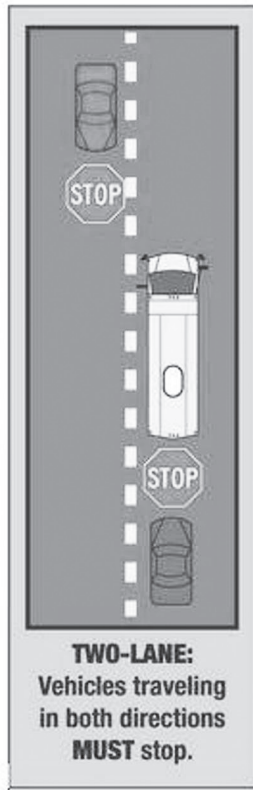
- The overall best practice is to “always stop if there’s a school bus.”
- Yellow flashing lights indicate the bus is preparing to stop to load or unload children. Motorists should slow down and prepare to stop their vehicles.
- Motorists may begin moving **only** when the red flashing lights are turned off, the stop-arm is withdrawn, and the bus begins to move.
- Never pass on the right side of the bus, where children enter or exit. This is illegal and can have tragic results.
- The greatest risk to a child isn’t riding a school bus, but approaching or leaving one. That’s why, as a vehicle driver, it is especially important to pay attention. Students’ lives are on the line.
- Slow down. Watch for children walking in the street, especially if there are no sidewalks in the neighborhood. Watch for children playing and gathering near bus stops.
- Don’t drive distracted. Be alert. Children arriving for the bus may dart into the street without looking for traffic.
- Watch out for young people who may be distracted and not paying attention to the traffic around them.

### In Michigan

- Drivers who pass stopped school buses may be charged with civil infractions carrying a fine up to \$500, and up to \$100 in costs.
- Drivers who pass a stopped school bus and cause a death are subject to a felony with either a fine up to \$7,500 or up to 15 years in jail.

**Operation Safe Stop (OSS)** has become nationally known as a successful law enforcement strategy for calling public attention to the dangers of illegally passing school buses and for lowering the incidence of such illegal passing. Each day in Michigan, there are 15,000 school buses transporting 700,000 children for more than 900,000 miles.

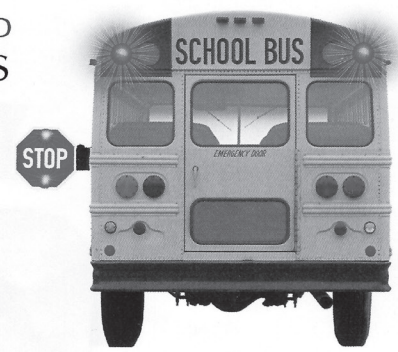
The objective is twofold: (1) to raise awareness of the danger for children when drivers violate the law requiring them to STOP for a school bus loading or unloading children, and (2) to educate children, parents, school staff, and motorists about the school bus zone, danger zone, safe walking, and key school bus safety rules and tips.

(With or Without Bus Stop Signs)

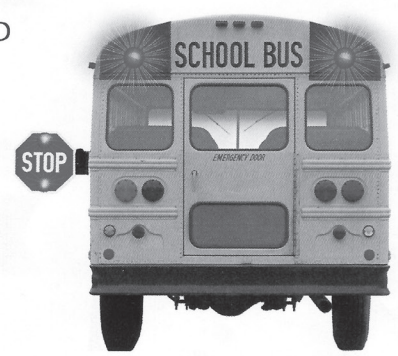
1. Yellow lights are flashing — prepare to stop.

### SCHOOL BUSES WITH OVERHEAD RED LIGHTS

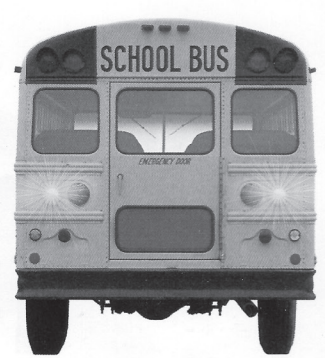
(With or Without Bus Stop Signs)

**Bob Wilson**  
*Howell Township Board Trustee*  
*Republican Party Candidate*

My name is Bob Wilson. I grew up a Farmer in Illinois. I have lived in Howell Township for 29 years. I graduated from high school with honors, spent 4 years in the Navy and have 2 war ribbons (expeditionary medals, Lebanon and Grenada 1983), 2 years of college, spent 20 years in manufacturing doing CNC machine repair and nearly 16 years as a successful business owner. I am a conservative and support all of our military organizations.

I ran for office 2 years ago because I felt that the Howell Township government played major favoritism with the people that they do like and make life hell for people that they do not. They have spent \$542,000 so far, which will probably be over a million after going to the Supreme Court fighting Oakland Tactical with opening a gun range in a gravel pit which in my opinion would be the best place for one.

They just rezoned property for a landscape company but won't rezone for those they don't like such as Oakland Tactical. I personally think people need to be trained in firearms for safety reasons. 80% polled say stop paying attorneys and let the range open.

I am a certified septic installer. I watched this township approve a bid to put in a trench drain 900 feet long at a cemetery, which is supposed to be 6-feet deep. I volunteered to oversee this job as it is in my talents. Job change. They called the township, no one called me, and they made changes to the job to not bury it 6 feet but only 4.5 feet deep. I noticed this and brought it up to the board. They all had a meeting without me once again and came back to the board with "the elevations were not right to go full depth." This is false. The board was told to hire a neutral engineer to look at this to see what was true. They did NOT hire a neutral party, they had the engineering company that created the mess give an explanation at a board meeting conveniently leaving out the fact that the depth changed 25%, 43 yards less digging, hauling away, and the same bringing in sand.

I requested to have a meeting with the engineer at the cemetery to measure depths. Coddington, Melton, an engineer and myself went to the site. After measuring, the field could have been put to the proper depth. Coddington came back to the board and told them a different version in front of us. I think this job was changed to accommodate the digging depth of the machine on site. Job Change with no board approval. Should have decreased in price by at least 25%. \$70,000 job should have been \$50k.

My next goal, no changes without approval of a bid committee. Also need a committee for ordinance violations, not one person being judge, jury and executioner. One person should never decide things. I am also in favor of tiny houses (ADU's), something affordable for our aging parents or children on our own land.

I also requested township employees' paychecks be posted. We pay 2 six-digit salaries. For a 4 day work week, 13 holidays off. I had to do a FOIA request to find out the pay.

I am responsible for starting the Shiawassee River Cleanup Committee and appointed Curt Hamilton (D) to lead the efforts. Curt is also running as a trustee, background checks on subcontractors maintaining public areas, getting all township properties out to bid to the public vs giving it to the same person for 15 years, more transparency to payroll.

This entire board has been in place for too long, it really is a good ole boy club. This entire board voted to NOT allow the citizens to vote to have or not have a dispensary. Polls show 70% in favor. We can change this with a Wilson, Counts, Hamilton and Fagan trustee board. Boal and Smith have said they are not in favor of a dispensary, both also are against the gun range and don't care what we spend. We all believe in letting the people decide.

If voted in I will continue to keep moving forward

exposing the favoritism, Get up-to-date with board meetings being live on net for people at home, (They don't even want an audience), making things more transparent, protect our environment, stop allowing this board to take such high incomes, do my best to keep taxes low, try to keep the general fund from supporting the sewer business, slow the metropolis, will allow the dispensary issue to be put on the ballot for the public to decide vs the club. Your property rights and 4th amendment are GONE!!!

Because of "permissive zoning" you no longer have the right to use your property as you wish even if it's not prohibited in the zoning ordinance. In a recent Michigan Supreme Court case (Dezman v Charter Twp of Bloomfield), the Supreme Court clarified that when a township has adopted a permissive zoning ordinance, the correct conclusion is that non-listed uses are prohibited.

What does that mean for us?

Shipping Containers ( Have any of these? Only permitted in the Industrial Flex Zone)

At Home Occupations (Work from home? May not be permitted)

Use your imagination (If it's not permitted it is PROHIBITED!)

This is a major issue for me, that we are allowing this precedent to shape our township ultimately allowing our neighbors to manage our property rights.

So now onto the loss of your fourth amendment right that protects you from unreasonable search and seizure. In another recent Michigan Supreme Court decision (Long Lake Twp v Todd Maxon), it was decided that the exclusionary rule against the use of the illegally obtained evidence applied primarily to criminal cases, and not civil actions. The actual conclusion was "the exclusionary rule was not intended to operate in this arena," and "application of the rule in this case would serve no valuable function" The exclusionary rule prevents the government from using evidence gathered in violation of the Constitution, such as evidence obtained from an unreasonable search or seizure. So the U.S. Bill of Rights only applies to criminals, but not law-abiding citizens?

What does that mean for us?

The township can use any drone footage WITHOUT a warrant to obtain evidence in attempt to enforce the zoning ordinances. This was discussed at the most recent board meeting and even presented as an option to use fly over technology as used by the assessing department, in this case "EagleView" to enforce the zoning ordinance. This will also allow for a nosy neighbor to surveil your property using drone and aerial photography to weaponize the ordinances against you. Remember permissible zoning prohibits anything not explicitly permitted.

Please vote SHANE FAGAN for TRUSTEE on November 5th and I will fight to protect you from this local government overreach.

At Social Security we strive to make our services more accessible while maintaining your privacy. We installed new kiosks in most of our local offices to make it easier for you to check in and conduct business with us. The kiosks are private, easy to use without assistance, and provide consistent service to our customers.

Modifications to earlier screens have improved the check-in process, especially for our customers who are blind or have low vision. Each kiosk is compliant with the Americans with Disabilities Act (ADA) and includes the following features:

- Accessible keypads.
- Audio headphone jacks (complimentary headphones are available upon request).
- Braille instructions for how to use the kiosk and report any accessibility issues.
- Built-in thermal printers and ticket dispensers.
- Enhanced 508-compatible check-in software.
- Touchscreen monitors with privacy filters.

These kiosks are just one more way we're improving the customer service experience in our offices. Last year, we began offering Mobile Check-in Express. It allows customers to use their mobile device to scan a QR code at their local office to check in for scheduled and walk-in appointments.

By turning on their device's location services and mobile notifications, visitors receive:

- An electronic ticket so they know their place in line.
- An alert when an employee is ready to help them.
- Information about their interview location.
- An invitation to participate in our feedback survey.

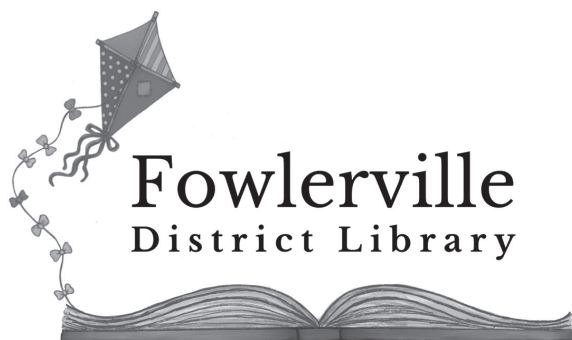

## Letter to the Editor

The Fowlerville Village Council and its Marihuana Committee are currently considering implementing an ordinance via a Council vote, which would allow up to 7 licenses for commercial marijuana businesses within the small 2.5 square mile Village limits of Fowlerville. The Village Council has good intentions in pursuing this ordinance—they were under duress from an outside pot group that threatened to put the issue on the ballot and they felt that pre-empting this with a “kinder, gentler” ordinance would help keep more local control of the situation—for details like zoning, operating hours, how licenses are awarded, etc. However, this is the wrong approach for the youth and community of Fowlerville for the following reasons:

**Pre-empting is no longer necessary: Court of Appeals Ruling** - A very-recent ruling from the Michigan Court of Appeals indicates that these marijuana ballot proposals that overreach and try to dictate zoning, licensing etc are unconstitutional and illegal. Marijuana ballot proposals can only ask *yes or no* on whether pot businesses are allowed. They can’t run roughshod over municipal power, so no need to pre-empt them with an ordinance from the Council. This ruling has already been used to knock these proposals off the ballot in Genoa Township, South Lyon, Wixom, Farmington and Sylvan Lake.

**We need to protect our youth and send the right message** - Our kids’ brains and lives are at stake. States that have legalized recreational marijuana have seen an average increase of over 15% in the use of marijuana by youth, and the marijuana products they are using are up to 90%+ THC, 20-25x stronger than a “Woodstock joint” - very damaging, especially to brains under the age of 25. With this high potency, legalization increases youth addiction as much as 25%, and 1 in 6 teens who use marijuana become addicted. The consequences of this include increasing likelihood of psychosis, learning/memory issues, depression/self-harm, lower IQ, higher unemployment rates, and many other adverse life outcomes. This is not what we want for our kids.

**Fowlerville youth have worked hard through youth prevention efforts to send a message to their peers** – Over the past three years, I was part of a community organization called Y-LAB and Fowlerville High School established a local chapter called *Be the Change*. *Be the Change* is a Fowlerville High School youth led organization designed to build leadership skills and increase protective factors that will prevent youth substance use. Allowing dispensaries in our community would completely contradict the efforts of students who are working hard to create a substance prevention message in Fowlerville.

For adults who want it, pot is readily available just down the road in Webberville, or via delivery, or growing your own. A small inconvenience for the benefit of our youth. Let’s stand together to protect all Livingston County youth and keep the outsiders’ pot shops out of our communities.

Let the Village Council know that there is no need for a pre-emptive ordinance, and the right number of pot businesses in Fowlerville is zero. Attend the Village Council meeting to be held on this topic on **Monday, October 21st at the Fowlerville Village Offices**, with the Marijuana Committee meeting at 5:30pm followed by the regular Council meeting at 6:30pm, and provide your input to help the Village Council make an informed decision.

## Michigan Governor's Report

### Lowering Costs for Michiganders

One of the biggest challenges Michiganders face today is costs. It's hard to buy a house, afford a car, or save for retirement while keeping up with bills.

That's why we are continuing our work to lower costs and help Michigan families keep more of their hard-earned money. Whether you're in college, have kids in school, or are ready to retire, we're doing what we can to help make your life more affordable.

--We rolled back the retirement tax to put an average of \$1,000 a year back in the pockets of 500,000 senior households.

--In tandem with the Biden-Harris administration, we've made strides to lower the cost of prescription drugs and ensure access to quality, affordable health care. Medicare now negotiates the prices of ten expensive, commonly used prescription drugs directly and insulin costs \$35 a month for everyone. We will keep rolling up our sleeves, lowering costs, and doing what we can to make life more affordable for you and your family.



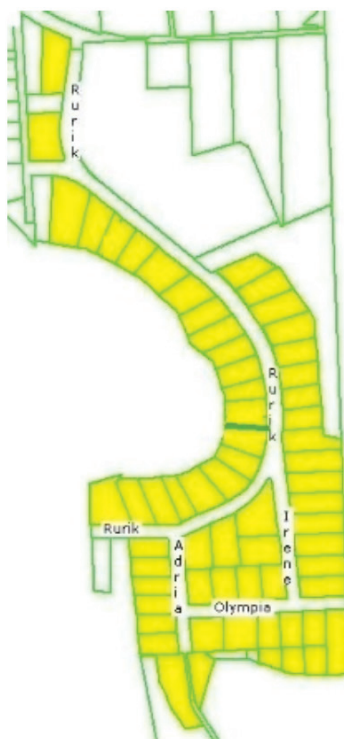

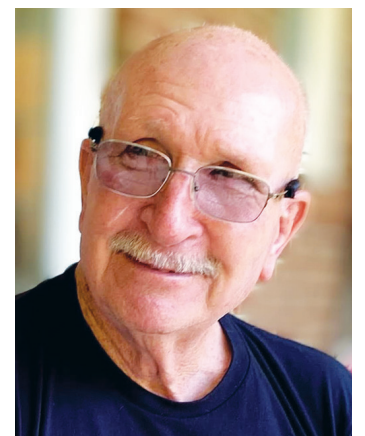
