Fowlerville High students to perform 'Clue' on April 11-12-13

The actors and backstage crew have been busy rehearsing for the upcoming spring play put on by Fowlerville High School students. This year's presentation is 'Clue'—a combination murder mystery and comedy.

Performances will be held at the Alverson Center for Performing Arts, located at the high school, on Friday, April 11th at 7pm, Saturday, April 12th at 7pm, and Sunday, April 13th at 2pm. Tickets are \$10 at the door, cash only. Open seating (there is some handicap seating available).

A short synopsis of the plot is that on a dark and stormy night, six mysterious guests are invited to a dinner party at Boddy Manor. Their host is murdered, and they are left to try and solve the murder when all of them are prime suspects.

Jill Martin, director of the Alverson Center, noted that the play is "inspired by the classic Hasbro game 'Clue' and is a whodunit that will keep you guessing until the very end."

"Expect slapstick comedy, the classic 'Clue' characters, and twists and turns like a hilarious roller coaster," she added.

Fowlerville High School Spring Testing Schedule 2025!

As we welcome spring to Michigan it is also time to look at our high school testing schedule. State law requires students to participate in The Michigan Merit Exam (MME) summative assessments. Summative assessments measure what students are expected to know and be able to do at specific grade levels and in specific content areas. It provides 9-10 grade students the chance to practice their skills for their 11th grade SAT and gives all students the chance to take these assessments free of charge in a familiar location. Attendance is very important on these days. Please get a good night’s rest and start your day with something to eat.
As of 2023 testing has moved to a digital platform- they will

take their test on their school provided chromebooks. Please make sure your student brings their FULLY CHARGED chromebook on their day of testing.

Please see below for a detailed schedule for your student/ test.

All testing will take place in the Competition Gym unless your student receives testing accommodations. Accommodated locations will be shared with those students individually.

Seniors:

No school on Wednesday, April 9th. Attend WTC or Liv/ CTE as normal. Return to normal schedule all other days.

Juniors:

Excused from WTC or LivCTE during all testing days.

-Wednesday, April 9th:

SAT -(7:30-12:30- NO LUNCH- Light snack during mid-morning break. 11th grade students are dismissed from school after testing). Digital Test- bring fully charged chromebook.

-Thursday, April 10th:

ACT WorkKeys- (7:30-11:30-”C” Lunch. Return to 5-6 hours as normal). Paper/pencil test- bring #2 pencils/ calculator.

-Friday, April 11th:

M-Step- (7:30-9:30-Extra time for those that need it. Return to normal school day). Digital Test- bring fully charged chromebook.

Sophomores:

-Thursday, April 17th- PSAT/10- (7:30-10:30. Return to 4th-6th hours as normal). Digital Test- bring fully charged chromebook.

-Normal schedule all other days.

Freshman:

-Tuesday, April 15th-PSAT/9- (7:30-10:30. Return to 4th-6th hours as normal). Digital Test- bring fully charged chromebook.

Fifth Word of Lent: The Lesson of Zeal

It's unbelievable that the year is flying by so fast. It seemed like we were just celebrating Christmas and look where we are at—Easter. I guess my parents were right when they said the years would fly by after you turned 21!

We have been walking through Lent this year and sharing the Beatitudes and the Last 7 words spoken by Christ from the cross, and as hard as it is to understand many pieces of scripture, I hope that I am able to do so to share the goodness of Lent and Easter.

This week, the fifth week is about zeal. What is zeal? According to Oxford dictionary:

great energy or enthusiasm in pursuit of a cause or an objective.

How it is used in the Bible:

Scripture encourages us to cultivate zeal for serving Christ through good works.

So, to be fully in with your entire heart and soul. Like social justice, human rights, you know stuff we are still working on currently. When Jesus was on the mount giving the sermon, this was the Beatitude that said *"Blessed are they that hunger and thirst after justice: for they shall have their fill."* And on the cross we hear Jesus say *"I thirst"*.

These words are hard for people to understand. The people who post pictures and quotes about Jesus and scriptures that were spoken by Jesus, yet don't actually do what those posts say, are far from the zeal we are talking about. This attitude towards religion makes it seem like something that is "mystical," incidental to life, just mere words to only be oohed and ahhhed at... Oh they are truly a Christian.

For Catholics, Fridays are a day of abstaining from meat in reverence of Jesus giving his life on Friday. Yet so many make excuses of "well I was going to a party and I didn't want to upset my host if I didn't eat" or young teens who are embarrassed and will say "I have friends who are unbelieving and I stayed Saturday night at their house so I didn't go to Mass Sunday morning" or this is one not only teens experience "When others make fun of praying to the Blessed Mother and ridicule the saints or the crucifix, I said nothing, because I didn't want to start an argument about religion."

Yet we give in on other things. How many can raise their hands that as young people you didn't turn down a drink with buddies in the corn field... Everyone likes that Boone's Farm or MD2020 (I'm old... LOL). Standing up for your convictions and belief in God is considered weak and, well, stupid. No one wants that, especially in today's world. If the world does hunger and thirst, it is always for something less.

Instead of hunger and

thirsting for the justice of God, it is easier and more accepted to hunger and thirst for worldly things, such as bigger house, a new car or truck, all the toys that come with what one believes is success. The material wants.

I know many who read this paper that come across my article and, when they see that I am talking about God and faith, they turn away. I understand why. They have never been made to feel wanted and accepted by whatever church they have attended. There was always someone who made them feel inadequate, not worthy if they continued to live the way they were. Some, especially the youth, were/are made to feel bad because of circumstances beyond their control, yet it didn't matter. Others have walked away because of the lifestyle they were born into, and yes, I said born into, but we won't go into that. My hope is that by reading my articles you will see that God is looking for you, don't let others run you away, they don't have the monopoly on faith, God, Jesus or the cross.

I have been reading some words by Richard Rohr, a Franciscan priest who in his teaching spoke about "Why is my group always better than your group?" and he speaks about those who are the "insider" often misses the grace, while the "outsider" gets it. It was written "No prophet gains acceptance in his own place." Fr. Rohr ends with "Religion which was supposed to be life and healing for the WORLD has too often become death and boundary—keeping for the few" (Rohr 2011)

If you want, you can read 2 Kings 5:1-15b; Luke 4:24-30 (The Holy Bible 1946, 1952, 1957, 2006) for clarification.

Many look at the words "I thirst" and think that Jesus was dehydrated, yet that wasn't it, he was thirsting for justice—Insatiable thirst for the souls of the human beings. The world hates the zealous because they are a criticism of the mediocracy we live. People for centuries have been about QUANTITY not QUALITY.

I look at my life and the times I was exactly like those examples above, not doing anything to show that justice is important and that all humans are worthy. I look at how many have walked away because of being persecuted or afraid, thinking they didn't belong in the "club" or with those who felt they were "the chosen ones".

Look away from the mediocre ways. The world is looking for the light, are you willing to put yours under a basket? The world is looking for savor, are you willing to let the salt lose its savor? Think of those who hunger for justice, those who are hungry and homeless, are you willing to walk away from them and not lend a hand—not fight for justice for them? I hope not.

Spring is an exciting time as our students have the opportunity to show what they have learned through state assessments. In April and May, students across the district will participate in the M-STEP, PSAT and SAT. These assessments help us understand student growth, but more importantly, they allow students to demonstrate their hard work and academic progress. Bulletin 1014 for 2023-24

Bulletin 1014 is published annually by the Michigan Department of Education. It provides financial and statistical data for Michigan public schools. It includes information for revenues and various expenditures per pupil. The report also ranks public school districts across Michigan in these categories, providing the ability to compare district revenues and expenditures across a variety of categories.

Fowlerville Community School’s administrative costs per pupil were \$1,671, ranking 668th out of 822 districts. This meant that 81% of Michigan districts spent more per pupil on administrative costs, placing Fowlerville in the lowest 19% of districts for administrative spending.

Administrative Costs Per Pupil

Fowlerville’s total support expenditures per pupil were \$4,551, ranking 694th out of 822 districts. In percentile terms, 84% of districts spent more per pupil on support services, placing Fowlerville in the 16th percentile statewide.

Total Support Expenditures Per Pupil

Total support expenditures include instructional support services such as curriculum development, staff training, and educational media services. Business and administrative costs cover general administration, school administration, business services, central services and other support services. Operations and maintenance include expenses for building maintenance, custodial services, and utilities to ensure school facilities remain open, comfortable, and safe. Transportation services account for the cost of student transportation to and from school and school-related activities.

What This Means for Fowlerville

This data shows Fowlerville’s commitment to responsible financial management. The district has maintained much lower-than-average administrative and support costs, ranking us in the bottom 19% of districts for administrative costs and in the bottom 16% for total support expenditures. This means that over 80% of public school districts in Michigan spend more on these than Fowlerville. This shows the district’s ability to keep non-instructional expenses low while still meeting the district’s needs.

MSU’s Gifted and Talented Education (GATE) Summer Programs Taking Registrations

Michigan State University has opened registration for its Gifted and Talented Education programs for the summer. These programs provide gifted students the opportunity to dive into Science, Technology, Engineering, Arts and Mathematics through challenging, creative and hands-on activities. Homeschool Elective Opportunities at Fowlerville Community Schools

At Fowlerville Community Schools we offer a wide assortment of elective courses for students in grades K-12 that homeschool families can take advantage of. These elective courses provide opportunities to explore new interests, gain hands-on experience and build connections with peers, all within a supportive learning environment.

If a homeschool student is enrolled in non-core classes and meets Michigan High School Athletic Association (MHSAA)

Credit Guidelines (4 of 6 classes at the Junior High or High School), the student may participate in athletics. In addition, students can participate in non-core co-curricular and extracurricular activities that are directly related to the non-core classes they are taking. Homeschool students may also participate in all of our Recreation programming even if they don’t meet MHSAA credit guidelines or aren’t attending Fowlerville.

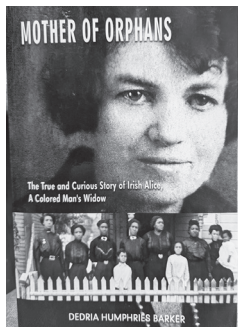
'Fowlerville News & Views' sponsoring Book Conversation with Lansing author

2024 Water Quality Report for Village of Fowlerville

Water Supply Serial Number: 2400.

This report covers the drinking water quality for the Village of Fowlerville for the 2024 calendar year. This information is a snapshot of the quality of the water that we provided to you in 2024. Included are details about where your water comes from, what it contains, and how it compares to United States Environmental Protection Agency (U.S. EPA) and state standards.

Your water comes from [9, 10, 11, 12, 13] groundwater wells, each over [9-255', 10-246', 11-297', 12-260', 13-253'].

The State performed an assessment of our source water to determine the susceptibility or the relative potential of contamination. The susceptibility rating is on a seven-tiered scale from “very-low” to “very-high” based on geologic sensitivity, well construction, water chemistry and contamination sources. The susceptibility of our source is low, moderately low, and moderately high, from 2008.

There are no significant sources of contamination in our water supply. We are making efforts to protect our sources by PARTICIPATION IN THE WELLHEAD PROTECTION PROGRAM.

Contaminants and their presence in water: Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the U.S. EPA's Safe Drinking Water Hotline (800-426-4791).

Vulnerability of sub-populations: Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune systems disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. U.S. EPA/Center for Disease Control guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

Sources of drinking water: The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. Our water comes from wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- **Microbial contaminants**, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- **Inorganic contaminants**, such as salt and metals, which can be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- **Pesticides and herbicides**, which may come from a variety of sources such as agriculture and residential uses.
- **Radioactive contaminants**, which can be naturally occurring or be the result of oil and gas production and mining activities.
- **Organic chemical contaminants**, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.



In order to ensure that tap water is safe to drink, the U.S. EPA prescribes regulations that limit the levels of certain contaminants in water provided by public water systems. Federal Food and Drug Administration regulations establish limits for contaminants in bottled water which provide the same protection for public health.

Water Quality Data

The table below lists all the drinking water contaminants that we detected during the 2024 calendar year. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise noted, the data presented in this table is from testing done January 1 through December 31, 2024. The State allows us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. All the data is representative of the water quality, but some are more than one year old.

Terms and abbreviations used below:

- **Maximum Contaminant Level Goal (MCLG):** The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- **Maximum Contaminant Level (MCL):** The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- **Maximum Residual Disinfectant Level (MRDL):** The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- **Maximum Residual Disinfectant Level Goal (MRDLG):** The level of a drinking

water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

- **Treatment Technique (TT):** A required process intended to reduce the level of a contaminant in drinking water.
- **N/A:** Not applicable
- **ND:** not detectable at testing limit
- **ppm:** parts per million or milligrams per liter
- **ppb:** parts per billion or micrograms per liter
- **ppt:** parts per trillion or nanograms per liter
- **pCi/l:** picocuries per liter (a measure of radioactivity)
- **Action Level (AL):** The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.
- **Level 1 Assessment:** A study of the water supply to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.
- **Level 2 Assessment:** A very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

Fowlerville agriculture science teacher & FFA advisor talks about program at Rotary Club’s Farmers Day lunch

Curtis Refior, the Fowlerville High School agriculture science teacher and FFA advisor, was the guest speaker at the Rotary Club’s annual Farmers Day lunch. Accompanying him were officers of the FFA Chapter.

Refior talked about the program and listed its accomplishments.

“FFA, formerly known as the Future Farmers of America, was rebranded as the National FFA organization because what we learned is that not all of our young people are going to be farmers, but a lot of our young people will end up being employed in the agriculture industry,” he noted. “In Michigan, agriculture’s the second largest industry and employs 20% of our workforce, Nationwide, the statistics are similar. So if you think about all of the processes that took place to get the food on our table that we’ve eaten this afternoon, those are careers that our students could be involved with all the way through that production chain. My role is to help our young people become aware of those career opportunities and then develop some of the skills that might help them be successful when they do those things.”

Refior noted that while Fowlerville High School offers the program which includes the classroom and other learning facilities, under an agreement with other Livingston County schools districts, any of their students can enroll in the program.

“Since we have the only agriculture science program and FFA Chapter in the county, some of our students are from those other districts as well as our own,” he explained.

(Note: As part of this agreement, Fowlerville students can enroll in vocational and career-training classes offered in other districts that are not available at the high school.)

Refior pointed out that agricultural education has three components, adding that it’s referred to as the three-circle model.

“It’s important to explain the three parts because the approach is different from what you see in regular classrooms,” he said. “In regular classrooms, every student in the Fowlerville Schools is taught by a qualified teacher with a supported curriculum. That’s one of the three aspects of ag education. The other two that make us different is we have an experiential learning part of our curriculum where people have to do things with their hands and get experience developing some skills. And then the third part of the three-circle model is leadership education. Every student that comes into my class gets a teacher using an approved curriculum, but also opportunities to work with their hands and develop some skills, and then also an opportunity to develop their leadership abilities. I think through this three-circle model, we’re producing some great graduates who are ready to go out and be productive citizens in our society.”

Refior pointed out that students spend the first half of their year learning about plants and plant science as well as agribusiness and leadership, then in the second half of the year the focus is more on animal science, some natural resources, and specific career readiness opportunities and skills.

ily by identifying and removing lead materials within your home plumbing and taking steps to reduce your family’s risk. Using a filter, certified by an American National Standards Institute accredited certifier to reduce lead, is effective in reducing lead exposures. Follow the instructions provided with the filter to ensure the filter is used properly. Use only cold water for drinking, cooking, and making baby formula. Boiling water does not remove lead from water. Before using tap water for drinking, cooking, or making baby formula, flush your pipes for several minutes. You can do this by running your tap, taking a shower, doing laundry or a load of dishes. If you have a lead service line or galvanized requiring replacement service line, you may need to flush your pipes for at least 5 minutes to flush water from both your home plumbing and the lead service line. If you are concerned about lead in your water

and wish to have your water tested, contact Village of Fowlerville and Cathy Elliott 517-749-2506 for available resources. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available at <https://www.epa.gov/safewater/lead>.

The Village of Fowlerville has received a sampling violation for Partial chemistry testing. The testing month was September. (The state lab changed the testing rules in June and did not notify the Village of Fowlerville, this is the only lab that changed their testing requirements) we were out of compliance October 1st ,2024 and returned to compliance November 4th, 2024

“We have a bunch of different projects that are always underway,” he said. “We have an excellent facility with a state-of-the-art classroom that’s full of awesome technology, an indoor lab that is spacious and well-funded. And we are continuing to grow our outdoor space. We built a new greenhouse in the fall, and we have some upcoming projects to further develop our outdoor space.”

“We also have outdoor learning spaces including the school wood lot and an apiary where we keep seven beehives throughout the year,” he said. “So, we’ve got students involved in a lot, all sorts of things in all sorts of areas.” After having done this overview of the program, Refior had the four students who accompanied him stand and introduce themselves and told a favorite thing about FFA.

The students included Kaliegh Schoenbeck, Adilyn Grimm, Delaney Richardson, and Grace Lesinksi. The first three girls are from Fowlerville, while the last one is a student at Hartland High School.

Refior said the program currently has 96 students, including 11 who have graduated from high school and are continuing their pursuit of an American Farmer Degree.

“When the program was brought back to Fowlerville nine years ago and I was hired, the first year we had 26 students,” he said, noting that all five county school districts had voc-ag programs and FFA chapters until the late 1980s when they were discontinued. Refior then listed some of the individual accomplishments of students during the past nine years

- 70 students who achieved the FFA State Degrees.
- 28 students who received the Outstanding Junior Awards.
- 82 teams consisting of 136 individuals who have participated in Leaderships Contests which includes Prepared Public Speaking, Job Interview, and Demonstrations.
- 2 state winners in the Job Interview Contest and several state runner-ups.
- 72 state Science Fair entries with 31 state winners.
- 3 FFA Proficiency Award winners.
- 114 Academic Excellence Award recipients.
- A National Superior Chapter Award given last year.

“Students are coming to us and growing their academics and earning recognition but also developing a variety of skills that will help them in later life,” Refior said, “And our chapter is receiving recognition nationally. So, I’m proud of what the students have accomplished over the last nine years and the success the program has experienced as a whole. I want to thank the Rotary Club for its support as well as the Fowlerville community.”

Adult trout stocked in Clinton & Huron rivers, Spring Mill Pond

Approximately 4,250 adult trout were stocked recently by the Michigan Department of Natural Resources in the Huron River (Proud Lake Recreation Area, Oakland County) and Spring Mill Pond (Island Lake Recreation Area, Livingston County) in southeast Michigan. These fish are retired broodstock from Michigan's state fish hatcheries.

- The Huron River, downstream of the Proud Lake Dam, was stocked with approximately 1,950 brown trout and 1,350 rainbow trout, all ranging in size from 13 inches to 19 inches.
 - Spring Mill Pond was stocked with approximately 450 brown trout and 500 rainbow trout, also ranging from 13 inches to 19 inches.
- Special regulations apply for anglers interested in targeting these trout:
- The Huron River at Proud Lake Recreation Area is closed to fishing Oct. 1 through March 31. April 1-25, anglers are limited to flies only, catch-and-release fishing, with the exception that children under 12 may keep one trout sized between 8 inches and 12 inches.
 - Spring Mill Pond at Island Lake Recreation Area is closed to fishing March 15-31. Anglers are limited to artificial lures only, catch-and-release fishing April 1-25.
 - On both bodies of water, beginning April 26, all baits are allowed, and anglers may keep up to five trout over 8 inches, but only three over 15 inches.

The Clinton River was also stocked with 1,150 adult brown trout ranging from 13 inches to 18 inches. These fish stocked at Riverside Park in Auburn Hills will provide additional angling opportunities beyond the yearling fish that are stocked annually. The Clinton River is open to trout fishing all year, and anglers can keep up to five trout over 8 inches, but only three over 15 inches.

The 2025 Michigan Fishing Regulations are available online, along with other helpful resources including fishing location maps, fish ID information, the weekly fishing report and more. Visit Michigan.gov/Fishing to learn more.

To find out if fish were added to any of your other favorite fishing spots, visit the DNR's fish stocking database at michiganandnr.com/fishstock/.

PFAS awareness

While these fish are stocked upstream of the advisory area, the Huron River is under a "Do Not Eat" fish consumption advisory from Wixom Road south to Lake Erie due to elevated PFAS levels in fish. The main source of contamination in Norton Creek has been addressed, but the perfluoroalkl and polyfluoroalkl substances advisory is still in place until further testing.

The stocked trout do not reside in the Huron River for long periods of time. Touching the fish or water is not considered a health concern. For further information go to Michigan.gov/PFASResponse and search for Huron River.

Spring Mill Pond is not connected to the Huron River and not affected by the consumption advisory.
