## Fowlerville Fall Fest being held Saturday, Sept. 14<sup>th</sup> at fairgrounds

The annual Fowlerville Fall Fest will be held this coming Saturday, Sept. 14, from 11 a.m. to 5 p.m. at the Livingston Centre Historical Village. Nestled in the Fowlerville Fairgrounds, this event promises to be a day of fun for all. This annual festival is the Livingston Centre Historical Society's largest fundraiser, with the proceeds going towards the upkeep and restoration of the village's historic buildings. Organizers noted that these buildings "are cherished symbols of this community's heritage."

Admission includes a delightful array of activities. Old-fashioned carnival games, inflatables—including a bounce house and obstacle course—barrel train rides, and lots of kids' activities will be held on the midway. A face painter will also be on site, generously sponsored this year by Bob Maxey Ford of

Fowlerville. Children can paint pumpkins throughout the day and participate in the Kid's Scarecrow Parade at 11:30 a.m. Tours of the historic village and live demonstrations will be offered all day.

Food lovers will find an impressive lineup of food trucks, including The Bloated Goat, Mini Donuts & More, Torch 180, Smoke Daddy, GUD Dog, Sugar Shack Donuts, LKB Concessions, and Twisted Sugar Bubble Bar. There'll be something for everyone.

Highlighting the afternoon schedule will be the First Responders Tug O' War at 1 p.m., where local heroes will compete head-to-head in a test of strength. In addition, Torch 180 will sponsor various field day activities.

Talented local artists will provide music and entertainment throughout the day. The music schedule kicks off at 11 a.m. with Emily Faber, followed by Jessy Adams at 12 p.m., Bryce Engle

### Area resident awarded 2023 Air Company Grade Officer of the Year

U.S. Air Force First Lieutenant Caleb L. Jenkins of Brighton and formerly of Fowlerville was recently named the 2023 Michigan Air National Guard Company Grade Officer of the Year.

Lt. Jenkins serves at the 127th Wing, Selfridge Air National Guard Base, Michigan. He was selected from amongst company grade officer peers across Michigan, and his accomplishment was recognized by Governor Gretchen E. Whitmer and the Adjutant General of the Michigan National Guard Major General Paul D. Rogers at the state Pass in Review held in Grayling in June.

Jenkins, an intelligence officer, developed innovative contingency tactics and procedures that contributed to a significant shift in operational training for Mobility Air Forces. He then spearheaded implementation of these tactics by serving as an in-the-field mentor for operations and exercises across the Indo-Pacific region, including Japan, Guam, and Hawaii.

As his unit's chief of intelligence, Jenkins developed a

first-of-its-kind integrated intelligence mission planning exercise that simulated a contested, decentralized operating environment against a peer threat. This exercise brought Airmen from across the nation to Michigan for training.

Lt. Jenkins is an active volunteer. Locally, he is a member of the Livingston Sunrise Rotary Club and multiple veterans groups. He and his wife, Kaila, regularly volunteer for various local charitable organizations and community events.

Or according to Webster: The distinguishing character or personality of an individual”.

We are living in a culture that is heavily persuading us to believe that our identity comes from “what we do” or “our position in society”. Admittedly, in my teens and young adult years I chased after the very things I thought would give me great definition, those very undertakings that I now see as running after foolish goals.

As I’m moving through my study on “The Sabbath”, this week’s teaching focused on “identity”. Too often, we define ourselves as “what we do”—teacher, office worker, physician, engineer, accountant, software analyst, bus driver, research technician, architect, finance officer... the list of professions and employment opportunities is quite extensive. EVERY job or career has value and holds potential for great personal growth and satisfaction. Yet, the results of reaching personal goals is not how God defines you or me. On the contrary, He isn’t interested in what you “do” regarding employment; He’s after your heart. He wants you to identify as His child when you come into a relationship with His Son, Jesus Christ.

We read about the Hebrew nation in the Old Testament Book of Exodus who were living under Egyptian rule, making bricks during long work days. If we were to apply the world’s definition of

finding identity in “work”, then we could say the Israelites were brick builders. Indeed, that’s the work they were doing, but it isn’t an accurate description of their worth and value to God. In His eyes, they were His people and eventually their freedom comes out of miraculous events by raising up Moses and his brother Aaron to lead them from captivity.

I need to fully understand, and so do you, that “God’s work isn’t defined by His work” (Walking the Text, Brad Gray) Furthermore, you and I are “not our work”... “you are not what you produce”.

If I were to apply my former thoughts of who I was in my 20s and even up to now at age 70, and also factor in a variety of jobs I held, well my identity list would look like this: Children’s Zoo Employee \*Receptionist \*Administrative Assistant \*Management Trainee \*Office Clerk \*School Board Member \*Direct Sales Rep \*Serving Roles at My Church

A good read to further cement an understanding that believers in Christ are sons and daughters of God can be found in the book of Galatians, specifically chapter 4. Honestly, I had been feeling flat in my relationship with God for a few weeks. Although I stayed committed to reading scripture, praying and serving, I felt empty until my own pastor taught from this chapter last week. It breaks my heart—and I can trust it hurts God too—that too many people are getting caught up in false identity definitions. It’s time we find worth and value in what God says about us and not our culture’s loud voices bombarding us with lies. So, who does God say you are? Here’s a few definitions straight from scripture to encourage you:

- You are His beloved child
- You are chosen
- You are a holy temple
- You are made in His image
- You are valuable
- You are His friend
- You are forgiven
- You are redeemed

What I didn’t tell you earlier in this week’s column, that when I was a little girl watching Saturday morning television, Roy Rogers was my hero. I wanted to grow up and be like him. My dream didn’t last long when my hopes of getting a horse were shattered because after all—we lived in the city! In junior high I had great aspirations to become an author. So far I’ve had fun and privilege writing for personal enjoyment and teaching Bible studies over the years. The latter is PART of “what I do” but it doesn’t define who I am.

## TOWNSHIP OF HANDY NOTICE OF ADOPTION: ORDINANCE TO ADOPT AMENDMENTS TO THE TOWNSHIP ZONING ORDINANCE REGARDING ACCESSORY BUILDINGS, STRUCTURES AND USES

To the residents and property owners of the Township of Handy, Livingston County, Michigan, and all other interested persons:

On August 26, 2024, the Township of Handy (the "Township") adopted an Ordinance To Adopt Amendments To The Township Zoning Ordinance Regarding Accessory Buildings, Structures And Uses ("Ordinance"). A summary of the Ordinance is provided below. A true copy of the Ordinance, including any exhibits, is available for inspection at the Township Hall, 135 N Grand Ave, PO Box 189, Fowlerville, MI 48836.

Section 1 of the Ordinance amends section 2.2 of the Township's Zoning Ordinance regarding accessory buildings, structures and uses to, among other things, add regulations for storage containers as accessory buildings.

Section 2 of the Ordinance amends section 1.20 of the Zoning Ordinance to add a definition for "storage container."

Section 3 of the Ordinance provides that if any portion of this Ordinance is found invalid for any reason, such holding will not affect the validity of the remaining portions of this Ordinance.

Section 4 provides that all other ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent necessary to give this Ordinance full force and effect.

Section 5 provides that this Ordinance takes effect seven (7) days after publication as provided by law.

# Michigan Senate Report

## As Michigan's third grade reading proficiency drops, governor vetoed reading scholarships

The results of the 2024 Michigan Student Test of Educational Progress (M-STEP) have revealed a concerning trend: Third grade reading proficiency has plummeted to its lowest level in the nine-year history of the state assessment test. Only 39.6% of Michigan's third graders were proficient in the English Language Arts (ELA) portion of the test, marking a steady decline from previous years. This means that 60.4% of third graders statewide failed to meet the proficiency benchmark in English this past spring.

State education officials have noted that these third graders were in the critical early stages of learning to read during the COVID-19 pandemic, which disrupted their educational progress. Recognizing the long-term impact of these disruptions, Sen. Lana Theis has been a strong advocate for giving parents the tools and support they need to help their children succeed outside the classroom.

"It's heartbreaking to see our children struggling to meet this fundamental milestone," said Theis, R-Brighton. "Reading proficiency is not just another academic achievement, it is the gateway to success in every other subject and has lifelong implications. We knew the pandemic would have a lasting impact on our students, especially in those formative early years, which is why I fought so hard to include reading scholarships in the 2022 budget. These scholarships would have provided crucial support to parents, enabling them to help their children catch up and build the reading skills they need to thrive."

The reading scholarships, which were included in the fiscal year 2022 School Aid budget as passed by the Legislature, would have offered up to \$1,000 per eligible student for reading materials, literacy programs, and tutoring services. However, despite bipartisan support, Gov. Gretchen Whitmer line-item vetoed the \$155 million program.

Theis expressed her deep disappointment in the governor's decision.

"Gov. Whitmer's veto of these reading scholarships was a blow to the very families who needed them most. It's clear that political gamesmanship took precedence over the educational needs of our children," Theis said. "We must prioritize giving parents the resources they need to support their children's education, especially after the disruptions caused by the pandemic. Our kids deserve better."

As the state grapples with the implications of these declining M-STEP scores, Theis remains committed to advocating for policies that empower parents and support students in achieving essential academic milestones. She is calling on her colleagues in the Legislature to renew efforts to provide targeted support to the students most in need and to revisit the critical importance of reading proficiency as a cornerstone of a successful education.

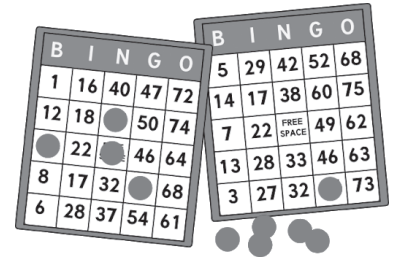

### Livingston Educational Service Agency seeking renewal & restoration of special education millage in November election

The Brighton, Fowlerville, Hartland, Howell and Pinckney schools, as well as each public school academy in Livingston County, have asked the Livingston Educational Service Agency (LESA) to propose the renewal and restoration of the existing special education millage in the upcoming election

on Tuesday, Nov. 5. If approved, this millage proposal would continue to fund services, programs and resources for more than 3,500 students with special needs in the local school districts and public school academies across Livingston County.

Initially approved by voters for ten years in 2015, the expiring portion of the special education millage should be familiar to taxpayers. In 2015, the agency committed to giving 100% of the millage-generated funds to local school districts and public school academies. LESA intends to do the same if this proposal is approved by the voters.

**If passed, the millage would continue to:**

**Fund for Special Education Programs:** The millage funds are used to operate various programs, including unified sports, work readiness training, peer-to-peer initiatives, assistive technology, and behavioral support services.

**Fund for Paraeducators:** A significant portion of the millage goes towards covering the cost of paraeducators and curriculum materials, among other supports.

**Free Up General Fund Dollars:** While federal and state mandates require support for special education students, they do not provide total funding. The millage helps fill this gap, helping ensure these mandates are met without diverting resources from other students' educational needs.

renewal and restoration would continue to fund local school districts special education programs," said Dr. Michael Hubert, Superintendent of LESA. "Without these funds, districts may have to use general fund dollars from other programs to pay for mandated, but otherwise unfunded, services and programs that meet the needs of students with disabilities."

Voting will occur in person on Tuesday, November 5 or by early voting from Oct. 26 to Nov. 3 or by absentee ballot until Election Day. LESA is hosting one-hour informational meetings about the millage proposal leading up to the vote to provide more information, and community members are encouraged to attend.

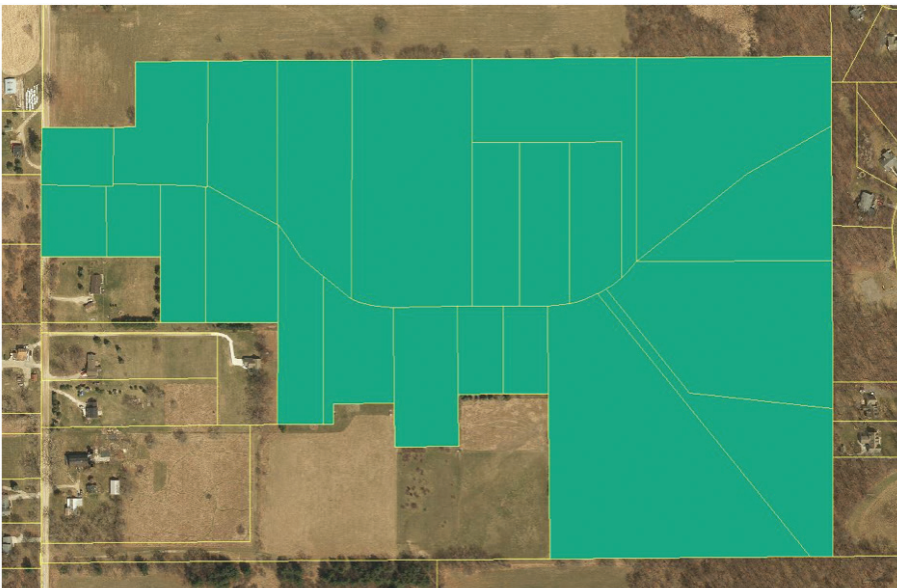

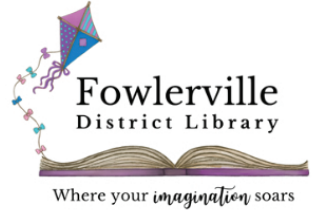

### Me and You and a Degu named Boo

From feathers and gills to scales and fur, many public libraries around the country have resident library pets. In fact, the pet lineup in Michigan public libraries includes three bearded dragons, a uromastyx (a spiny-tailed lizard), hedgehog, red eared slider aquatic turtle, aquariums with fish, a cat, a frog, a leopard gecko, and Asmo the Library Snake (corn snake) on Facebook.

At Fowlerville Library, we have pets, too. Our pets

are two degus named Jem and Boo. Boo is the new addition and the littlest.

What is a degu (pronounced DAY-goo)? The Common Degu is a small social rodent. It has a long silky coat that is grey-brown tinged and a long, thin tail with a tufted black tip.

Library pets offer a unique way to connect with the community. They are interesting and fun to watch, present an educational opportunity – be honest, have you ever heard of the common degu before now?! – and the kids love them.

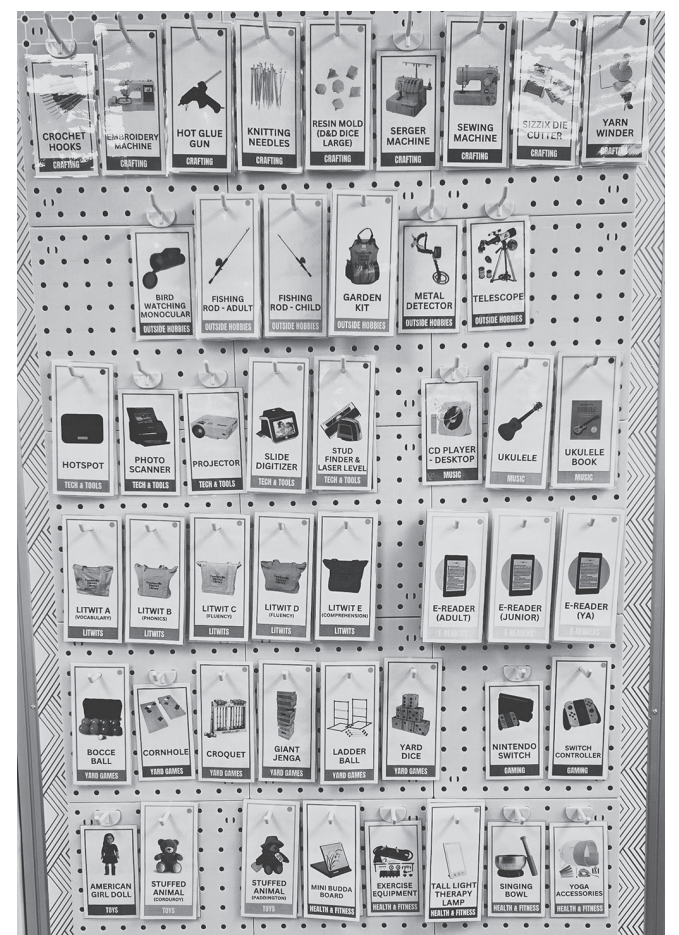
magically disappear. We have a regular and a mini. It's fun for kids, too. The use of the Buddha Board comes recommended by our director, Isabella.

**Michigan apple growers expected to harvest 30.5 million bushels this season**

Michigan’s official crop estimate of 30.5 million bushels (1.281 billion lbs.) of apples was announced recently as part of the USApple Outlook meeting which is held in Chicago. The 2024 estimate is above average for the Michigan Apple industry.

“It is unusual to have three large crops in a row,” said Diane Smith, executive director of the Michigan Apple Committee. “However, as growers continue to plant high-density orchards and adopt other innovative growing practices, Michigan’s apple crop sizes will increase, and we will continue to see these larger crops.”

According to the USDA, Michigan harvested 31.9 million bushels of apples in 2023. Average annual crop size is approximately 25.9 million bushels. There are more than 14.9 million apple trees in commercial production, covering 34,500 acres on 775 family-run farms in Michigan.

Warmer than normal temperatures in late winter and early spring caused buds to form early, leading to earlier bloom in May. Growers were fortunate this year to not experience significant frost and freeze events after that early bloom, meaning a plentiful crop being harvested about 10 days earlier than usual.

“Michigan Apple growers share a common goal of producing flavorful, high-quality apples,” said Smith. “They work with tree fruit researchers to implement the latest growing techniques and use new technology to monitor growing conditions. Michigan growers are committed to bringing the best quality fruit to the consumer.”

Many factors contribute to the size of an apple crop, including weather, bloom conditions and tree health. To

make the estimate, growers and other industry experts report on what they are seeing in various regions of the state, then come to a consensus on the crop size estimate.

Michigan Apples are available nearly year-round from August to June. The largest and most valuable fruit crop in the state can be found at about 150 farm markets and cider mills in Michigan as well as more than 12,000 retail groceries across the U.S., according to Smith.

The Michigan Apple Committee is a grower-funded nonprofit organization devoted to marketing, education and research activities to distinguish the Michigan apple and encourage its consumption in Michigan and around the world. For more information, visit MichiganApples.com.

## Hard cider’s increased popularity is boosting Michigan’s apple industry

The popularity of craft beverages has grown immensely in the last 20 years, and hard cider has quickly become one of the fastest-growing sectors within this industry.

From 2008 to 2019, the number of hard cider drinkers increased from 6.8 million to 24.5 million. The vast variety and popularity of hard cider can be explained by its characteristics that make it appealing to various groups of consumers. Similar to beer and made like wine, hard cider appeals to both men and women. Hard cider is naturally gluten-free, providing consumers with gluten intolerance or celiac disease an alternative to beer and wine.

The Michigan Apple Committee is supportive of the hard cider industry and their work with Michigan Apple growers.

“Michigan cider makers use more Michigan-grown and sourced ingredients than any other craft beverage makers in the state. In a recent Michigan Cider Association survey of Michigan hard cider producers, we learned that, on average, an impressive 93% of the total ingredients utilized in their production were grown locally in Michigan. By choosing Michigan Cider, consumers are demonstrating their support for our local farms and, often, for family-owned small businesses, as well.” said Paula Englin, executive director, Michigan Cider Association.

There are nearly 200 wineries and cideries that produce hard cider in Michigan. Michigan cider makers work with Michigan Apple farmers to grow specific cider apple varieties that are needed to produce hard cider. Many of the apple varieties produced in Michigan, such as Cortland, Winesap and Northern Spy (and others), are used to give hard cider a unique sweet yet acidic taste. Cider makers feel the best ciders present a blend of tannin, acidity and sweetness using a variety of apples. They will often come up with their own blends of varieties to achieve a unique flavor.

“The demand for locally produced food and beverages grows every day. Cider makers based in Michigan are fortunate to have access to a large supply and vast array of locally grown apples,” said Diane Smith, executive director of the Michigan Apple Committee.

It's hard to learn on an empty stomach, and I am proud that we were one of the first states to get this done. It makes a real difference for students.

#### We are supporting student success and well-being by:

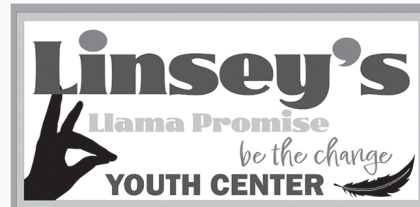
- Delivering additional resources for at-risk students, English language learners, rural districts, and special education students.

### Michigan DNR Fishing Tips—

#### Muskellunge is a premier challenge

Known as "the fish of 10,000 casts," muskellunge are a tremendous game fish native to the lakes and streams of Michigan. They are a prized catch to many anglers but present many challenges. But if you do your research and are patient — you could possibly land a big one!

Muskie anglers can choose from a variety of methods, such as trolling, casting or still fishing with live bait. Tackle requirements for muskellunge are stouter than equipment generally used for walleyes and bass. Larger, bulkier lures and fish that exceed 30 pounds or more call for heavier lines and stronger rods. It should be noted that muskie fishing success usually requires more dedication and persistence than for other species.

### 2025 Ingham County Report of the Liaison Committees

The Liaison Committees have completed their review of the 2025 Controller Recommended Budget. Each committee held meetings between August 2 and August 28 to discuss the Controller's recommendations and to receive comments from the various county departments and agencies. After this review, the proposed 2025 General \$108,394,800. This is an increase of 3.19% over the 2024 amended budget. The total budget amended to \$328,959,736, an increase of 2.87% from the 2024 amended budget. This proposed budget includes funding for 1,291 full-time equivalents (FTEs) (excluding the Medical Care Facility).

The actions of the committees were as follows:

#### COUNTY SERVICES COMMITTEE

The County Services Committee budget was approved with \$17,489,000 in General Fund expenditures, and amended to \$74,975,811 in total expenditures. The committee did not recommend any items to the Strategic Planning Initiative funds.

#### HUMAN SERVICES COMMITTEE

The Human Services Committee budget was approved with \$23,172,124 in General Fund expenditures, and amended to \$121,357,911 in total expenditures. The Human Services Committee primary recommended the following three items for discussion during Finance Committee totaling \$365,656 from the Strategic Planning Initiative funds without ranking:

- \$150,000 to fund Lake Lansing S Pedestrian Entrance.
- \$78,329 to fund Tri-County Aging Consortium Dues out of General Fund instead of the Elder Millage Fund per Controller recommended.
- \$137,327 to fund Veterans Benefit Coordinator position which is fund currently by grant.

#### LAW AND COURTS COMMITTEE

The Law and Courts Committee budget was approved with a General Fund budget of \$69,773,486 and total budget of \$120,051,435. The committee recommended the following two items totaling \$85,700 per the Sheriff's Office request from the Strategic Planning Initiative funds:

- \$69,600 to fund 74 Glock Handguns and Accessories.
- \$16,100 to fund 18 Honor Guard Uniforms

The total of all items referred to the Finance Committee for funding from the \$300,000 Strategic Planning Initiative funds is \$451,356. A complete list of the rankings and the actual votes on the items referred is attached. *(call for the full report for all information)*

The Finance Committee is scheduled to meet Wednesday, September 11, 2024 to consider these recommendations. The Finance Committee will also have a discussion on the Controller's proposed millage rates.
