Summer is upon us, with kids finishing up school and beautiful warm weather in Michigan. It's a perfect time to go

on a staycation right here in Ingham County. Ingham County has incredible parks and trails throughout the county, and they continue to grow due to the Ingham County Parks and Trails millage funding and additional matching grants that have been applied to the millage funding.

In March 2020, Ingham County voters approved renewing the millage to support the development of a county-wide regional trails and parks system. Over the next six years, the \$0.5 million levy will raise an estimated \$4 million annually. Located just minutes from the heart of Lansing, more than 1,200 acres of outstanding Ingham County parkland are devoted to sports and recreation. Enjoy the quiet simplicity of a picnic overlooking Lake Lansing, or spend an afternoon looking for wildflowers, hiking nature trails, or canoeing along the scenic banks of the Grand River.

Lake Lansing South also makes for a beautiful summertime destination. Once a popular amusement park, it is located in Haslett on Lake Lansing, the largest body of water within 30 miles of Lansing. Lake Lansing is 1.2 miles long and 1 mile wide, with a maximum depth of 34 feet. The 30-acre park site includes a sandy beach bordered by four acres of lush green grass. The historical carousel building has been preserved as a reminder of the park's rich history. Come out for a day of picnicking, swimming, fishing, or simply enjoying the scenery and history!

As your county commissioner, I am working on using millage funds and additional revenue to enhance our quality of life within the community, showcase the best sites the county has to offer and focus on the rural communities of our county. If you want to explore these options this summer, know that Ingham County park passes are good for a year! Additionally, if you need help getting to any of these locations, CATA offers free rides to your Ingham County Parks!

Between Insubordination and Micromanagement: Military Command beyond Hollywood

Those who have not served in the military likely envision certain caricatures that they believe are representative. When the military is invoked in conversation, the mind pictures

what the individual believes is a stereotypical servicemember or defaults to characteristics assumed to be central to military culture. Popular culture inordinately contributes to these mental frames, so military caricatures are usually quite skewed.

When you think about the American military, maybe you think of a brash, self-confident non-commissioned officer who is very effective at the mission but also evinces rogue, rebellious tendencies, à la SSG William James in *The Hurt Locker*. Or maybe you imagine intrusive, overbearing senior commissioned or non-commissioned officers who squelch innovation and embody more dictatorial characteristics than leadership qualities, such as those depicted in a myriad of World War II movies and TV shows from *Hogan's Heroes* to *Saving Private Ryan*.

In other words, most popular media depictions of the military seem to showcase one extreme or another. They either emphasize an almost complete absence of upper leadership, leaning into the idea of a one-person army, or a laughable lack of individual autonomy with all decisions flowing top down. How many times have you heard the phrase “That’s an order!” yelled in a war movie? The reality is in fact somewhere in between and more cohesive than how Hollywood likes to depict it. I am sure it is shocking to you that Hollywood is rarely very good at mimicking the military!

What Hollywood misses is the doctrine of mission command, one of the greatest advantages of the U.S. military over the militaries of potential adversaries. The joint concept is predicated on centralized command, distributed control, and decentralized execution, as framed in Air Force Doctrine Publication 1. Put plainly, higher echelons of leadership retain command authority. They set the overarching objectives and issue the commander’s intent. Subordinate forces can then apply that intent wherever they may be distributed. They know what the commander wants, and they start pairing capabilities with requirements.

Finally, the forward echelon responsible for executing the mission is able to innovate to get the mission done. Those forces know the what and why from the commander; the where and when from the distributed control; and they have the freedom and responsibility to develop the who and how. Those tactical forces are empowered with a vector as well as left and right bounds from upper leadership in order to embrace problem solving at their level.

History demonstrates the effectiveness of this methodology. Napoleon’s Grande Armée (at times), U.S. forces in the Pacific in World War II, and even some U.S. battles in the War of 1812 are examples of successful mission command. We also see in Russia’s invasion of Ukraine how inefficient a military can be without mission command. And beyond the military, many contemporary businesses use a form of the mission command concept to foster innovation and growth.

Despite its real-world effectiveness, I suppose mission command makes for less exciting movies and TV shows. But the next time you are watching a salty non-commissioned officer or a micromanaging senior officer on TV, I hope this brief introduction to military command helps fill in a few gaps that popular caricatures overlook.

Michigan House Report

I was pleased to introduce legislation this week that will make sure schools in Michigan carry Narcan, a fast-acting, over-the-counter medication that quickly restores normal breathing to a person whose breathing has slowed or stopped due to an opioid overdose.

This legislation has the potential to save lives. Since 1999, the opioid death rate for people under the age of 21 has skyrocketed from 1.2 deaths per 100,000 to 23 deaths per 100,000.

This isn't a partisan issue. My plan is part of a bipartisan package of bills that aims to reduce instances of overdose-related deaths in our young people. No matter the side of the aisle, we can all agree that the opioid epidemic is a serious issue in Michigan that needs to be addressed.

A plan I helped introduce to provide greater privacy and support for crime victims in Michigan was approved by the House this week.

House Bills 4420-23 would make more victims eligible for additional protections and services by expanding the list of serious crimes covered by the existing Crime Victims' Rights Act. The legislation would also allow victims to use remote technology to deliver their impact statements during a convicted criminal's sentencing process. The plan protects the identity of victims testifying in a court hearing by allowing them to have their images blurred in any publicly available recording of the proceeding. Finally, the plan would help connect survivors of sexual and domestic violence to critical support services.

I'm pleased to see this advancing because I know how essential it is to give crime victims a voice in the criminal justice process. As sheriff, I worked closely with families affected by crime. I understand the importance of treating them with respect and compassion as they face the challenges of the justice system and work to overcome difficult circumstances.

These bills now advance to the Senate for further consideration.

Lone gone are the last days of school for me. My own ended with graduation in June of 1971. I'd be a liar if I said "it seems like only yesterday" when I sat with my 600+ classmates on our football field waiting to get through all the speeches until each one of us walked up to the platform to get our diploma. While I can remember being very uncomfortable in my cap and gown in the afternoon heat, I cannot recall one speech or which one of my classmates delivered it. Living in that moment was certainly an important time in my life but now it's a nice faded memory like an old pair of favorite jeans.

This week kids all over our communities are graduating, too...with the popularity of social media many of their photos are being posted for family and friends to enjoy. Parents are sharing first day/last day comparison photos and they've been great to see...causing me to reflect back on my own trek through elementary school years on into junior high and eventually high school.

Much has changed in the 52 years since I left my high school in Saginaw. We didn't have social media to post photos or create an event for our graduation parties. Goodness, it wasn't until my senior year that we girls were allowed to wear jeans or pants to school.

In my elementary years, on our last half day of school, we COULD wear shorts! Our dress code for the school year was always a dress or skirt...socks with shoes...no sandals or flip flops. We never saw a teacher in pants either...attire for them was the same, and our male teachers were required to wear a tie.

My elementary school was a city block from our home, which meant I walked. Our neighborhood had at least 50 kids, so we always had a group to join as we made our way to Merrill Park. I can remember being excited and nervous all at the same time, arriving on time and getting to my desk, waiting for my teacher to hand me my final report card with all my grades, her written comments regarding my academic growth...notes about behavior...and most important of all...the indication I had passed onto the next grade and who my teacher would be in the new school year. The walk home was filled with relief and all of us kids comparing grades and finding out if we would be in the same classroom with a friend.

I have many fond memories from my school years, most of which were never captured in a photo or social media post that are commonplace today. Some memories are tangled with the current events from the 70s...I can remember the "guys" in my graduating class being concerned about registering for the draft as the VietNam War was being fought... others were headed off to a top ten university, questioning if they were prepared for the rigors of college courses...quite a few went straight into the workforce as Saginaw had three major automobile plants working three shifts, promising good pay and steady employment. A few of my classmates enlisted in the military, a choice that was well respected in our community.

On my graduation night, I got my diploma. Well, actually, I

got the folder my diploma would go into...in order to get my "actual" diploma I had to return my cap and gown...the tassel was mine to keep...along with a bunch of memories that are becoming more difficult to "pull up" in an aging mind...yet always bring a smile to my face when they do...and knowing I no longer need to worry about passing or failing...

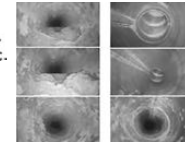

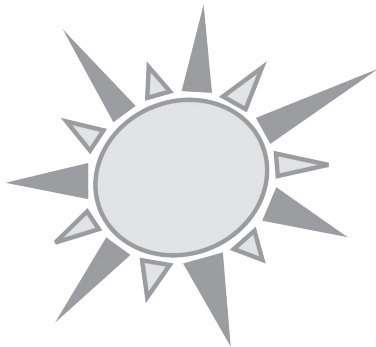

Life Imitates Art

By Jace Arledge

In every era of our nation, there have been songs, paintings, and writings that described what was going on—the sign of the times if you will.

I believe though that the '60's had the most poignant effect on society and its future. The music and poetry that was shared throughout the industry described the pain and struggles of a society of people. Many of those works still influence society. Let's look at some songs.

Blowin in the Wind – 1962 written by Bob Dylan

Bob was said to have written this song not as a protest song, because he doesn't write protest songs, he writes what needs to be heard or spoken by someone or somebody.

Dylan also said that the music was derived from an old Negro spiritual "No More Auction Block." The lyric evoked biblical verse that posed a series of elemental questions about mankind, always with the same implied answer, "that in time man must transcend the senseless inhumanity of war."

In each verse, he drives home the message which echoes Jefferson's famous words in the Constitution that "some truths are self-evident." These answers, Dylan writes, are self-evident, and as obvious and indisputable as the wind. These lines do not leave the listener to decide on an issue. They don't ask what is wrong or right, but how long will it take for people to wake up to the truth?

If you are familiar with the song, the questions can still be asked TODAY in 2023, almost 60 years later...

"How many times must the cannonballs fly before they are forever banned?"

"How many years can some people exist/Before they're allowed to be free?"

"How many times can a man turn his head/And pretend that he just doesn't see?"

"How many deaths will it take 'till he knows/That too many people have died?"

The beauty of this song is that Dylan does not offer answers as much as he gives us the questions and allows us to find the answers on our own. Or at least keep questioning.

The Eve of Destruction sung by Barry McGuire written by P.F. Sloan 1965.

The lyrics discuss wrongs of the American society. Such as "you're old enough to kill but not for voting" which addressed the issue of sending young people off to fight a war that many of them didn't believe in, but also didn't have a say in political issues that mattered to them.

As with Civil Rights, the writer expresses anxiety over this specific matter. And the way he sees it, lack of respect amongst different groups of people is yet another sign of the times. He's not confident that politicians can solve the problem of lack of love between fellow men. Hence the lyrics "a handful of Senators don't make legislation." Which is what we are witnessing today in many states.

Then the issue of hate, with the lyrics "hate your next-door neighbor but don't forget to say grace." How intense. We are witnessing that today, the Bible quotes but what they are missing is the LOVE THY NEIGHBOR part. It's a discrepancy which the writer saw 60 years ago.

Peace Train was written by Cat Stevens in 1971. This song was a call for unity and understanding for the world. Though this became a hippie anthem, often used by protesters to spread a message of peace, there's no political bent to it, and it's relentlessly hopeful, with Stevens "thinking about the good things to come."

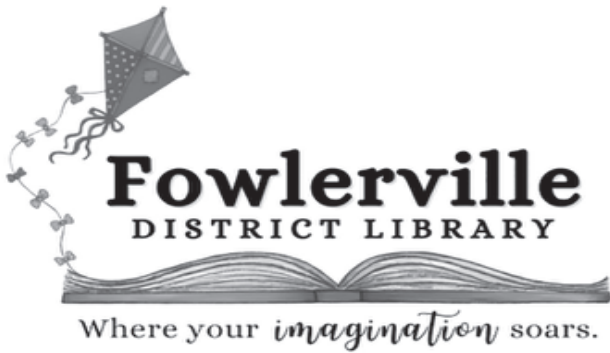

Fowlerville lady observing her 100th birthday this Wednesday, June 13

As far as milestone occasions go, nothing quite matches someone reaching their 100th birthday. A Fowlerville lady will mark that special date this Tuesday, June 13th.

Eleanor Ingersoll was born on that date in 1923—the seventh of eight children of the Voss family who resided on a farm in the Cass City area.

“My parents and four of my older sisters and brothers immigrated to Michigan from Hungary in 1912,” Eleanor noted.

“My father went to night school after arriving here to better understand his new home,” she said. “One of the ways he learned the language was to subscribe to both English and Hungarian newspapers.”

She recalled going to a country school and attending the Catholic Church on Sundays while growing up. “Always

church first and then we'd have company over for a meal,” Eleanor added. “They didn't work much on Sundays.”

Her mother passed away when she was four years old. Her father then raised the large family, with the older children assisting with the care and upbringing of their younger siblings.

When Eleanor was about 15, the family relocated to nearby Akron where she graduated from high school and subsequently met and married Les Ingersoll. Their wedding date was July 1, 1946.

Les, who was a few years older, came from the Vassar area and was initially friends with Eleanor's older sister, Betty—which is how they met.

Her husband was a barber instructor and horse enthusiast and for the next decade the couple lived in different cities in Michigan, along with spending four years in Colorado where Les taught at a barber college and was part-time riding and jumping instructor.

In Michigan, he also trained harness racing horses and drove them in the fair circuit.

It was the horse-racing connection that brought the family, which by then included a daughter Bev and son Jim, to Fowlerville.

“He had met Mac McQuerry (a horse trainer and racer) and Mac told him that Fowlerville would be a good place for him to pursue his harness-racing career and that the town could

use another barber,” Eleanor said.

The family moved here in 1957.

Les owned a barbershop for over 11 years and became part of the horse-racing community. He passed away in October of 1984.

Eleanor, meanwhile, started working as an Avon Lady, selling products for that direct-market cosmetic company, and then began a long career of 25 years at the Chemung Hills Country Club in Howell.

“I started out as a waitress and then became the bar and restaurant manager,” she noted.

After leaving this position, she began working at the bar in Webberville in the mid-1980s when it was owned by her son and daughter-in-law (and known as Sulkys Pub & Grub) and continued when it became Fool's Gold under new ownership.

She finally retired at age 80.

Her interests over the years have included gardening and yard work, quilting, reading, bowling, golfing, traveling, old-time movies and music, and dancing.

These days she lives at her daughter Bev Rife's home in rural Fowlerville.

“Mom always decided when she had gotten too old to do something,” Bev noted. “She quit working, decided on her own when to stop driving a car, and then one day told me she shouldn't live alone anymore.”

Her family now includes three granddaughters, three great-grandsons, and four great-great grandkids, plus lot of nieces and nephews.

As for any tips she might offer on how to reach the age of 100, Eleanor replied, “I've been blessed with good health,” adding that “God smiled on me.”

Village of Fowlerville Residents Reminder Yard Waste Collection

Compost Brush:

Remember to follow the guidelines:

Brush must be stacked in the same direction, parallel to the curb but not in the road. Branches must be no longer than 4 feet and between 1 and 6 inches in diameter. (Twigs and smaller branches need to be bagged and put out in brown yard/compost bags for regularly scheduled pick-up on Mondays.)

Brush must be out by 7:00a.m., no sooner than three (3) days prior to the scheduled pick-up date.

This service is for trimming of brush, shrubs, trees and branches that may fall in a storm. The Village is not able to take tree trunks and root balls.

The Village will not remove brush from clearing of lots or from tree removal.

The last day for Brush pick-up will be November 14, 2023.

Compost Brown Bags:

Yard waste/compost must be in paper yard bags (NO plastic bags). All bags should be placed out for pick-up at residential curbs by 7:00 AM on the morning of each pick-up. **Bags that weigh in excess of 40 pounds will not be picked up.** Please limit it to 5 bags per pick-up. Keeping the bags less than 40 pounds each and limiting the quantity ensures the whole Village will be attended to equally and maintained efficiently.

*Yard Bags will be available to residents for free (limit one pack of 5 bags per week, per resident) for the 2023 season. Bags can be picked up at the Village Offices or at Kodet's True Value Hardware outside of the Village Office's regular business hours. Please show proof of residency when registering. Thank you in advance for your patience with this popular program.

The last day for compost bag pick-up will be November 20, 2023.

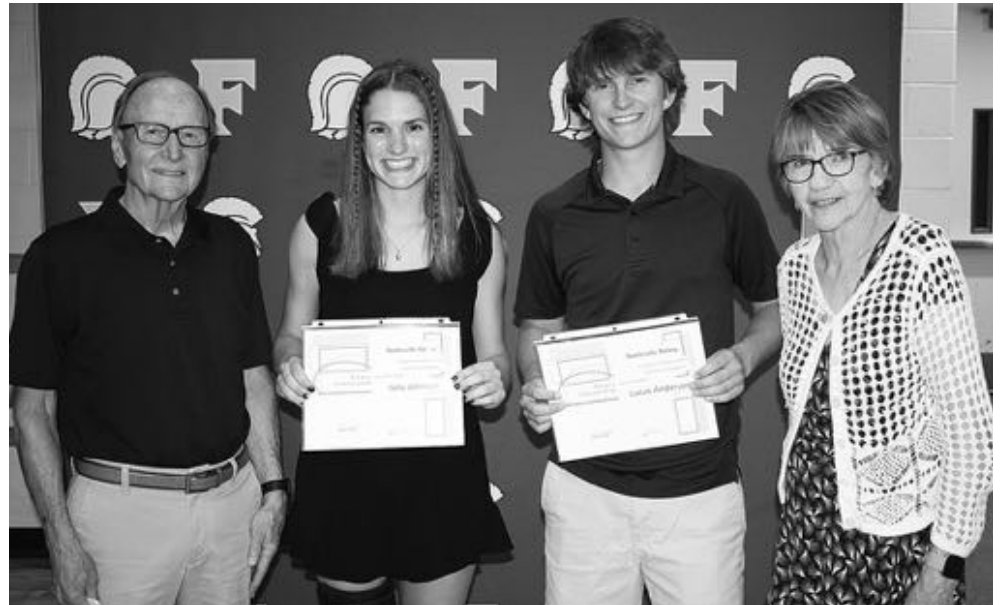
