

Amend to remove the ability of the Township Sexton or other Township official to give permission for grading, leveling, excavating, or plantings outside of a flowerpot or urn; 5 MPH speed limit designation; and to clarify other ordinance provisions.

The Township Board reserves the right to modify or alter the proposed ordinance and amendments at or following the public hearing and to make its decision accordingly.

# Democracy Reevaluated: Values, System, or Function?

Last week, I asserted that we, as fellow Americans, can find common ground when it comes to democracy. To achieve this baseline unity, we must have a clear understanding of the core definition of democracy. As discussed previously, many people use the term to describe ideas and principles that are outside the scope of the definition. That does not mean these addenda are bad, but describing them as fundamental parts of democracy makes agreement and common understanding more difficult. To advance toward some amount of unity, let us consider together what we mean when we refer to democracy.

Most people seem to consider democracy to be a set of values and/or a system of government. For Americans, the set of values that we often associate with democracy stems from our founding and, before that, enlightenment thinking. We are well familiar with the self-evident truths identified in the Declaration of Independence: "that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty, and the pursuit of Happiness."

Fifteen years later, the first ten amendments to the U.S.

Constitution codified and expanded these rights. This mission to refine the principles of democracy continues today, and it is certainly not isolated to the United States. Around the world, people and cultures associate democracy with peace, civil liberties, economic freedom, antiand corruption, principles. But does this set of values change the definition of democracy? Or do these principles address another aspect of government and society?

Before answering that question, we should consider if democracy is a system of government. Again, we can reference our history books. The preamble to the U.S. Constitution outlines several imperatives of government: "establish Justice, insure domestic Tranquility, provide for the common defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our

Posterity." In the American system, we often equate these principles with a democratic system of government.

According to the Declaration of Independence, the self-evident truths of liberty are secured through governments that "[derive] their just powers from the consent of the governed," and as Abraham Lincoln put it so well in 1863, we have a "government of the people, by the people, for the people." Is this, a government of the people, not the essence of democracy? After all, the Constitution famously begins by identifying the participants as "We the People of the United States." Is democracy simply a government endorsed by the people? If so, how do we define endorsement? How do we determine what is a real democracy? Russia and Iran have elections, so should we consider those countries to be democracies?

For those of you conversant in the debate over democracy, these are familiar questions, and you probably have an idea of what you consider to be a real democracy. However, I have found debates over real versus faux democracies very subjective and mostly unhelpful. Even when someone establishes requirements for what constitutes a supposedly real democracy, satisfactory compliance is largely in the eye of the beholder. The question becomes one of degree: is that nation democratic *enough*? If we are not careful, such ambiguous terms can lead to unnecessary disagreements over definitions when the parties actually agree on principles.

So, what is the conclusion? How can we find unity in the midst of complexities and contradictions? We start by returning to the root definition of democracy, which is quite simple. Democracy is the *function* of participation by the people. In other words, democracy is about the right to vote and have a say in the direction of your community, state, and country. The set of values I discussed above is often associated with democracies but is not automatically bound to the function of voting. Likewise, democratic participation can contribute to certain systems of government, but it remains one function, albeit a critical one, within a larger system.

Why is this important? I know it seems like I am making a big to-do about a very small nuance. However, as the tired but still important adage goes, words mean things. We discussed three discrete topics that many people try to lump together: a set of values, a system of government, and a function of democratic participation. I think there is room for healthy debate within these categories, but we must first understand a common lexicon. With this foundation, we can consider the strengths and pitfalls awaiting nations with democratic structures so we can better prepare for the future!

# U.S. Congress Report

# Introduces Bill to Provide Cancer Screenings to Dept. of Defense Firefighters

U.S. Rep. Elissa Slotkin (MI-07) has introduced new, bipartisan legislation to provide cancer screenings to federal firefighters at the Department of Defense. The Federal Fire Fighter Cancer Detection & Prevention Act would provide testing to active-duty and civilian firefighters for prostate, colorectal, and breast cancer as part of their annual Department of Defense physicals.

The testing required by the legislation would be triggered by age thresholds later in firefighters' careers - their 40s and 50s, when screenings for these cancers are generally recommended, as well as if a firefighter exhibits symptoms or is a high-risk individual. Most testing would occur only a few times during the last 10 years of a firefighter's career. The bipartisan bill is co-led by Republican Rep. Don Bacon (NE-02) and is endorsed by the International Association of "Our firefighters charge headfirst Fire Fighters (IAFF). into the flames to keep their communities safe, exposing themselves to dangerous toxins in the process. That's why it's on all of us to make sure they're receiving the proper medical care they've earned," said Slotkin. "This bipartisan bill is an important step towards making sure our Department of Defense firefighters are receiving essential preventative screenings for things like prostate, colorectal, and breast cancer. And because the screenings are optional and incorporated into standard Department of Defense physicals, they won't add any undue burden on patients. I look forward to working with my Democratic and Republican colleagues to get this important bill over the finish line."

### **Letter to the Editor**

The phrase, "Everyone is entitled to their own opinion" keeps coming up in conversations I have with others at school board meetings. I disagree. That expression is for non-lifeand-death situations: discussing favorite music genres, best sports teams, whether or not pineapple belongs on pizza... You know, the "small stuff" that we're told not to sweat.

The fact is, though, there are adults in our community who are actively hurting children because of the opinions they



feel entitled to. This, I feel, crosses multiple lines of ethics and common decency. Firstly, if you're causing harm to any other human, that ought to be a red flag. But even more so, it is our collective adult responsibility to protect the children. (I'm not even going to get into the specifics of the folks who continually use their religious beliefs as validation for the way they are treating minor children.) THIS stuff is a big deal, well worth sweating over, and I'm not being "political" for saying so.

I don't care what you believe; any person claiming to be "concerned about kids" had better be looking out for the interests of ALL of the children in our schools. You cannot pretend to love everyone, to care about everyone, and then ignore the pleas of the ones who just want to exist. They're not asking for much, just to have their basic human needs met while at a place they're legally required to be for most of their waking hours.

They want to go to school and eat lunch without having things thrown at them. They want to be able to use the bathroom without being harassed or threatened. They want to be addressed by the name and pronouns they identify with, just like everyone else.

They want to get through a day without being told through words and actions — that they don't fit in and don't belong in their school or the world. Children! Who are told by their peers that they should just kill themselves. (You know as well as I do that these ideologies start at home. The adults are passing their own bigoted beliefs to the kids in their care,

who in turn, are spewing that bigotry toward other children

This IS a matter of life and death, when children are reporting bullying to the adults that they trust to help them. Brave young people are showing up and speaking out at public board meetings, asking to be given the smallest measures of human dignity (not special treatment as some would claim) and these kids are being met with apathy at best, and derision at worst. They feel the absolute NEED to put themselves at risk of ridicule from other mean-spirited adults in the community, all because their words are not being taken seriously by school administration. They've followed the procedures, gone to the adults and reported the problems, all with no measurable results. And now they're begging to be taken seriously before things escalate to violence.

I will not stand idly by when ANY of our kids' lives are at risk. We talk a lot about safety at school, but we are absolutely failing our children when we refuse to consider the social and emotional aspects of safety that are JUST AS VALID as physical safety needs. Fowlerville Community Schools states in writing and pays lip service to a commitment to not condone bullying of any sort. It's well past time to take ACTION in this regard. For our children. For our schools. For our community.

Boston....when all of us got to a chair to put our shoes back on I remarked on dad's Boston Red Sox hat...the little boy's name...and advised them that my son in law was a diehard Red Sox fan and named his dog Fenway. Not able to resist temptation, I suggested that a future child could be named Fenway...dad laughed...mom smirked at me with a polite smile but wrinkled face that screamed "don't give him any ideas'....beautiful family. Wonder if they'll discuss my suggestion any time in their future?

Along with quaint conversations is my love for lessons that come through "word pictures". The man on the above paddle board represents a powerful lesson in strategy for me and came to me after returning back home. My friend Cathy and I enjoyed a boat ride on Canyon Lake and during the return trip we encountered two people on their paddleboards. In the middle of the lake, they paddled with strength and agility making their way back to the boat launch. One of them actually came quite close to our boat as we created a small wake beside and behind our vessel. That's when I got a good glimpse of the paddle board...its shape, much like a surfboard, a strong cord attached to the paddler's ankle in case they became disconnected from one another, the lone paddle being dipped and pulling the water back as the athlete glided on the water's surface. I could see that this sport was not for the timid or weak beginner...the launch was a good way's off in the distance, strength and endurance was necessary getting back to the safety of shore.

Realizing the effort that goes into the sport of paddleboarding made me think of my own struggles...my recovery working through food addiction ...codependency...fear...anger...to succeed I need people to come alongside me. I need the right equipment and the training that comes with the effort. I need practice using my equipment and must do so with diligence after starting slowly and building up to steady as I go....my anchor that keeps me safe and connected to my "board" is Christ...if I fall or get off track He pulls me back...my paddle is the Word of God...scripture is alive, it speaks and is useful for every challenge that tries to force its energy on a weak mind or body....I have people in my life that encourage me or hold me accountable for my actions...the boat launch is God Himself...He is strong, steady, a rock waiting for me to land on, cling to, walk away from troublesome waters and resume my journey on solid ground. Every adventure on my paddleboard-smooth waters or not-is time with God right beside me every stroke of the journey. Difficulties may produce a "wake" that tosses my paddleboard to and fro, but soon God's calming presence makes the ripples settle down

and become part of the water's looking glass mirror....

People and paddleboards...both offer me a lot of curious and fun opportunities to chit chat my way through a day... learn incredible simple life lessons from the simplicity and beauty of God's creation and those brave enough to turn a board into the adventure of a lifetime!

### Michigan GOP shows hostility to China after courting companies for years

There are hundreds of Chinese companies employing tens of thousands of workers in Michigan, partially a result of aggressive efforts by Republican leaders over the past decade to bring them here.

GOP former Gov. Rick Snyder led a record eight trade missions to China during his eight years as governor. His last trip, a weeklong journey to the Middle Kingdom in 2018, came even as President Donald Trump was waging a trade war against the country.

"These missions are proof that productive dialog and cooperation with other nations ensure we are partners rather than competitors," Snyder said at the time.

China's economy was opening to the world. As the country grew more powerful, there was a widespread view that Americans needed to be better prepared to succeed in a global economy that would be dominated by China and the United States.

Former Oakland County Executive Brooks Patterson, a prominent Republican who died in 2019, was among those who believed young people at least needed to speak China's dominant language. In 2007, Patterson called for Oakland to become the first American county to teach Mandarin in all its

During Snyder's tenure, Chinese companies invested \$1.21 billion in the state and created 6,304 jobs. Today there are 269 Chinese companies operating in Michigan that employ about 32,450 workers, according to the Michigan Economic Development Corp.

The Snyder administration even created a "Michigan/ China Week" to celebrate economic ties between the state

and China.

But there's been a stunning fracture between the U.S. and China over a variety of issues, including President Xi Jinping's reassertion of state control over many Chinese companies, the country's growing aggressiveness toward U.S.-backed Taiwan and Chinese spy balloons flying over U.S. military installations.

Michigan Republicans' position on China has gone from engagement to outward hostility.

Laughably, the state GOP is blaming Democrats for what it says was their collusion with China and "globalist organizations" that "abandoned Detroit and the working class."

Now, the party says, "their eyes are on Michigan. On this current path, Michigan will become the global headquarters for communist influence and power, and drive Michigan into a deeper depression." (Bet you didn't know Michigan was in a depression.)

The controversy is playing out in two electric vehicle battery projects in the state.

Ford Motor Co. is building a \$3.5 billion battery plant in Marshall, licensing battery technology from Contemporary Amperex Technology Co. Ltd. (CATL), a Chinese company that's the world's largest battery maker. Ford's investment is being supported by \$1.7 billion in state and local investment incentives.

And Chinese battery maker Gotion Inc. wants to build a \$2.3 billion battery factory in a rural location near Big Rapids. The state on April 20th approved giving Gotion \$175 million from the Strategic Outreach and Attraction Reserve (SOAR) Fund to aid in the plant's construction.

Together, those plants are expected to employ more than 4,500 workers.

But Republicans in Congress are trying to prevent Ford from receiving billions of dollars in federal Inflation Reduction Act tax credits, designed to help automakers produce batteries and electric vehicles domestically.

Missouri U.S. Rep. Jason Smith, chair of the powerful House Ways and Means Committee, wrote a letter on April 18 to Ford CEO Jim Farley, alleging the company could be exploiting a loophole in the act regarding "countries of concern" receiving battery credits. Others, including Senators Marco Rubio and Joe Manchin, a Democrat who often acts like a Republican, have also criticized the deal.

Farley has said the factory will be wholly owned by Ford, and CATL will not benefit from the tax credits.

Republican Michigan lawmakers claim the Gotion plant, which is slated to be built in Mecosta County's Green Township, is a front for that nation's Communist Party and poses a serious, but unspecified national security threat.

Gotion executive Chuck Thelen vigorously denied such claims in a recent virtual townhall meeting about the factory.

"I'm slated to be the plant manager, and I can assure you, I'm not a communist," he said.

The state Senate Appropriations Committee approved the transfer \$175 million to the SOAR Fund for the Gotion project, the vote was 10-9. All 10 yes votes came from Democrats, but three more Dems voted with Republicans in opposing the expenditure.

Concern about China's involvement in the U.S. economy certainly crosses party lines. A new Pew Research survey found 83% of Americans have a negative view of China. About 40% of Americans see China as an enemy rather than

a partner or competitor.

Automakers are rapidly production ramping up of electric vehicles as governments around the world set emission standards that will result in the demise of the internal combustion engine.

"The problem for U.S. automakers is that they won't be able to meet those standards for at least a few years without using Chinesemade battery materials and technology.

China, which started in investing electric vehicles decades ago, last year controlled 56% of the global battery market and produced most of the materials needed to make them.

But not a single Republican in Congress voted for the Inflation Reduction Act, which offers lucrative incentives for U.S. automakers to eventually end their reliance on China.

Makes you wonder which side the GOP is on, doesn't it?

### Proposed Gotion battery plant, plus taxpaper-funded incentives, present number of concerns

Michigan has a poor track record of business incentive programs. Historically these types of programs have failed to live up to their promises. As taxpayers gave away billions of dollars to attract job creators, the assured jobs did not materialize, and the minimal jobs that were created failed to make

Last year, lawmakers and the governor launched a new corporate welfare scheme - the Strategic Outreach and Attraction Reserve (SOAR) – in another attempt to draw businesses and create jobs by giving away taxpayer-funded "incentives." One of the first projects that was proposed under the new SOAR scheme is the Gotion battery plant. Last week, Democrats on the Senate Appropriations Committee voted to transfer \$175 million from SOAR to the Chinese battery maker, and The Right Place economic development group, who are planning the electric vehicle battery manufacturing plant near Big Rapids. I vehemently oppose the project and voted No.

Every aspect of the proposed Gotion battery plant is concerning, not the least of which being the secrecy in which it has been crafted, and Michigan residents and lawmakers should take heed of the many risks this proposal presents.

The first concern is for the health and safety of our fellow Michiganians. EV battery components are volatile, highly combustible, and toxic. A toxic event at the site would endanger residents, impacting the air, water, and land, and potentially causing mass evacuations, similar to those seen recently in Ohio and Indiana. The local population surrounding the plant lacks the ability to deal with the potential disasters that could occur, through no fault of their own. It would require many more resources, people, and equipment — all at a significant cost that local governments can't afford. And Gotion won't be required to pay local taxes to help support those efforts. An accident could be decimating.

Second, the Gotion plant also presents a significant environmental risk to the greater Big Rapids area, and surrounding communities. With the proposed location of the plant along the Muskegon River, which serves as a source for many lakes and empties into Lake Michigan, any potential accident would risk contaminating a major water resource in the region, not to mention damage to natural landscapes and wildlife.

Gotion has not produced any documentation of its past environmental record, and lawmakers have not been presented with even an unofficial review of the environmental impact for the site, which is typically conducted in these scenarios. Furthermore, I have seen no evidence that one has even been conducted.

Third, Gotion is a national security threat. We shouldn't be giving away land and our citizens' tax dollars to a company that can take orders from the Chinese Communist Party (CCP), which the company admits ties to in its own Articles of Association. The national security threat is greater considering the looming potential conflict between the U.S. and China on the world stage. The idea that a company who explicitly states in its Articles of Association that it will comply with the demands of the CCP means that our residents and our country become secondary to them in a time of conflict.

The threat of the CCP is not imagined. The U.S. federal government is keenly aware of and actively working against this emerging risk to the sovereignty and security of our country, and Michigan by extension. The Federal Bureau of Investigation calls the Chinese government's subversive efforts the FBI's top counterintelligence priority. Per the FBI: "The counterintelligence and economic espionage efforts emanating from the government of China and the Chinese Communist Party are a grave threat to the economic wellbeing and democratic values of the United States."

It is bad enough that Gotion has deep ties to and is directly influenced by the CCP. But that association only scratches the surface of the risks Gotion's battery plant will bring to our state. A potential disaster from this plant is too great a risk to ignore and, if it is approved, I believe Michigan will soon regret its decision. I just hope it's not too late.





Ingham County has had a busy couple of weeks. Press releases have discussed the infrastructure of the County Juvenile Center's needs and what it may look like moving forward. Reorganizations within Ingham County have been presented; they will be going forward in 2023, but a projected general fund shortfall will also be addressed in future Finance Committee Meetings. The BOC must reach a consensus to find solutions that do not affect the quality of services provided to Ingham County residents.

I recently volunteered and was appointed to the Ingham County Strategic Plan Task Force Committee.

The focus of the Strategic Plan process is to:

  - 7) Set goals for the time frame identified.

# What is it trying to teach me? By Jace Arledge

In certain circles, you can hear varied opinions from those who believe there are certain "morals, virtues and laws" one should conduct themselves by. Most of these opinions are based from "A" bible of some sort, be it NIV, KJV, ASB, AMP, CSB, CEB, DBY, ESV, The Inclusive Bible, Jerusalem Bible, MSG, NABRE, NSB and the list goes on (it's funny how many versions there are and there is only one needed, if the words are the same, a form of entrepreneurship perhaps?).

The strange thing is, if you read the words spoken by JESUS, you don't hear those opinions that ring loudly from the mountain tops. No, the words that were spoken BY JESUS were primarily in the form of what are called PARABLES. What is a parable you ask... Let's look at a few descriptions:

- 1. According to the dictionary, parables are short allegorical stories designed to teach a truth, religious principle, or moral lesson. They are often engaging stories that contain few details but are ripe with meaning. Jesus's parables used elements of everyday life to illustrate a more profound message. In modern times, parables are almost always associated with Jesus. (Hallow.com)
- 2. A parable is a succinct, didactic story, in prose or verse, that illustrates one or more instructive lessons or principles. It differs from a fable in that fables employ animals, plants, inanimate objects, or forces of nature as characters, whereas parables have human characters. (Wikipedia)
- 3. Parable: a short, simple story that teaches or explains an idea, especially a moral or religious idea. (Cambridge Dictionary)

SO, one can see that a parable is a short story that explains a moral lesson, religious idea and are almost always associated with JESUS... but what if you don't believe in JESUS, then what? Well, that's a different topic, I digress...

By some counts, Jesus gave us more than 30 parables in the Gospels of Matthew, Mark and Luke. Others suggest the total number of parables by Jesus totals more than 50. He used these forms of telling stories because Jesus encountered so many different groups of people during his public ministry. He spent time with his disciples, with Pharisees, and with large crowds of strangers who were listening to him for the first time. He needed to engage these wildly different groups of people, so he told stories that were able to draw in diverse crowds with different points of view.

These stories revealed the truth about God's kingdom while simultaneously challenging the commonly held world views of many of those to whom He spoke.

This is where the part of "What is it trying to teach me?" comes in. What was Jesus trying to teach anyone who read those stories, in the words of Miley Cyrus WHAT DOES IT

If you have read them, at all, you would see that they all

- 1. Love
- 2. Forgiveness

- 3. God's Kingdom
- 4. Prayer
- 5. Redemption
- 6. End times

With parables we are also mindful to challenge the way we view the world. To see it through the eyes of the CREATOR.

I have had trouble understanding many of these stories as there was something about them that I just didn't see or it didn't "smack me upside the head." Either I was overthinking or wasn't thinking. Jesus does not always explain in-depth the parables He shares. He often omits many details, rarely mentioning people by name.

The lack of explicit explanation and detail prompts us to prayerfully consider the meaning of parables for us in our time and circumstance, given that we are no longer running around in togas and watching gladiators fight wild animals in the Colosseum. Times have changed, evolved and so do meanings and views. You can't talk about how it feels today to hunt and gather your food when all you need to do is get in your car and drive to the store, not walk 100 miles. Interpretation and application must be different, different from 50/100/200/2000 years ago.

If you aren't familiar with where the parables are in the Bible, here's reference for you:

They are in the Synoptic Gospels (there are none in the Gospel of John).

Parables can do the same for us today as they did for the original audience. They can give us a fresh perspective on Jesus' ministry and understanding that God offers His kingdom to EVERYONE. And that is a radical statement in today's society isn't it.. Something for EVERYONE. So I challenge you to read them and tell me what you get out of

Remember what Jesus said in Matthew 13:13, "This is why I speak to them in parables: 'Though seeing, they do not see; though hearing, they do not hear or understand."

Stay kind and LOVE unconditionally!

# **Slam the Scam** with Social Security

By Hillary Hatch, Social Security Public Affairs Specialist

The Social Security Administration and its Office of the Inspector General (OIG) continued to raise public awareness about Social Security imposter scams during the fourth annual "Slam the Scam" Day held in March. Social Security scams — where fraudsters pressure victims into making cash or gift card payments to fix alleged Social Security number problems or to avoid arrest – are an ongoing government imposter fraud scheme.

For several years, Social Security impersonation scams have been one of the most common government imposter scams reported to the Federal Trade Commission. We've made concerted efforts to address this issue, through extensive outreach and investigative initiatives. These efforts have made a significant impact, reducing money reported lost to Social Security scams by 30 percent from 2021 to 2022.

And if your grandkids are 16 or older, or you're traveling to these locations via air, passports will be required.

# Livingston County Comments

This has been a busy month with several extra long meetings. We authorized our budget process and approved ARPA funds for digitizing County Clerk records, several drain projects including a project in Handy Township to fix an ongoing issue with the sewer line that serves the evergrowing Red Cedar Crossing sub on Van Buren Road. We also sent an extra payment to cover our pension liabilities.

The subject that has taken most of the Commissioners' attention this month has been a resolution dealing with our county's response to the eleven-bill gun legislation from Lansing. I think it best to give you some of the text of that resolution so you can form your own opinion of our action. Though, several years ago, we passed a similar resolution, those new to the board, including Chairman Domas, wanted to weigh in on this important issue.

WHEREAS, a "Constitutional County" is defined as a place of refuge for the law-abiding citizen in regards to the citizens' rights under The Constitution of the United States of America and Michigan Constitution including but not limited to the Second Amendment right to Keep and Bear Arms;

NOW THEREFORE IT IS HEREBY RESOLVED, by the Livingston County Board of Commissioners, that the County of Livingston, Michigan, be, and hereby is, declared to be a "Constitutional County"; and

IT IS FURTHER RESOLVED that this Board affirms its support for the Livingston County Sheriff and the Livingston County Prosecuting Attorney and acknowledges and respects their respective oaths of office. This board strongly encourages their utmost discretion in the exercise of their duties in enforcing any statute, law, rule, order, or regulation that is contrary to the rights established by The Constitution of the United States of America and the State of Michigan Constitution; and

BE IT FURTHER RESOLVED that this Board will not authorize or appropriate new funds, resources, employees, agencies, contractors, buildings, detention centers or offices for the sole purposes of enforcing any statute, law, rule, order, or regulation that restricts the rights of any lawabiding citizen affirmed by the Second Amendment or Article 1, Section 6, of the Michigan Constitution, nor be used to aid any state or federal agency in infringing or restricting such rights; and

BE IT FURTHER RESOLVED that the Board respectfully requests the Michigan Legislature, the United States Congress, and other agencies of State and Federal government to vigilantly preserve and protect those rights by rejecting any provision, statute, law, rule, order, or regulation that may infringe, have tendency to infringe or place any additional burdens on the rights of law-abiding citizens to keep and bear arms; ....

There are at least two ways to look at the application of the 2<sup>nd</sup> Amendment. One holds a more strict, limiting view seeking to find as many technical reasons to give the right to bear arms an ever-shrinking field of legal operation. It seems that the same people hold that if guns are controlled that murder by guns will also be controlled. If this point of view is true, Chicago should be a prime example of gun laws' ability to protect lives from "gun violence."

The other view is the natural reasoning that the framers of the original 10 amendments used to fashion the actual words chosen. Life being the most important part of existence, the means to protect your life and property are forever legal. Hence, the ability to possess firearms must not be infringed. The new "red flag" orders work very much like the personal protection orders which can be issued upon the complaint of one person. The thorough due process happens at a later hearing where the target must prove their innocence.

All rights have limits. As "fire" may not be falsely yelled in a theater, neither may anyone cause mayhem or murder with a gun. We do not, however, demand that everyone remain silent for fear that someone yells "fire." I am sure that true mental illness is a legitimate reason to remove this normal right to have a firearm. People dangerous to society should lose all of their liberties, but such drastic measures should

# Michigan's list of birds at risk updated first time since 2009

Michigan officials recently took six birds off of the state's endangered and threatened species list. But they added seven other species.

The last time the list was updated was in 2009. Among the species that newly receive threatened status are the Eastern whip-poor-will, evening grosbeak, golden-winged warbler, Northern goshawk, spruce grouse and upland sandpiper.

Also added is the black tern that annually loses around 7.6% of its population, said Erin Ford, conservation manager at Audubon Great Lakes in Michigan. The group protects and improves bird habitat and advocates for the natural environment.

Ford bands black terns with ID numbers to recapture and track them. In 2018, Ford was banding chicks at the Wigwam Bay State Wildlife Area when a female black tern landed on her assistant.

"The bird kept diving, bombing us and tapping our heads,"

Ford said. "And as soon as we were done with the chicks, we put them back and she was happy and content."

Raccoons ate the eggs out of many nests in the area. The attacking bird's nest was the only one that survived.

"She was so vigilant and protective," Ford said. "She's one of my favorites."

The bird was captured again at the age of four in 2019. The oldest black tern was captured in Wisconsin – it was 10 years and three months old.

Black terns throughout Michigan abandon colonies, even when the habitat looks ideal, Ford said.

The smallest colonies are the higher risk of extinction. Bigger colonies with hundreds of birds have a better chance of surviving, she said. Large colonies are at St. Clair Flats, Wigwam Bay and Munuscong state wildlife areas.

One of the reasons for the decline of the population could be fluctuating water levels, Ford said.

"We had almost no chicks in 2020 because the water was so high," she said.

Black terns nest on floating mats of crushed dead cattails. "When water levels fluctuate and we have big storm events, it can really impact the stability of those mats and it

can cause nests to fail," Ford said.

"Or those mats can disappear completely during deeper water level years, so they have no place to nest. So that's one way that climate change is impacting the species."

There are several ways people can help black terns. When boating and kayaking, slow down next to the nesting sites to avoid destroying them. And report invasive species, such as narrowleaf cattails, to the Midwest Invasive Species Informational Network operated by Michigan State University. Planting native species can also help.

Black terns eat insects and small fish and their chicks and eggs are food for water snakes, turtles and bigger fish, Ford said.

When a species is near extinction, its status is endangered. Listing it as threatened means that the species is likely to become endangered soon. Long-eared owl was uplisted to endangered this year

To support endangered birds, you can register for volunteer stewardship with the Michigan Department of Natural Resources.

The lark sparrow was taken off of the list because it no longer breeds in Michigan. It mainly lives across the Great Plains and Michigan is "outside the core breeding range," said Jennifer Kleitch, an endangered species specialist at the Michigan Department of Natural Resources.

If the species migrated through Michigan, it would still be protected by the Migratory Bird Treaty Act, she said.

Michigan habitat is seeing the greatest loss of birds because of development, population, increased pesticide use and climate change, Ford said. North America has lost 3 billion birds since 1970.

But there is hope.

Conservation efforts restore the population, said Kleitch.

The yellow-throated warbler was delisted because it recovered and no longer needs protection.

Other birds that started to recover and are downlisted with a status of special concern are merlin, prairie warbler, redshouldered hawk and trumpeter swan. This status puts those birds in the Wildlife Action Plan that "is leveraged to bring in money from grant opportunities to better manage" those species, said Kleitch.

There were 15 species that didn't change status. Now it is 25 birds in total compared to 24 species in 2009.

To help update the list in 10 years, people can participate in bird surveys using the eBird app created by Cornell University or register for volunteer training at the Audubon Society.

Among the Michigan good news is that the peregrine falcon and Kirtland's warbler were downlisted from endangered to threatened.

Kirtland's warbler is a globally rare songbird that depends on young jack pines for breeding and nesting.

"The lion's share of breeding habitat is found only in Michigan," Kleitch said.

You can support Kirtland warbler conservation by buying a license plate with its image. The money goes to the Michigan Nongame Fish and Wildlife Trust Fund.

Or you can improve bird habitat in your own yard:

--The Partners for Fish and Wildlife Program led by the U.S. Fish and Wildlife Service helps landowners do that for free

--The Wildlife Habitat Grant Program by the Department of Natural Resources distributes awards for enhancing habitats for game species.

--The Michigan Conservation Reserve Enhancement Program by the U.S. Department of Agriculture and the State of Michigan pays landowners for planting native grass and restoring wetlands.

"Collectively we can help recover rare species and conserve Michigan's natural heritage for generations," Kleitch said.
