#### Fowlerville has five wrestlers qualify for upcoming state meet

Fowlerville has five wrestlers qualified for the upcoming high school state meet at Ford Field in Detroit on March 4-5.

Three of the qualifiers were girls who are on the the Fowlerville team. This is the first year the post-season tournament is being held for female wrestlers under the umbrella of the Michigan High School Athletic Association.

Freshman Margaret Buurma captured a regional championship, winning 6-2 in the 115-pound final over Goodrich's Kendra Vickory. Vickory is ranked No. 1 in the state, while Buurma is No. 9. Buurma went 4-0, reaching the final with two pins and a 15-0 technical fall.

Hannah Arledge-Teran, a senior, placed second in the 120-pound class, losing in the finals to No. 2 Arden Eschtruth

of Midland in an 8-5 decision. She got there by winning her first three matches with pins and then earning 7-6 decision in the semifinals over top-ranked Morgan Irwin of Westland John Glenn before losing 8-5 in the 120 final to No. 2 Arden Eschtruth of Midland.

The third state qualifier for the Gladiators was Gabrielle Damerow, who placed eighth in her 105-pound class.

For the boys who competed in the tournament at Niles, freshman Levi Baker became Fowlerville's first regional champion since 2014 when he pinned DeWitt's Kaden Lapaugh in 5:40 in the 112-pound final

Dalton Daniel, a junior, qualified by placing fourth in his 119-pound class.

Two other Fowlerville boys—Jim Buurma and Jon Davis were unable to advance beyond the Regionals.

#### Fowlerville wrestling history is being made with 5 state qualifiers

After competing in the Regionals last weekend, the Fowlerville High School Wrestling team has five state qualifiers. The historical part is that three of those qualifiers are female athletes. MHSAA has officially recognized girls wrestling as a high school sport this year, so we are going to take our entire girls team to the upcoming state meet.

Those female members include Maggie Buurma, Hannah Arledge-Teram, and Gabby Damerow.

The two boys who qualified were Dalton Daniel and Levi

Each one of our girls has had their own story to get to this

Hannah was a state champ in 2020 when the state tournament was offered and ran by the Michigan Coaches Association. She has provided great leadership as a senior girl that has been through the process before.

Maggie has wrested through the youth leagues for a few years now and joined the high school wrestling team this year as a freshman.

Gabby is a senior that has been recruited to join the team because of her weight and physical abilities. She could have filled in the last two years as a 103 pounder on the Varsity team when we did not have one last year. Now that she has joined the team to get in better condition for track, her spring sport, we have found out her positive personality far outweighs her physical abilities. We should have gotten her out sooner.

Hannah, a past girls state champ, was unable to wrestle last year because of covid rules, but she is playing catch-up to make up for the lost year. She has had some limited time wrestling on the boy's team; however, she wrestled in the girls tournaments and did a good job representing Fowlerville. In fact, she represented us well enough to get seeded in the girls regional tournament. She placed second after beating the 5th seed, 4th seed and the 1st seed. She was 4 wins and 1 loss for the day after losing to the second seed.

Hannah has beaten this opponent before, so anything can happen when she makes it to the state tournament.

Maggie has wrestled some very tough matches this year against both the boys and girls. She dominated in the Regionals, going 4-0, a big step to getting to the state meet. She had 2 pins, a tech fall against a very seasoned wrestler from South Lyon East and a win in the finals against the first seed from Goodrich.

Goodrich is a hotbed for girls wrestling that has turned out quite a few athletes who have qualified for the boys state meet and placed on the national level. I would not be surprised to see these two competitors meeting each other again in the state finals if they both wrestle as well as they did this past Sunday Feb. 20.

Gabby is often forgotten about when people are talking about Fowlerville wrestling. She is a first year wrestler who played a back-up role on the Varsity boys team. Wrestling can be a very physical sport that tries to separate by experience (varsity and JV) and by weight. But there must be some common sense of when we place the athlete in the match or hold them back. We do not put wrestlers in matches when they are not ready.

Gabby was held back until she was ready. She took her losses for the season, but wrestled in all the girls tournaments and a couple of boys duals and got the experience. Just enough experience to get through the girls Regional with an 8th place finish. Don't be surprised, given her athletic ability, work ethic, and desire to improve, that she will find a way to slide into a state placement as well.

Dalton Daniel was sitting in a pretty good spot going into the Regional Tournament at Niles. He finished second in our district and was placed where he would wrestle the third-

place finisher from the other district. He won that match and was matched up with the number one from the other district. Dalton did not wrestle his best match and was pinned.

This put the pressure on him for the next match. He had to win in order to move on to the state meet. After seeing a couple of senior teammates come up short of their goals, it placed even more pressure on Dalton.

He came through by winning his third match and showing the champion of a person he is. His next and final match was with the DeWitt foe. He has been defeated by him before, but Dalton came on to wrestle his best match of the day to make this a competitive match. He lost 4-3 but showed that the next time they wrestle, results will be different.

Qualifying for the state meet coming out of our Regional is a great accomplishment. Our tough Regional places wrestlers at the state meet on a regular basis. If Dalton wrestles up to his capabilities, he is in a position to place high at the state

Levi Baker had a heck of a great day by pinning all three opponents at the Regional tournament. He opened with a win over his St. Joseph opponent, gaining a pin at the 4:17 mark. Next, he met the number 1 from the other district and pinned this Niles opponent in 2:38. The Niles wrestler is a senior and wrestling at home, but this did not interrupt Levi's focus on wrestling his best match.

This set up the finals match with the DeWitt guy that has beaten him twice already, once in our dual meet at Dewitt and the second time just the week earlier in the District finals. Levi attacked first and started with the four-point lead. The match goes back and forth until Levi puts him to his back and finishes it with a pin at 5:40.

This ends the 11 year-drought of not having a freshman qualifier to the state meet from Fowlerville. The seeding committee for the state meet did not give the freshman from Fowlerville much respect when they put the tournament together, but this has not affected Levi in the past. Levi will make his own way, independent of what others think of him. Levi is a special young man.

The state tournament will be held March 4 and 5 at Ford Field. There are four divisions of boys, with our two Fowlerville wrestlers competing in Division 2 and one division of girls. There are five mats per division and add in three mats for the warm-up area. This makes the largest wrestling event ever in Michigan with 28 mats on the field.

This is a historical experience and Fowlerville will have an involvement in both the boys and girls competition.

Thank you to everyone that tuned in on Friday, February 25\*\*to discuss auto no-fault insurance! It was a great discussion and I'm hoping everyone enjoyed it just as much as I did!

This week, my bill, HB 4065 was up for testimony in the House Military, Veterans, and Homeland Security Committee. This bill would amend the Michigan Military Act to authorize the adjutant general to award the Michigan Vietnam Veteran Recognition Certificate in the name of the legislature for those who served in the military during that war. There'll also be a special insignia for those veterans who suffered medical issues from exposure to the Agent Orange chemical while serving in the war.

I had a group of veterans from our county at the capitol testifying in support of the bill. Thank you for visiting and for your service!

According to the Michigan Public Service Commission, eligible Michiganders may qualify for monthly assistance toward paying their monthly home internet bill under the federal Affordable Connectivity Program, and the Michigan Public Service Commission today is sharing information to make it easy to determine your eligibility and sign up for the benefit. #### **Initial Implications of Ukraine**

During the last week, Russian President Vladimir Putin, with the support of the legislative Duma, recognized the Ukrainian separatist regions of Donetsk and Luhansk as independent states; deployed military forces into eastern Ukraine to support the separatist factions; and launched a large-scale, unprovoked, and unjustified assault against Ukraine. Perhaps in a glimpse of his larger objectives, Putin also demanded that Ukraine recognize Russia's occupation of the Ukrainian territory of Crimea as legitimate, give up its semi-advanced weapons, and agree to never join NATO or develop closer ties with the West. Furthermore, over the past several weeks, Moscow repeatedly called on the U.S. and NATO, the foremost Western military alliance, to ban the possibility of membership for Ukraine and reduce the allies' regional military posture.

Why is Putin doing this, and why should we, as Americans, care? Since Ukraine's independence with the breakup of the Soviet Union, Russia, especially under President Putin, has attempted to exert political influence and military pressure on its neighbor and former ally. The people of Ukraine are divided between those who lean pro-Russia and those who are more pro-Western, and as one might expect, this split

> has contributed to internal external political manipulation.

In perhaps the most prominent example 2013 and 2014, Ukrainian President Viktor Yanukovych backed away from closer ties with the European Union after pressure from Russia, and protestors upset with this decision demonstrated across the country. Many other Ukrainians opposed the protestors, but the Ukrainian parliament ousted President Yanukovych. Shortly thereafter, Russian President Putin sent unmarked troops to secure the Ukrainian Crimea peninsula as a Russian territory, claiming to represent the interests of the people of Crimea. Shortly thereafter, pro-Russian separatists in Donetsk and Luhansk seized government and claimed buildings independence from Ukraine, igniting a years-long civil war.

Likely, no one except Putin knows for certain how far he will push his disruptive actions, but we can judge some of his prospective motivations and evaluate recent trends. First, by recognizing the independence of Donetsk and Luhansk, he can depict Russian provocations as defensive, stabilizing measures. In reality, Russia's invasion exploits and heightens Ukraine's instability to benefit Russia as it seeks to dominate another sovereign country. Putin declared an unprovoked war for the sake of his ambitions.

Second, Putin rose to power during Russia's decline after the Cold War, and he seeks a rejuvenated Russia with greater regional dominance. To achieve this, Putin is willing to use military and political coercion at the expense of other states' sovereignty and international stability, and Ukraine is a stumbling block to Russian influence. Russia is well-versed in deception and disinformation, using a blend of hard and soft power to increase uncertainty and encourage sympathy. Putin seeks personal and national gains by towing the line of what he thinks he can get away with on the international

Despite taking place almost on the other side of the world, the events in Ukraine matter to Americans. Putin is challenging the international order that the U.S. helped build and still leads. More specifically, Russia is demonstrating a concerning disregard for national sovereignty, human rights. and global peace and stability. Tragically, the Ukrainian people sit in the crosshairs of Putin's ambitions. Russia's actions must not become a trend. If the U.S. does not remain strong in opposition to Russian aggression, then other nations may perceive a lack of resolve and pursue similarly hostile behavior. What happens abroad sooner or later affects us at home. To avoid escalation and unnecessary bloodshed, the U.S. must act tactfully, and in so doing, we must demonstrate wise leadership.

#### **Veterans Council names Veteran** & Auxiliary Members of the Year

The Livingston County Veterans Council recently named the Veteran of the Year and the Auxiliary Member of the Year. Council and members voted to name Gary Dunn as the Veteran of the Year for Livingston County. He's well known around the community for his involvement with various organizations and efforts but notably, the U.S Marine Corps "Toys for Tots" every holiday season. The Auxiliary Member of the Year is Dale Brewer, the Commander of the Disabled Veterans Unit 125. He's also very active in the community with different events and fundraising efforts and is a member of the Fowlerville July 4th Committee.

David Mester, the Senior Vice Commandant of the Marine Corps League 161 who headed the selection process, provided the following information about the recipients.

#### GARY DUNN

#### **Livingston County Veteran of the Year**

Gary joined the U.S. Marine Corps in December 1967 and served during the Vietnam Conflict. In December 1973 he was discharged from military service and moved to Michigan.

In 2004, Gary joined the Marine Corps League, David Muringham Detachment 161 located in Howell, Michigan. Since joining the league, he has shared and provided his winwin attitude with everyone he meets. He is not the type of person to just participate, but rather the person who wishes to get involved in the affairs of MCL and the surrounding community.

Gary has been chairman of the Toys for Tots in Livingston County since 2004 and recently promoted to District Manager and Trainer for Toys for Tots. The Afghan, and Iraqi war lasted 20 years. Gary has been providing Christmas toys to children of veterans and non-veteran families for the past 17 years. In 2008, the Livingston County location became an independent unit reporting directly to the Toys for Tots Foundation.

Gary has built, with the help of many volunteers, the "Toys for Tots Train Float" and participates in "Fantasy of Lights Parade" in Howell and the "Christmas in the Ville Parade" in Fowlerville, Michigan. This float has won the Grand Marshal's Award twice.

In recent years the "Toys for Tots" Program has expanded under the direction of Gary to update gifts for children ages 9 thru 16 to include electronic devices. In 2021, Toys for Tots distributed 31,000 gifts prior to the Christmas Holiday from the Salvation Army Warehouse. That is approximately more than 2,100 veteran and non-veteran families.

It should be noted that Gary or a volunteer will meet with a family member and let them pick the toys for their children. A pickup date will be assigned, and the toys are packaged. In addition, Gary has worked with the Salvation Army as a 50-50 partner for the last four years to ensure these families receive food for the holiday season.

Gary continues to be active in both community and veteran affairs in Livingston County. He has donated many hours and

personal resources to Toys for Tots in Livingston County

#### DALE BREWER

#### **Livingston County Auxiliary Member of the Year**

Dale began volunteering with Disabled American Veterans (DAV) CHAPTER 125 in 2014. He participated in a fundraising committee which was a car show and continued as an active volunteer. This ultimately led to the formation of the DAV Auxiliary Unit 125 in 2017.

Dale has been the Commander of the DAV Auxiliary Unit for the past five years. In addition, he is a 125 Auxiliary Charter Member. The DAV Auxiliary Unit 125 is weaved into the fabric of the Disabled American Veterans Chapter 125, but considered as two separate organizations.

In addition, Dale is involved with the Connect Five Veterans Foundation that benefits both organizations by enlisted talent from both DAV groups to create a team success. This new approach has raised the bar for other DAV units in the state to follow

Dale is a positive person and participates in many local community activities such as the Fowlerville Fourth of July Committee, Wreaths Across America, Fowlerville Chili Cook Off, Darren McCarty Fundraiser, and Gleaner's Mobile Food Program to name just a few. His attitude has provided him the reward of being Michigan State Disabled Auxiliary representative to the Great Lakes Cemetery Advisory Council.



### Love Your Enemy: Who & How?

By Scott Herald, Pastor of Fowlerville First United Methodist Church

Scripture Reading: Luke 6:27-38 (Common English Bible)

"But I say to you who are willing to hear: Love your enemies. Do good to those who hate you. Bless those who curse you. Pray for those who mistreat you. If someone slaps you on the cheek, offer the other one as well. If someone takes your coat, don't withhold your shirt either. Give to everyone who asks and don't demand your things back from those who take them. Treat people in the same way that you want them to treat you.

"If you love those who love you, why should you be commended? Even sinners love those who love them. If you do good to those who do good to you, why should you be commended? Even sinners do that. If you lend to those from whom you expect repayment, why should you be commended? Even sinners lend to sinners expecting to be paid back in full. Instead, love your enemies, do good, and lend expecting nothing in return. If you do, you will have a great reward. You will be acting the way children of the Most High act, for he is kind to ungrateful and wicked people. Be compassionate just as your Father is compassionate.

"Don't judge, and you won't be judged. Don't condemn, and you won't be condemned. Forgive, and you will be forgiven. Give, and it will be given to you. A good portion—packed down, firmly shaken, and overflowing—will fall into your lap. The portion you give will determine the portion you receive in return."

#### Message

"Willing to hear" ... This phrase has captured my attention. Jesus opens with it in the second half of his Sermon on the Plain: "I say to you who are willing to hear?"

I have spent quite a bit of time trying to get a handle on why that simple phrase should so captivate me. Could it be because I feel guilty for not listening? For not being willing?

Or maybe I start to pay attention because this is exactly what I want to hear.

Today's scripture addresses questions relevant to our time: "How are we supposed to treat others?" and "Does God's love actually extend to all?"

Jesus has come to turn the world upside down. Worldly wisdom has no place in the kingdom. Jesus offers blessings for people who have most likely never been blessed. And he presents woes to all those who have been successful in the world's eyes when he says, "how terrible for you."

Then, he invites the disciples to participate in his work by offering love and grace to everyone, especially those who do not deserve it.

As we pick up the continuation of the Sermon on the Plain, I wonder what the disciples thought as Jesus continued speaking. Just how many "would be" Disciples "tuned out" because the message was too hard?

We know that as Christians we have two main rules: love God and love others as we love ourselves (Matthew 2:36-40). When we do these things *we fulfill all of the law*. It sounds so easy ... doesn't it? Yet this is probably one of the most challenging passages of scripture we are to practice.

If we are (really) listening, this message will no doubt cause us to shift in our seats. It is both uncomfortable and convicting. When we finish reading scripture in worship we say, "The word of God for the people of God, thanks be to God."

But are we really thankful for this difficult message? I don't know about you, but sometimes I just want to grumble the response under my breath. I guess I've tuned out, canceled or am just plain unwilling to listen at times. Jesus offers this message to his disciples *who are willing to hear*.

Friends, are we willing to hear?

After all, wouldn't it be much easier if Jesus had left this part out?

Christ died for us while we were sinners. Why are we supposed to love our enemies? Because we were enemies of God and God has been gracious with us.

In Christ, God has surprised us with mercy, grace, and forgiveness. For those of us willing to listen, we are called to do the same for others!

Loving our enemies ... I want to pause a moment; maybe it's the word "enemies" that causes us issue. So, let's try "neighbor" instead ... love our neighbor as ourselves. Sadly, that doesn't seem to work either, does it? But it certainly would be a place to start.

Loving our enemies begins when we recognize that God cares as deeply for them as God cares for us!

It means recognizing that our enemies or neighbors are also children of God created in God's image!

How is that possible?

When we love our enemies, we are loving the image of God within them. We love them not because we think they "deserve" it, but because we have experienced God's love and forgiveness in our own lives and we know the power it holds.

How we treat others is an indication of whether we are willing to hear. It is a direct reflection of whether or not we have truly acknowledged and received God's grace and love.

We talk a lot about loving God and loving others, but rarely do we talk about loving ourselves. Our scripture includes a version of the golden rule: " *Treat people in the same way that you want them to treat you.*"

We know that oftentimes people do hurtful things because they are hurting within. It can be hard to know how to treat others well if you have never been treated well. This does not excuse bad behavior, but it makes it even more important for us to *surprise* others with love and compassion.

Hold this thought; our "enemy" may come to know the surprising love of God through us!

One lesson my father had taught me was that our family name did not have scandal attached to it. So, how is it possible that God loves and has compassion for those that are the example of scandalous behavior? How is it possible that God loves and has compassion for those who aren't even willing to try ... let alone listen

How could God love someone who hates me, who has caused me pain?

Getting past this stumbling block of the realization that God loves the person, the people who have caused me and mine pain and suffering, the same people that may even intend to do it again ... well, moving beyond that is hard indeed

Perhaps moving over or through isn't the point. Maybe it's more of moving to the side by way of praying for our enemies ... which is moving toward what Jesus is calling us to hear!

Love is compelling and transformative. Love breaks down barriers and walls. Jesus loved even until the end. Jesus, even as he was dying on the cross, offered forgiveness and love to the thief next to him. As if that wasn't enough, Jesus even loved us through the grave, coming back to offer new life for those who condemned him.

This is who we follow. This is the sacrificial love we are called to embody.

It is not easy, but it is what will indeed transform the world into the world God intends for it to be.

Who in our lives needs to know the surprising love of Jesus? Who needs to experience grace and forgiveness? Love them. Pray for them. Serve them.

With this thought; I am reminded of the transforming power of prayer; prayer may not change things for you, but prayer will change you for things!

As a beloved Child of God ... If you are willing to hear ... (then) Love your enemies. Do good to those who hate you. Bless those who curse you. Pray for those who mistreat you. Love people in the same way that you want them to love you





#### WONDERFUL SOUR CREAM CAKE

- 3 cups granulated sugar
- 1 cup commercial sour cream
- 6 eggs, separated
- 2 sticks butter (substitute will not do)
- 3 cups all purpose flour
- 1/4 teaspoons soda

- 1 teaspoon almond extract
- 1 teaspoon vanilla

Cream butter and sugar, add egg yolks one at a time, beat well after each addition. Add soda to sour cream. Add flour and sour cream alternately to mixture blending well after addition. Add flavoring. Fold in stiffly beaten egg whites. Pour into well greased lightly floured tube pan & bake 1 1/2 hours at 300 degrees. It is best when not frosted and will keep a week if covered.

#### Jim Hall remembered for contributions to community's economic development

"Jim had a passion for our community and for economic development" was how his friend and associate Fred Dillingham described C. James 'Jim' Hall who passed way this past Saturday, Feb. 19, at age 79.

Hall and his wife Barb have been living in Au Gres, a town located on Lake Huron, since his retirement in 2009. For most of his life, though, starting from the time he was young, Fowlerville was "home." He was a longtime businessman, serving 42 years as the State Farm Insurance agent, and during that time was very active in community affairs. His involvement included, at one time or the other, membership in the Fowlerville Rotary and Fowlerville Commercial Club, along with serving as treasurer on the Fowlerville Fair Board and as a longtime chair of the Village Planning Commission.

But it was in economic development that he spent much of his time and energy. He was among those who founded the Livingston Economic Development Council in the early 1980s, a public-private non-profit organization that works to bring new businesses to the county.

In the early 1990's, he was instrumental in helping establish two valuable tools that helped promote economic development in the Fowlerville community.

The first was the creation of the Village's Downtown Development Authority, a board appointed by council that uses captured property taxes within the DDA District to fund various infrastructure improvements and promote commercial activity.

The second was the formation of the Local Development Financing Authority (LDFA)—also appointed by council—that administers the Village's industrial parks, also using captured property taxes within the LDFA boundaries to fund necessary improvements and maintenance and to attract new businesses to the area.

"Because of Jim's understanding of economic development from serving on the county EDC, he was very instrumental in creating the DDA and LDFA for our community," said Dillingham. "The LDFA proved to be especially important because it has been the tool used to finance the infrastructure improvements on East Van Riper Road that led to the factories locating there and then later the creation of the Garden Lane Park and the National Park off West Grand River."

Dillingham noted that he'd worked with Hall on economic development projects for the Fowlerville area during his time as a state legislator, but more so after he became the executive director of the Livingston EDC, adding that "Jim (as a board member) recruited me for the position."

"I had been gone from the state Senate for about a year when he contacted me, urging me to apply for the director's position that was open," Dillingham recalled. "I interviewed for the job and, I'm sure that Jim lobbied his fellow board members to hire me."

Dillingham was the third executive director of the EDC, with Jim Thompson being the first and then Dan Foster. It was Thompson, working with Hall, who accomplished an important stepping stone that was vital to eventually opening up the southern area of the Village for industrial development.

That stepping stone was obtaining a Community Development Block Grant from the State of Michigan that, along with a local match from the Village, financed the construction of a new water tower. This tower, coupled with the one in the Downtown area, would eventually provide the necessary water pressure for fire suppression systems in the factories, along with allowing the expansion of water lines to neighboring areas, including residential and commercial developments.

"The water tower was the beginning of everything that was done on East Van Riper Road," noted Dillingham. "But, when Kelsey-Hayes expressed an interest in locating a new anti-lock brake assembly plant here, additional infrastructure improvements were needed, an incentive package had to be put together, and this is where the LDFA became necessary and where Jim's leadership, as its chair, played a key role."

Ed Alverson, in his roles as Handy Township supervisor and school superintendent, worked with Hall on various projects, but also in creating zoning ordinances and other legal tools that would prepare the community for future development.

"I served with him on both of the boards and talked with him on various matters," Alverson said. "As far as economic development, he was visionary. He had a great sense of community. In pushing for economic development, he saw it as a means of creating jobs close to home, of those residents who had those jobs frequenting local businesses, and of having a higher tax base that would result in various community improvements."

Among those improvements have been new school buildings and a major maintenance program for the school district, the projects made more affordable due to the industrial tax base. The last couple of bond issues, for example, including the recent one to construct a new elementary school, have not

required an increase in the millage levy. Instead, the debt is being retired by extending the pay-off period a few years.

"Having all of those businesses in the industrial parks has a big impact on the taxable value and allowed the community to do things that it maybe wouldn't have otherwise been able to do, or the cost would have been higher for individual taxpayers," said Alverson.

"Another important thing, although not as easy to measure, is that he helped support efforts to create harmony between the Village and Handy Township so we could avoid the turf battles that have occurred in other communities with development projects,"

he pointed out. "He also, in his conversations with local government officials, stressed the need for Fowlerville to be a 'business friendly' place. That welcoming attitude helped bring a couple of manufacturers to our community who might have located elsewhere.

"But, beyond what he did for economic development, Jim was a person who loved his family and cared a great deal for his community," he added. "He only wanted to see the very best for it."

Echoing the comments of both Dillingham and Alverson was Phil Utter, who served on the LDFA with Hall, was a fellow business owner, and partnered on a housing development.

"Jim Hall was a good friend, great business partner and a visionary leader in our community," said Utter. "Jim was the driving force behind the establishment of both the Fowlerville Downtown Development Authority as well as the Fowlerville Local Development Finance Authority. Both of these boards have been in place for nearly 30 years now and combined have created more than 1,300 new jobs in our community. In addition to the jobs created, the private and public investments in both of these districts have resulted in major infrastructure improvements and a substantial tax base that would most likely not be in place today without these two entities being created."

Utter noted that Hall not only served on the boards, but promoted their importance.

"During his time as chair of both boards, Jim took the time to invite new members of the Village Council to his office so that he could walk them through the structure and benefits of both the DDA and the LDFA and why it made sense to have them in place," he said.

Utter added that Hall's vision extended beyond what happened at the industrial parks and in the Downtown Business District, pointing to a housing development that the two of them undertook.

"Another idea that Jim had that came to fruition was Addison Farms Condominiums in Fowlerville," Utter said. "I was fortunate to be a co-developer with him on this project which was started in 1997. It took a little while for the condominium concept to catch on in our community; however, today it is a sought-after development with local realtors having clients waiting for a home in Addison Farms to become available.

"Jim was all about making Fowlerville a better place to live," Utter continued. "He was constantly working on ideas and initiatives which would make our community stand out among its peers.

"I was extremely fortunate to call Jim Hall my friend. Working with him on a variety of matters, from my insurance needs to economic development, he was always there, and we worked well together. Everyone in our community has experienced some level of benefit, either directly or

indirectly, from the efforts of Jim Hall. He will be truly missed."

Cindy Denby, in her comments, pointed out that she had different interactions with Hall over the years, including being a student of his in high school, a secretary for Jim Thompson when he was the Livingston EDC executive director, a Handy Township supervisor, a legislative aide, and a state representative.

"My first experience in getting to know Jim was

when I was a Fowlerville High School student and he taught a Michigan History class," she said. "History and government were some of my favorite classes and in that class we were required to learn the names of all the townships in Livingston County."

Hall had started out as a teacher after graduating from college, prior to purchasing the local State Farm Agency. During his first few years as an insurance agent, he taught on a part-time basis.

That initial student-teacher relationship was only the start.

"During the next 40-plus years, we not only became friends but our paths would cross over and over where we served and worked together on several boards which included the Livingston County Economic Development Council, Fowlerville LDFA and DDA," she said. "Jim was truly a community leader who was always looking at ways to encourage economic growth in Fowlerville as well as other areas of Livingston County. His leadership over the years would result in employment opportunities for area residents for years to come.

"After he retired (in 2009) and moved to Au Gres, he would email me business articles that he found interesting and thought I would like to read," she pointed out. "He never lost interest in looking at projects that would impact a community and the quality of life for the residents."

For Ken Curtis, Jim was both a brother-in-law and fellow Fowlerville businessman, Rotarian, and Downtown Development Authority Board member. But their association goes back a long ways as they had both attended school together, with Ken being two years younger, and were teammates on the Gladiator high school sports teams.

His older sister's marriage to Jim served to further deepen that association and, over the years, they often worked on efforts to improve and enhance the community.

"He was a great committee member on the county EDC board, along with the LDFA and the DDA," said Curtis. "He was very interested in economic development and did a lot of research. He took the time to understand what was going on. If there was a major development that might be coming here, he'd go so far as to walk the land to better understand the situation.

"What happened in the industrial parks was very important to him, but he was also involved in a number of projects we did with the DDA where we tore down old buildings to expand parking and also to bring new street lighting along Grand River and Grand Avenue. He worked to make the Downtown Business District more attractive.

"A lot of what he did over the years was behind-the-scenes," Curtis noted. "A lot of people don't realize all that he did for our community. In that regard, he was an unsung hero."



\*Fowlerville News & Views: Steve Horton (editorpublisher of this newspaper) summed up the "rights" issue concerning property and vaccinations in his commentary last week. He has a way of provoking thought and discussion that creates understanding.

The issue has been very contentious in Ingham County and primarily in the rural areas. Mask requirements, quarantines, lost educational seat time, parental rights, etc. have been in

Ingham County has rigid standards for employees. Probate and Circuit Court are under the umbrella of the County, but separate employers. The Courts did not require the same standards and relied upon the employee's judgement, providing flexibility to work from home if necessary if feeling

The Executive Office and State Board of Education did not want to make a decision, except to say others should decide. The 83 counties and health departments may have different opinions. And, of course, the School Districts were left to work through it all.

The Center for Disease Control focuses on the single aspect of COVID and compares it with other communicable diseases. The Guidelines are constantly changing as a moving target. There is a much broader picture that sometimes gets overlooked. That is "total benefits for actions vs. total costs."

In this case, COVID is slowing. However, in Ingham County the cases of Child Abuse, Substance Abuse, Mental Health, Lost Education, Crime, Financial Ruin, and other societal problems have soared. There isn't a price tag that could be placed on these factors.

In the big picture, the CDC issues Guidelines as it should. However, the approach is not holistic. It would be similar to asking an Orthopedic Surgeon to be your only health care professional, dentist and oral surgeon.

Meanwhile, the local school boards, administration and staff go through the grinder because they are on the firing line. It is important to remember, they did not choose to be in the position.

I am not seeking re-election. Thus, I am complimenting Steve Horton and the Fowlerville News & Views. It is never phony. In my entire career, the most open and flexible news media has been this paper. Anyone can write without censure, without some editor not liking your opinion, and with open

The major outlets in Ingham County filter news for sensationalism. They will endorse or not endorse based on the owner's value system. In the last election, an editor insisted on knowing who I would vote for and who did I vote for; if it was for a candidate he did not like, I would lose the endorsement.

Needless to say, I said it was my sacred and personal right and it was none of his concern. Evaluate me as a commissioner.

\*Sheriff Wrigglesworth: He has done an amazing job in a very difficult situation for the past two years. Imagine a 24/7 operation as complex as a Sheriff Department.



When asked about her favorite part of class, Lauren shared, "Meeting new people and getting the opportunity to step out of my comfort zone."

Lauren's future career goal is first to become a veterinary technician, and later a radiation therapist. She plans to attend Baker College next fall and study veterinary technology. Lauren recently completed a six-week internship at the Fowlerville Veterinary Clinic. This provided her with an opportunity to really see what a career as a vet tech would look like. During her internship Lauren shadowed a current vet tech, and had the opportunity to observe appointments and help with the animals at times. We are required to periodically conduct Continuing Disability Reviews for beneficiaries with disabilities. This process requires that beneficiaries complete a Continuing Disability Review packet, that we mail to beneficiaries, to help us update information about their medical conditions and recent treatments.

Additionally, we offer an online option for beneficiaries to complete the Disability Update Report form and provide any supporting documents about their medical treatment or work activities.

We designed this form with convenience in mind — and to save you time. You can access the online form at <a href="www.ssa.gov/ssa455-online-form">www.ssa.gov/ssa455-online-form</a>. (Use either Microsoft Edge or Google Chrome for the best online experience.)

When you complete your Continuing Disability Review, you will need your Social Security number, current address and phone number, and a valid email address to complete the form. Also, you must have received a request for an updated disability report in the mail.

Once you "Click to Sign," you will receive an email from <a href="echosign.com">echosign.com</a> asking you to confirm your digital signature. Check your junk folder if you don't receive it within a few minutes. If your signature isn't complete, your form won't be processed.

### U.S. Congress Report

#### **Co-Sponsors Bill to Suspend Federal Gas Tax**

U.S. Rep. Elissa Slotkin (MI-08) has announced that she will co-sponsor the *The Gas Prices Relief Act*, a bill that would suspend the federal gas tax for the rest of 2022. By eliminating the roughly 18-cent-per-gallon tax until 2023, Slotkin's legislation would help ease the financial burden Michigan families and workers are facing at the pump.

"Inflation isn't just some political buzzword bouncing around Washington—it is real, and it is making life more expensive for Michigan families. Today, after too much talk from politicians in both parties, I am taking action by leading this bill to suspend the federal gas tax for the rest of 2022," Slotkin said.

"The fact is that Michiganders already pay some of the highest gas taxes in the country, and this bill would save them 18 cents per gallon," she added. "Many mid-Michiganders commute long distances each day for work or for school, and my legislation is designed to do one thing: decrease the cost at the pump and put money back in their pockets."

Slotkin noted that in 2015, Republicans in the State Legislature voted to raise Michigan's state gas tax and index it to inflation. Currently, the state's gas tax stands at 27.7 cents per gallon. The state currently has the 10th highest gas tax in the nation.

The Gas Prices Relief Act will lower high gas prices and deliver much-needed economic relief to Americans across the country by:

--Suspending the 18.4 cents per gallon federal gas tax until January 1, 2023. Currently, the national average for the cost of a gallon of gas is nearly one dollar higher than it was at the same time last year, according to AAA.

Michiganders are currently paying an average of \$3.35/gallon at the pump.

--Requiring the Secretary of the Treasury to monitor the program in order to ensure oil and gas companies pass along the savings at the pump to consumers. The bill also encourages the Secretary to take appropriate enforcement actions to ensure consumers see these savings.
