The newly-renovated Livingston County Veterans Memorial will be the setting of a special Veterans Day ceremony and ribbon cutting at the Historic Courthouse in Howell on Nov. 11th. After fundraising and generous donations from our community earlier this year, renovations to the Veterans Memorial including improved lighting and six granite stones displaying the badges of the United States military were approved. Installation of the lighting and stones is scheduled to happen in early November, just in time for Veterans Day.

On the day that we as a nation honor the contributions and sacrifices of our nation's Veterans, Livingston County Veteran Services, Howell's American Legion Post 141, Howell Chamber of Commerce, and the City of Howell will commemorate our local Veterans. Ribbon-cutting ceremony planned Nov. 1st for new Fowlerville Elementary School

Fowlerville Community Schools is pleased to announce the near completion of the new elementary school. The district will host a ribbon-cutting ceremony and special event on Friday, Nov. 1st from 4:00-6:00pm and the community is invited to attend. The newly-constructed building will serve all kindergarten through second grade students in the district. In the coming weeks, staff will begin transitioning and moving into the new facility, which will officially open full-time to students and staff on Tuesday, Jan. 21, 2025 with the start of the second semester.

This new Fowlerville Elementary School was made possible by the \$41.9 million dollar bond that voters approved in November 2021. The bond funds are not only being used to construct the new building but also to improve air quality in all buildings (including adding air conditioning), closing the Munn building and creating green space for future athletic improvements. In addition, it includes renovations at H.T. Smith Elementary to house the Little Glad Center, recreation program and other specialty programs.

The ribbon cutting ceremony will take place in front of the new building at approximately 4:45pm. Parking is available at both H.T. Smith and Kreeger Elementary Schools. There will be food trucks available, complimentary cider and donuts, a book bus, special guests and commemorative t-shirts for sale. At the completion of the ceremony, guests will get to explore the new building by visiting staged classrooms and other areas of the building.

“On behalf of our students, staff and the entire district, I want to express our deepest gratitude to the voters for approving the bond proposal that has made our new elementary school a reality,” said Matthew Stuard, Superintendent. “Your support demonstrates a shared commitment to providing exceptional learning environments for our children, setting them up for a bright future. We invite everyone to join us in celebrating

this milestone at our ribbon-cutting event. Together, let’s mark the beginning of an exciting new chapter for our school community.”

Outdoor Halloween Decorations & Wildlife: Use Care Out There

With Halloween just around the corner, you're sure to see pumpkins, ghosts, cornstalks and more adorning homes and businesses in your neighborhood. If you're planning to join the fun, take a moment before purchasing supplies or decorating outside to consider if your display could attract or harm wildlife.

Rachel Lincoln, a wildlife outreach coordinator with the DNR Wildlife Division, said it can be as simple as being aware that pumpkins, gourds, potted plants and flowers may bring deer, squirrels, birds and other animals to your property, or avoiding the use of paint, bleach or other chemicals on pumpkins because those substances can be harmful to wildlife that eat the pumpkins.

Beyond that, it's about taking a few extra precautions.

"Be sure your decorations are clean and scent-free. Every October, we get reports of wildlife with Halloween candy buckets or decorations stuck on their heads or feet from trying to reach the sweets that were inside," Lincoln said. "It's easy to prevent this by cleaning up candy wrappers or spills around outdoor decorations and not placing food-related decor that might lure animals."

Here are other tips for wildlife-safe decorations:

- Be cautious with fake cobwebs and string lights. Placing these decorations over bushes or between trees can accidentally entangle bats and birds flying through.

- Position these items away from natural flight paths or wildlife habitats to reduce the risk.
- After the holiday, check decorations for any small critters that may have used them as shelter, such as birds, squirrels or insects, to ensure you don't accidentally trap or harm them.

When I returned home from the Army, I witnessed many of my fellow veterans and battle buddies struggling to find opportunities back here in Michigan. IV Solutions Shortage

Background of a major problem existing post Hurricane Helene

The major disruptions to the IV fluid supply after Hurricane Helene are the latest in a string of challenges, (example: baby formula shortage) that have exposed vulnerabilities to the broader US supply chain.

Baxter, an international company with its largest manufacturing facility and more than 2,500 employees in Marion, North Carolina, makes 60% of the nation's supply of IV fluids and peritoneal dialysis solutions, amounting to 1.5 million bags daily, according to the American Hospital Association. The site is the largest manufacturer of these solutions in the United States. Baxter's N. Carolina's site was affected by flooding by Hurricane Helene last month and is currently closed for production. A shortage of IV fluids, which provide nutrients to the body or replenish fluids lost due to injury or illness, has forced hospitals to curtail elective procedures.

The medical device maker also received the U.S. Food and Drug Administration's clearance on Oct. 9 to temporarily import products from five of its facilities in Canada, China, Ireland, and the UK, and was working to secure authorization for more sites amid a nationwide shortage.

We do not yet have a timeline for when we expect production to be fully restored to pre-hurricane levels! In the meantime, extending expiration dates is under consideration.

Debris as a result of destruction

I have a mind that wanders. If an award were to be given to the world’s best daydreamer, I truly believe I’d be a top contender. I’m a person who asks a lot of questions such as “what if...” and “I wonder what it was like when...”

A good example comes from our visit to the Grand Canyon back in 2022. We took the time to watch a film about the discovery of the canyon and its history with different people groups and explorers who navigated the challenges offered by the conditions of the rocks, Colorado River, etc. When we toured the canyon and stood on one of the ridges, my mind wandered to imagining the “first” person to encounter this vast wonder in our nation. According to one search I did, Milton left behind millions of tons of carnage. Clean-up will take months, stretching into years most likely. Where does all that debris get moved/dumped?

This past week I decided to begin reading my Bible in chronological order, realizing that by doing so I will gain a new understanding of history from a biblical point of view. The plan began in Genesis and ended my time in that book when Noah’s flood happened, gave me a genealogy lesson in who his sons were and the sons they fathered, ending with the introduction of Abram and his wife Sarai. Home Economics makes a comeback in Webberville after 30-year hiatus

After more than three decades, home economics has returned to Webberville Community Schools, becoming very popular under the guidance of Alex Harris. A native of Howell, Alex is a graduate of Howell High School. She earned her associate degree in education from Washtenaw Community College before transferring to Eastern Michigan University, where she obtained her bachelor’s degree in Elementary Education and Emotional Impairment.

Now living in Webberville with daughters Elizabeth, Emily, and Brooke, Alex is excited to be part of a community that has educated four generations of her family. This marks her second year teaching in Webberville Community Schools, where her enthusiasm for education shines. Always busy outside of school, she also loves being outdoors, scrapbooking and spending quality time with her family.

“I’m so excited to be teaching home economics this year. We have so much fun and the students really look forward to being in the class,” Alex explained. “Parents are very supportive and are so happy the class is back in Webberville. The upperclassmen are always asking me if they can join.”

The home economics class is offered as a year-long elective for middle school students, and it is already bustling with engaging projects. Currently, students are working on a 7-day meal planning project, where they must create balanced menus for breakfast, lunch, and dinner. Trump's economic claims not supported by facts

Donald Trump claims that tariffs will raise so much revenue that it will make funding such programs as childcare insignificantly small. Nothing could be farther from the truth. Trump's economic claims are always false or misleading, and intended to deceive, which is fraud; no surprise, coming from a felon, convicted on 34 counts of fraud. There is literally nothing that comes from the mouth of Donald J. Trump that is true and reliable.

Tariffs are targeted sales taxes on certain imported goods. The purpose of tariffs is to increase the relative cost of imported goods, to discourage their purchase by consumers, in favor of lesser expensive domestically produced options.

Consumers in the country of import pay the tariff on a given product, not the country of export. If a tariff is working to its purpose, sales of a given imported product will be lower, very little tariff paid, and therefore, very little revenue raised. Tariffs that are too high could be an opportunity for domestic producers to artificially inflate prices to a level just below the cost of the imported option. Conversely, tariffs can also hurt domestic producers, if an imported good is necessary to produce the American-made product, or if other countries impose counter-tariffs on American exports. In any case, if tariffs are generating significant revenues for the federal government, it is American consumers who are paying the cost; another tax increase on the middle class, to benefit the rich.

Trump claims that he created the best economy in American history during his one term in office, but the facts disagree. Trump inherited a healthy economy from Obama's two terms, which after the economic crash of the Bush era, featured 75 consecutive months of job growth, all of which were lost during Trump's term, and re-created above and beyond the previous mark during the Harris/Biden term of office. It is the Kamala Harris economy that has featured record low unemployment and job growth.

Annual economic growth during Trump's term was about 2.5%, similar to the recovery period of Obama's second term. Trump's term saw one quarter of 3% economic growth (2nd quarter, 2019), the same quarter that he implemented the first round of tariffs, as American producers rushed to get their products to market, before other countries-imposed counter-tariffs. Growth fell off in the 3rd and 4th quarters of 2019, to 1.9 and 2.1 percent respectively. Covid hit in the 1st quarter 2020, and Trump's mismanagement of the pandemic caused a 31 percent contraction of the economy—the largest collapse since the Great Depression.

Contrast Trump's economy, having only one quarter of 3.1 percent growth, with Kamala Harris's term, which has seen sustained 3+ percent average annual growth for the past 22

months. The Kamala Harris Economy is now the largest and fastest growing economy in the history of the world.

Trump also boasts the best stock market growth ever. Sorry, not true. The Dow tripled during Obama's two terms, from a low of 6542 (March 9, 2009), to 19,799 on his last day in office (January 19, 2017), a 13,257-point gain, 200 percent increase.

When the Dow hit 30,000, Trump declared that to be a "sacred number," a sum total of 10,201-point growth during his term. The market hit that 30,000-point high on Tuesday November 24, 2020, exactly three weeks after Trump lost the 2020 election, and the very day that all of the States certified their popular vote totals. During Kamala Harris's term, the Dow has surpassed and is sustaining levels over 43,000 which is a greater point gain, and a more sacred number than Trump's 30,000.

Market inflation is essentially too many dollars in demand for an under-supply of goods. Inflation was near zero during Trump's term, because there was so much job loss because of his mishandling of Covid that nobody had any money to buy anything.

Kamala Harris restored job growth, which put more money in the pockets of consumers, but due to the out-sourcing of manufacturing jobs to China and other Asian countries since the Reagan era, we had few domestic product options in America, while China and Asia were devastated by Covid,

Letter to the Editor

I'm writing to absentee voters, and I want you to know that absentee voting, or voting by mail, is not only easy, but also safe. I would not use the postal system at this point in time. It is recommended mailing it at least two weeks before the election to be sure the post office gets it there on time.

Clerks' offices and election workers are made up of Democrats AND Republicans. I am an election inspector and generally I work in the location where people vote in person, there are usually an even number of both parties present, in fact I don't recall there ever not being an equal number of both.

After all the ballots have been tabulated by the voters, before we close and put away all the equipment, we get together and count all of the ballots at our precinct. Then we compare it to the tabulator. If the count is not correct, we start over. We check each other's count and make sure it is correct, then we sign off on the tabulator count receipt. Everyone must sign every machine receipt. Certifying that things have been done correctly.

Everything is locked in special bags. Separate locked bags, envelopes, and election book for the Clerk, the County, and the State. I have been doing this for five years, now. During that time, I have worked closely with those Head Election Inspectors who go back to the Clerk's office to turn everything in, daily now, during early voting. There is ALWAYS one person from each party who goes together to do this.

At the Clerk's office there are people tasked with receiving everything from the precincts. Accounting for all the locked bags, envelopes, and election books. They make sure all the counts are correct and accurate, and that all receipts have been signed. They ensure that nothing is missing.

There is another contingent of people to assist with the ballots that have been mailed in, dropped at the Clerk's offices, or dropped into the Drop Boxes. In Michigan, cities and townships with a population of 5,000 residents or more may establish an Absentee Voter Counting Board (AVCB) to process and tabulate absentee ballots during any of the eight days before an election between the hours of 7 a.m. and 8 p.m. Cities and townships, regardless of population, can establish an AVCB to process and tabulate absentee ballots on the Monday before an election between the hours of 7 a.m. and 8 p.m.

The return envelope is processed by checking the signature. Then the envelope is opened and the secrecy envelope is removed with the ballot still inside. Before the ballot is removed from the secrecy envelope the portion of the ballot at the top with the ballot number is removed. The ballot is properly removed from its inner secrecy envelope, each ballot is folded to make it flat. The ballots are then sent through the tabulation machine. Once every ballot has been tabulated, they are then counted by hand by members present and correlated to the tabulator's end count. All receipts are signed by those present. Again, everything is placed in locked bags, envelopes, and election book.

The City, Township, Village Clerks each sort everything out. They keep their own records. Everything that needs to go to the County/State is taken to the County Clerk's Office for processing. I could speculate that it is all repeated, but that is all it would be, speculation. My knowledge ends there.

In summary, the amendment ordinance provides for: a) the establishment of the Large Solar Energy System Overlay District (LSESOD) under Section 3.1; b) revisions to Section 3.7 to address certain requirements regarding the LSESOD; c) revisions to Table 3-1 of Article 3 to present the stated purposes and planned boundaries of the LSESOD, being approximately the south 80 acres of the southeast 1/4 of Sec. 24, the north 1/2 of Sec. 25 excluding the west 80 acres, the west 80 acres of the southwest 1/4 of Sec. 25, the portion of the southeast 1/4 of Sec. 26 located east of the westerly north-south drain crossing the southeast 1/4, the portion of the east 1/2 of Sec. 35 located east of the westerly north-south drain crossing the east 1/2, the west 1/2 of the southeast 1/4 of Sec. 36, the west 1/2 of the northwest 1/4 of Sec. 36, and the entire southwest 1/4 of Sec. 36; d) revisions to Table 3-2 of Article 3 and Footnote 3 of such Table to permit only Large Solar Energy Systems (Large SES) in the AR District as a principal use and only after an LSESOD rezoning of the subject property is approved; and e) revisions to Section 13.19 regarding application requirements, review procedures, and site development requirements and standards for solar energy systems.

Judy Christie and Sallie Brodie shared their experiences in traveling through Alaska to the enjoyment of everyone.

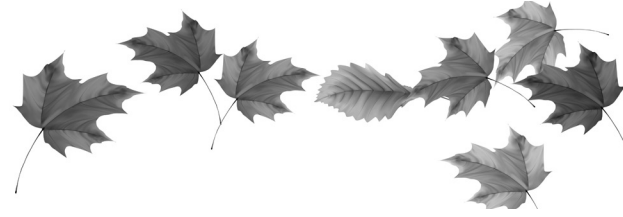
The next meeting is Nov. 18 at 1:30. Members will bring mittens, hats, and scarfs for donating to the Webberville Food Bank.

This photo and the following description of Lance Corporal Michael W. Hanks and his combat service is now part of the Michigan Military and Veterans Hall of Honor at the Michigan History Museum in Lansing. The description states that:

“Lance Corporal Michael W. Hanks served in the U.S. Marine Corps with honor and valor. Enlisting in 2003, Hanks was deployed to Iraq as part of Operation Iraqi Freedom, where he served as Fire Team Leader with 1st Platoon, Lima Company, 3rd Battalion, 1st Marine Regiment. From November 8-17, 2004, LCpl Hanks displayed extraordinary bravery during intense combat in Anbar Province. He repeatedly placed himself in harm’s way to save fellow Marines, eliminate enemy insurgents, and press the attack. His selfless actions on multiple occasions, including rescuing a wounded Marine and eliminating several enemy combatants, earned him the Silver Star Medal. On November 17, 2004, Hanks was mortally wounded during an assault on a fortified enemy position. In recognition of his gallantry, LCpl Hanks was posthumously awarded the Silver Star, along with the Purple Heart and several other military honors. He is buried at Greenwood Cemetery in Fowlerville, Michigan, and his legacy of courage and sacrifice endures.”

Fowlerville Marine inducted posthumously into Michigan Military & Veterans Hall of Honor

Nearly 20 years after being killed during combat, Lance Corporal Michael Wayne Hanks was posthumously inducted into the Michigan Military and Veterans Hall of Honor. A native of Fowlerville, the 22-year-old Hanks was serving with the U.S. Marine Corps in Iraq when he gave the ultimate sacrifice during the Second Battle of Fallujah. The induction ceremony, which included other honorees, took place this past Friday, Oct. 25th, at the Michigan History Museum in Lansing.

This prestigious recognition was accepted on his behalf by his father, Mike Hanks, alongside his niece, PFC Makiah Gladstone, who proudly serves in the Michigan National Guard.

Lance Corporal Hanks, a recipient of the Silver Star for his extraordinary acts of bravery, was honored for his remarkable courage and sacrifice. His actions during one of the most intense battles in U.S. Marine Corps history have left a lasting impact on those who knew him and those who have learned his story. He died on Nov. 17th.

His induction into the Hall of Honor cements his legacy not only within the Marine Corps community but also here in his hometown of Fowlerville.

In a statement, Michael’s sister, Melissa Ketchel, shared that “Makiah and I were proud to nominate Michael for this honor. His bravery continues to inspire all of us, and this induction ensures that his name, his story, and his legacy will be remembered forever. As a family, we are filled with pride, and we are committed to keeping his memory alive.”

Michael’s legacy also lives on through the Michael Wayne Hanks Legacy Foundation, which was established by his family to support military veterans and Gold Star families. The Foundation works to ensure that the sacrifices of fallen service members are not forgotten and that support is provided to those who continue to serve.
