Dawn Patrol being held next Sunday at Maple Grove Airport

The 73rd Annual Dawn Patrol will be held next Sunday, Sept. 8, at the Maple Grove Airport. The airport is located at the corner of Sherwood and Robb Roads, north of town. Take Fowlerville Road north four miles to Sherwood Road and then turn east and drive one mile to the airport.

Dawn Patrol normally draws hundreds of people who come out to visit with family and friends, eat breakfast, look at the planes, and enjoy the other attractions and activities. Weather

permitting, several dozen pilots and their passengers will fly in for the event, coming from all over Lower Michigan.

The 'all you can eat' breakfast is served rain or shine from 7 to 11 a.m. The menu includes eggs, bacon, biscuits and gravy, pancakes, donuts, and milk, orange juice, and coffee. Cost is \$10 per person with children five to 12 years charged \$8 and children four and under are served free.

There will be drawings taking place throughout Dawn Patrol with great prizes donated by area merchants being given away. Vendors are also welcome to participate.

If the skies are clear, the Capital City Sky Divers will join the activities with a parachute jump.

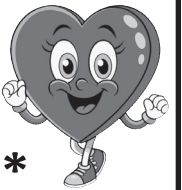

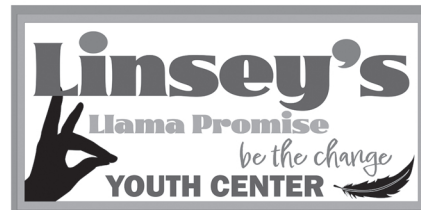

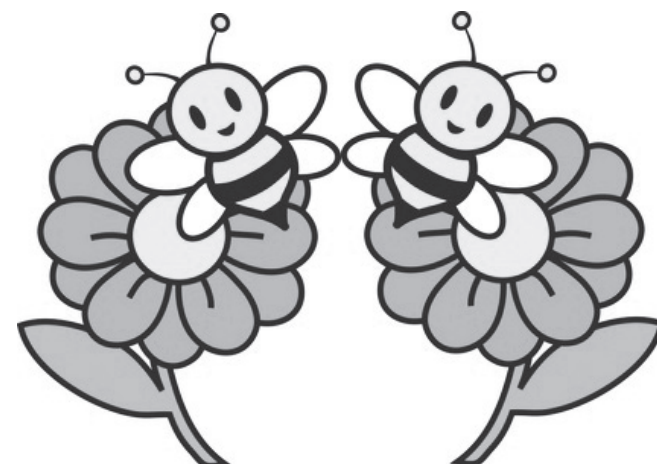

Combating Elder Abuse

Elder abuse is the intentional mistreatment or harming of an adult over age 60. This abuse can take many forms – physical, emotional, sexual, and financial exploitation, as well as neglect. In the United States, an estimated 1 in 10 adults over the age of 60 experience some form of abuse each year. That number is likely much higher because elder abuse is often underreported– especially in underserved communities.

Abuse victims typically show emotional and behavioral red flags, such as depression, unusual fear or anxiety, or intentional isolation. Many victims are abused by someone they know or trust. It's important to look for unusual changes in behavior around:

- Family members.
- Staff at inpatient facilities.

- Hired or volunteer caregivers.
- People in positions of trust like doctors or financial advisors.

You can help make a difference by checking in with older loved ones. The first step to preventing abuse is to look for signs of mistreatment or physical harm, including bruises, burns, and other unexplained injuries.

There may also be signs of neglect such as:

- Hunger and poor nutrition.
- Poor appearance or hygiene.
- Lack of necessary medical aids like glasses or medications that a caretaker should be providing.

There may also be indications of financial abuse, including:

- Unpaid rent or other bills.
- Sudden changes to a will.
- Unusual changes in money management or habits.
- Large, unexplained financial transactions.
- Allowing someone new to access bank accounts.

If you suspect that a person is a victim of elder abuse, please report it. If you or someone you care about is in a life-threatening situation, call 911. If you suspect possible abuse – but see no immediate danger – contact:

- Your local Adult Protective Services at www.napsa-now.org/help-in-your-area.
- The National Center on Elder Abuse at 1-855-500-3537 (ELDR).

You can also find additional local resources by searching the Eldercare Locator for your community at eldercare.acl.gov/Public/index.aspx.

Take some time to call or visit an older adult. Ask if they are OK and listen to what they tell you. Pay attention to signs of abuse or unusual behavior. Most of all, don't be afraid to report suspected abuse. For more information about elder abuse visit

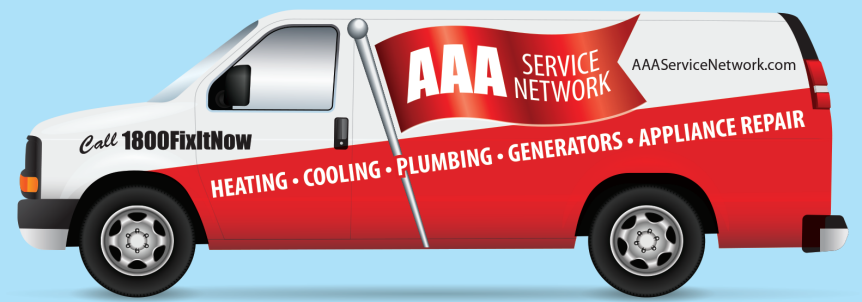

Experiencing Hawaii by Cruise Ship Part II

It was in the fall of 2014 when my twin sister Kathy and I decided to visit the Hawaiian Islands by going on a cruise ship instead of island hopping by plane. As I wrote in Part I, I flew into Los Angeles, stayed a few days at her place in Southern California, and then the two of us flew to Honolulu.

After arriving at the airport, we proceeded where our ship 'Pride of America' was docked and went aboard. The next morning we made the first of our stops. (See the map for where the ship goes.)

Part I told of our stops at the Maui Tropical Plantation, the Iao Needle in Iao Valley State Park, Maui Beach, neat places where we dined, and a Broadway show we saw aboard ship.

Here are highlights about the rest of our trip.

Historic Kona

The ship anchored in Kailua Bay and we took the tender boats to the Kailua Pier. This is right in the middle of Kailua Village and the historic heart of Kailua-Kona. We took the Polynesian bus with driver Cowboy Sal. He gave us a narrated tour of Kona and took us to the Royal Kona Coffee Center.

There are about 650 farms cultivating coffee in the Kona district. The typical size of a Kona coffee farm is three acres. Kona coffee represents approximately 95% of the coffee on the island. The unique composition of the volcanic soil contributes to its special taste. McDonalds in Hawaii uses Royal Kona. We tasted many samples of coffee and learned how it is processed.

Across the pier from Kamakahonu Bay, a small corner of sand sits at the end of the seawall and leads into Kailua Bay. Protected by the pier, it is a good small swimming beach. This location is also the start of the swimming course for the Ironman Triathlon.

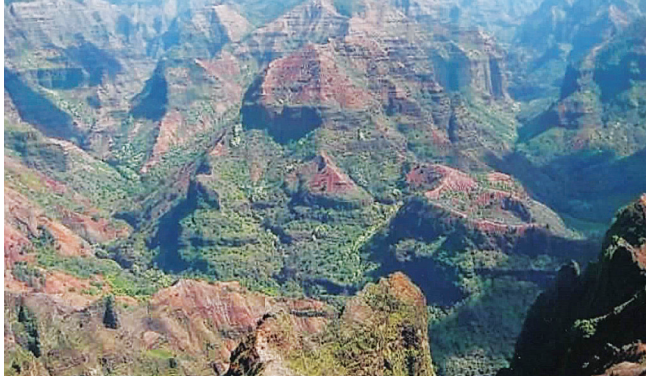
We stopped at the Saint Benedict's Painted Church overlooking beautiful historic Kealahou Bay in the famous Kona coffee growing region. It is a vibrant parish with outreach programs to take care of those in need and provide medical services. It was built around 1899 under the direction of the Belgian Catholic missionary Father John Velghe, who painted frescoes along interior walls and ceilings to bring life to the Holy Scripture.

The next stop was Pu'uhonua o Honaunau National Park. This served as a place of refuge for the defeated warriors as well as civilians during the time of battle in earlier times. No physical harm could come to those who reached the boundaries of the Pu'uhonua or Great Wall.

Back to the ship and dinner at the Classic Diner. We saw a magic show with Matt Marcy at the Hollywood Theatre. He had a lot of tricks up his sleeve, plus 'Oh What a Night'—a Frankie Valli & the Four Seasons Musical Tribute. It was a great show!

Kauai

We took a bus trip to see Waimea Canyon also known as the Grand Canyon of the Pacific. It is a large canyon, 10 miles long and up to 3,000 feet deep, located on the western side of Kauai in the Hawaiian Islands.

Waimea means "reddish water," a reference to the erosion of the canyon's red soil. It is so colorful with the reds and browns of its volcanic rock, along with the greens and blues weaved with tropical vegetation, and breathtaking to see!

We then rode to Mariko gift shop for souvenirs, magnets and jewelry. There is a Waimea waterfall and on top of the hill was Warrior Man. He did a dance and the gals just loved him! We gave him a \$20 tip and got a picture with him.

The bus stopped at Keoki's Paradise Restaurant and Bar. There we met a couple from Columbus, Ohio. We had pork, poi (a pudding-like paste made from the root of a taro plant), Mahi Mahi fish, rice, salad and fresh pineapple.

Our next stop, Spouting Horn Beach Park, is a delightful lookout where you can watch a blowhole spout a plume of sea water into the air. The waterspout occurs whenever waves are forced under the lava shelf and up through an opening. Depending on the tide and ocean conditions, the water may go 50 feet into the air. Also, if the light is right, you may be able to catch sight of a rainbow in the sea spray.

Luau Kalamaku was exciting with fire dancers, hula and Tahitian dancers. We loved the dancing as we were in our glory to see all the cultures, food and songs of the islands.

The time finally came to check out of the ship on Deck 5 and get to the Honolulu airport. We said our goodbyes to all our friends we had met. The bus was ready to take us back to Hawaiian airlines.

It was a smooth flight over the Pacific Ocean into Los Angeles.

The Norwegian cruise line (which 'Pride of America' is part of) operates year round, taking visitors to these special and interesting places located in the Hawaiian Islands. It was a trip of a lifetime!

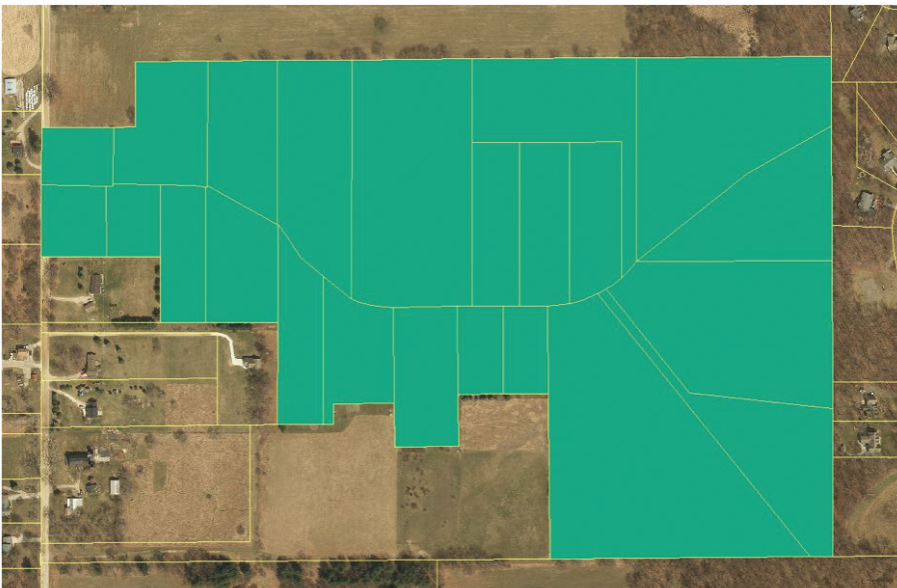

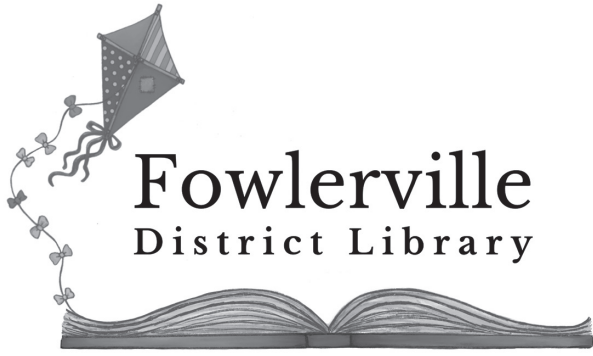

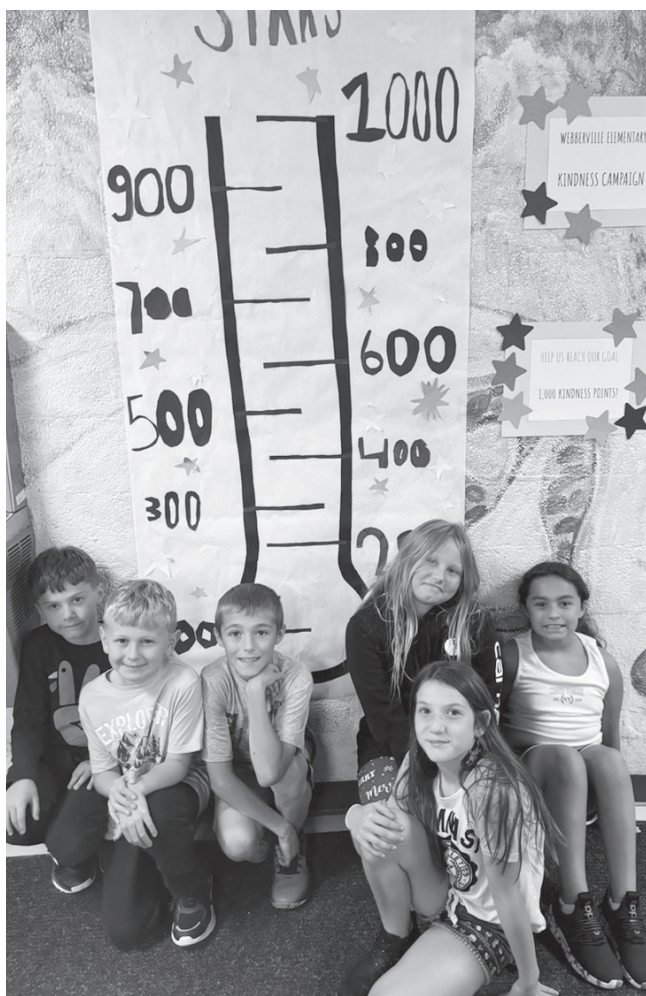

Michigan DNR Fishing Tips—

Glow lures are popular with Great Lakes salmon

Salmon fishing on the Great Lakes is really hitting its stride, as many species are getting ready to begin their upstream migration. At the moment, Lake Michigan is particularly popular for Chinook salmon, with anglers trying various techniques to land this prized sportfish.

One tactic that can be particularly useful when targeting Chinook salmon is fishing with glow lures. This species can often be caught near the surface in low-light conditions, and glow lures make that opportunity even more appealing.

In particular, glow lures work well in the early morning hours before the sun comes up or at night. Many believe this type of lure attracts salmon because it can be seen in the dark from longer distances and encourages them to strike.

Livingston County activist chosen as Presidential elector

A longtime political activist from Livingston County has been selected as the Presidential elector for the 7th Congressional District.

Kathy Carney was elected Saturday at the 7th District Caucus at the Michigan Democratic Party nominating convention in Lansing.

She will gather with Michigan's 15 other Democratic presidential electors on Dec. 17 at 2 p.m. to cast the state's votes in the electoral college should Vice President Harris and Gov. Tim Walz carry Michigan in the Nov. 5 election.

Carney, who lives in Green Oak Township, chaired the 8th Congressional District Democratic Party for more than four years.

In addition, she worked alongside her husband, Joe, when he was chair of the Livingston County Democratic Party for many years.

She served as a member of the Michigan Board of Osteopathic Medicine representing the public and has been inducted into the Brighton Area Women's History Roll of Honor.

Carney became active politically in the 1980s after a group of women became concerned that area wells had been contaminated with road salt. The Fonda Island and Briggs Lake Water Authority sued over the matter and the courts found the Michigan Department of Transportation was responsible for the contamination.

The last Livingston County resident to serve as a presidential elector for the Democratic Party was JoAnn Murphy of Green Oak Township who cast the then-8th Congressional District's vote for President Obama in 2012.

Labor Day is a federal holiday in the United States celebrating the achievements of American workers. It is observed annually on the first Monday in September with parades, parties and sports activities. For young Americans, it signifies the end of summer.

During the late 19th century, while America was at the peak of the Industrial Revolution, American workers had 12-hour shifts per day for seven straight days to make a living to survive on.

Factories and mines were at the height of demand and accepted workers of all ages. Despite prohibitions, some states practiced child labor as young as 6 years old. Workers were exposed to unsafe environments with bare hands and little to protect them.

The American Industrial Revolution dramatically increased the manufactur-

ing industry, replacing the agricultural sector. As a result, labor unions were established and easily spread. Labor unions started organizing rallies, strikes and protests about reforms on working hours, pay and safety.

On February 21, 1881, Oregon was the first to pass a law making Labor Day a holiday. That same year, Colorado, Massachusetts, New Jersey, Connecticut, Nebraska and New York followed.

On September 5, 1882, almost 10,000 workers marched their way to the Union Square in New York City marking the first Labor Day parade in U.S. history.

By the end of 1894, 23 states passed the Labor Day holiday law.

In order to further pacify workers, Congress passed an act making Labor Day a legal holiday in the District of Columbia.

Lessons in Work

Raise your hand if you've ever woken up on a Monday morning and mumbled "Argh, I have to go to work today!" I know that those words were part of my mantra far too often during my years of working outside our home. Our culture has slowly groomed us into believing that "work" is something to behold as drudgery and to be despised. What if I told you that this attitude doesn't have to live rent free in our minds? What if I told you that God designed "work" to be something to embrace with gratitude?

This week I began a personal study of "The Sabbath" under the teaching of some favorite guys from "Walking the Text", a ministry out of Nashville. These teachers really dig into Biblical texts, often bringing out definitions of specific Hebrew and Greek words to better understand scripture, as well as giving insight to historical and cultural events related to specific writings in all 66 books of the Bible. Here are some bullet points I made from the first teaching:

- Adam "worked" and cared for the Garden of Eden
- Labor has dignity; it's divine and came "before" the fall (original sin)
- Labor IS painful toil; work/labor is broken
- My work, your work, is a form of worship; the Hebrew word for "work" used in Genesis is "avad" which means to serve, work, worship

"Whatever you do, work at it with all your heart, as working for the Lord, not for human masters, since you know that you will receive an inheritance from the Lord as a reward. It is the Lord Christ you are serving". (Colossians 3:23-24)

"For we are his workmanship, created in Christ Jesus for good works, which God prepared beforehand, that we should walk in them". (Ephesians 2:10)

I cannot read these two verses and not recall some great examples/lessons I learned from observing how others regarded their "work". My first recollection is of my brother Mark who had been let go from a welding position. In order to help support their young family, he took a job pumping gas at a local station. One day a fellow he knew pulled in to have his tank filled and he was shocked to see Mark waiting on him. He questioned Mark "why are you working here?!", with quite an astonished and condescending tone when someone knows your work experience. He told him of his current circumstances, and it turned out this guy knew a company looking to hire full time welders. That brief encounter wouldn't have happened in my opinion if Mark had considered pumping gas "beneath" his dignity. Additionally, my brother eventually returned to Central Michigan University to complete his teaching degree and taught welding and robotics at Mid Michigan Community College until he retired.

When pregnant with our first child, I needed to be hospitalized for a week. During my brief stay I saw two different women come into my room to clean. One was a young woman who swept the floor as though the mop weighed a ton. The other was an older woman who hummed while she cleaned every part of the floor and bathroom as though the Queen of England was coming to visit. I joked with her saying "I bet you don't feel like doing your own housework after cleaning rooms here all day". To the contrary, I can still see her beautiful bright smile when she replied "Oh, no. I love to clean! I love to stand back when I'm finished and say 'my, my, my, doesn't that look pretty!'"

Bottom line is, our adversary Satan wants Christians to believe that work is grinding and yes, it is and can be for some, depending on the intensity of the job.

I would never apply to be a lineman working in seasonal weather challenges, but I'm grateful for the men and women who do every day. Mike Rowe made his series "Dirty Jobs" quite interesting while showing me numerous jobs I'd never set my eyes on!

Office jobs. Farm jobs. Retail jobs. Maintenance jobs. Garbage jobs. Engineer jobs. Teacher jobs. ALL jobs are important and when a right attitude is IN the work, God honors our efforts and even sees it as "worship".

How do you view your work? I challenge you to pause on your next Monday morning and IF you've fallen prey to seeing going to work as "daily grind", switch gears and thank God for the very work He has assigned you to do. I'm willing to bet you might even begin humming while you work....

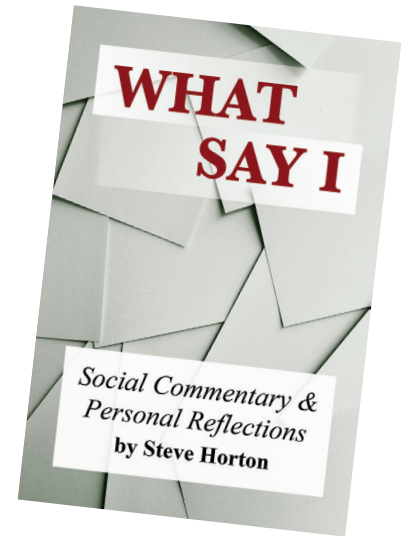
This collection offers 60 articles and a foreword, with most of the pieces written during the past 10 years (2015-2024).

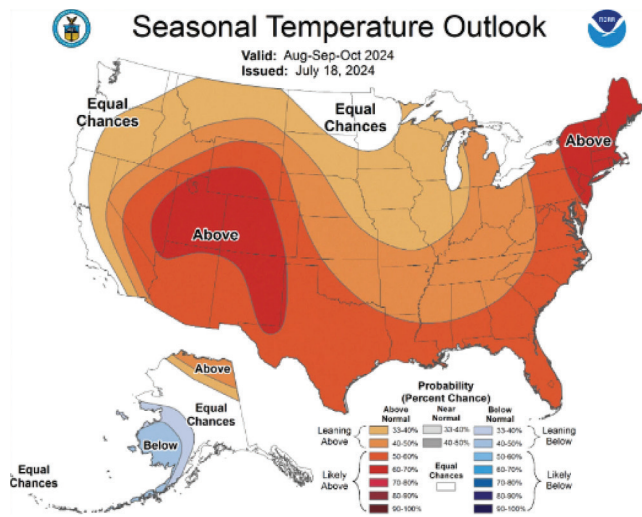

National Weather Service: Warmer-than-normal fall likely in Michigan

Early fall temperatures in Michigan will likely be higher than average, according to the National Weather Service, but are predicted to return to normal for the winter if long-term predictions hold up.

Cort Scholten, a meteorologist with the National Weather Service in Grand Rapids, said precipitation amounts are expected to be near normal for the next two months.

“Right now, this outlook is saying that the odds are favoring

overall we’ll see more warmer-than-usual days than we will colder than usual days,” he said.

Scholten said temperatures are expected to return to near-average in November through December, but with higher-than-average precipitation expected, which could be in the form of either rain or snow.

“We’ll still have plenty of temperature swings during the winter,” he said. “Warm days, cold days, week-long cold snaps, week-long times when we’ll melt the snow.”

Scholten cautions that uncertainties increase the farther out the models go, and that predictions for the winter could change in coming months.

Last winter was influenced by a strong El Nino, which often brings warmer winters to the U.S., Scholten said, but currently neither El Nino nor La Nina are influencing the country’s weather significantly. Climate models are leaning towards a La Nina potentially forming this winter, but those predictions are still uncertain.

Scholten said warmer temperatures have occurred more often in the last couple of decades than in the past. That trend is particularly evident during the winters and for nighttime low temperatures, which have not been getting as cold as before. High temperatures have also been increasing, but not by quite as much.

“It does take more of an unusual atmospheric setup to deliver us the same amount of cold temperatures as it did in the past,” he said. “We still get cold snaps – sometimes they can get very, very cold in our region.”

He said those cold snaps are balanced out in other parts of the world by significantly warmer temperatures for a general overall warming trend.

Scholten said he expects weather this fall to follow the pattern of day-to-day changes common for Michigan, including its share of severe thunderstorms and maybe a

heatwave or two.

“All these things are on the table for Michigan in the fall, as they are most years,” he said. “Weather in Michigan is always exciting no matter what happens.”
