'Music at the Park' begins this Tuesday with Fowlerville High Jazz Band

'Music at the Park' begins its schedule of outdoor shows this Tuesday, May 23, with a performance by the Fowlerville High School Jazz Band starting at 7 p.m. at the Centennial Park Gazebo (next to the old fire station).

The band is led by William Vlieg, the high school band director, and the ensemble will be playing an assortment of jazz standards and contemporary pieces.

This year's 'Music at the Park' will feature a June Series at the Centennial Park and a Summer Series at the Fowlerville Community Park Glover Amphitheater. All of the concerts are scheduled on Tuesday evenings, with several having rain dates

later in the week.

Next up on the schedule will be Velocity Shift set for Tuesday, June 6. The three-member band plays classic rock from the '60s thru the '90s. One of the members is Mark Gastambide who was the music teacher at Smith Elementary for 30 years prior to retiring last year. He's looking forward to coming back and playing for the Fowlerville folks again. The show starts at 7 p.m. and there is a rain date of Thursday, June 8.

The rest of the June Series includes KingFish on June 13 (with a rain date of June 15), the Livingston County Concert Band on June 20, and Kari Holmes on June 27.

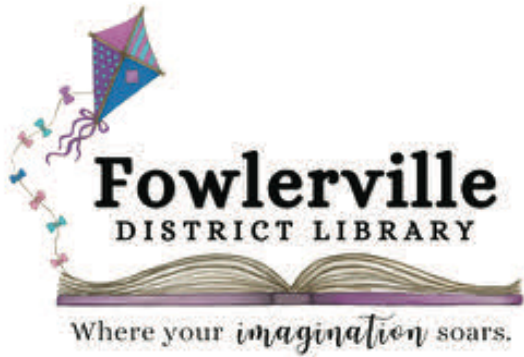

Preparing for Changing Communities

Communities throughout southeast Michigan are changing, and that is especially true for the small-to-medium sized municipalities of Livingston and the surrounding counties. Change brings new or re-energized issues to the forefront. These include population growth, housing costs,

aging infrastructure, adoption of technology, high speed internet access, and adequate municipal services.

I want to share a few brief thoughts on some of these trends.

The change we see most easily is that driven by internal factors, such as younger generations prioritizing different services than their parents or desiring a stronger community identity. Other challenges stem from external factors, such as national macroeconomic shifts toward a broadly services-based economy. Municipalities cannot stop these external effects, so the best they can do is shape policy in a way that is best for the people of their respective communities. In other words, change, good and bad, will continue to come whether we want it or not, so the question is how best to prepare for it.

Change usually means uncertainty, and that can be scary. But if we see an inevitable train coming down the tracks, the best thing we can do is to get ahead of it. We can close our eyes and hope the challenges go away, but we probably will not like the result when we open our eyes. The solution is to manage the change early rather than reacting as it overtakes us and limits our options. That means being smart about developing future-looking ordinances and a sound land use plan that sets the community up for success, not just now but also in twenty years.

On the point of investing in the future, a community must be willing to invest at a level commensurate with the benefits it wishes to receive. The logic seems intuitive, but the application is often missed. Some communities want more services and better infrastructure, so they collectively invest more in the city's or township's development. Conversely, other communities pay little into the system but are not ruffled by aging infrastructure and minimal services. Both options are fine.

One of the beauties of small, independent communities is the ability to tailor ordinances and services to the desires of respective constituencies. Still, we must remember that we cannot have it both ways. If we do not invest in our community's development, then we should not complain when something does not meet an expectation that exceeds the investment. (Although, it is important to address mismanaged investments! But that is another discussion for another day.)

When we do invest in updating and developing our communities, we must then be willing to accept the pain of progress. This is rarely easy. I think Michiganders have a special distaste for construction, so it is particularly frustrating when it invades our downtowns. Yes, development is painful in the moment, but if we never endure the pain, we will never reap the reward. We must rip the bandage off at some point, otherwise our beautiful communities will atrophy, as will the services and identity we expect.

Regardless of whether we find the coming changes exhilarating or concerning, I hope we all will continue to go the extra mile for our communities. When we talk about taking care of our communities, we are really talking about caring for each other. As we debate the best way to respond to the many changes before us, let us be unified in a willingness to inconvenience ourselves a little bit now to foster vibrant, thriving communities for the future.

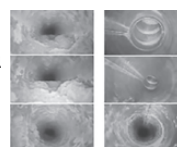

U.S. Congress Report

Introduces Bill to Expand Access to Counseling Services for Military Families

U.S. Rep. Elissa Slotkin (MI-07) has introduced bipartisan legislation to expand military families' access to mental health and counseling services. The *Comforting Our Families through On-base or Remote Treatment (COMFORT) Act* would allow military and family life counselors to work outside of the state in which they are licensed, expanding accessibility for services, the bill is co-led by Rep. Rob Wittman (VA-01).

"When our men and women in uniform sign up to serve, we make a promise to take care of them and their families," said Slotkin. "It's not easy being a service family – everything from frequent moves to long deployments can put plenty of stress on children and spouses. This legislation cuts red tape to expand options for counseling and mental health services, so our military families can get the support they need."

"Reliable access to mental health counseling services is necessary for our service members to stay healthy and carry out their duties in service to our nation. The mental health challenges our men and women in uniform and their families face are troubling, and it is incredibly important that we do everything we can to ensure they have the resources to stay safe. Our service members and their families make great sacrifices for our nation, and I'm proud to join my colleagues in this effort to provide them with the care they deserve," said Wittman.

"It is imperative that our servicemen and women receive the highest quality of mental healthcare available and, to do so, they must be able to have stable relationships with the care providers with minimal barriers to accessing care. We have long recognized that active service members have much greater risk of disruptions to their well-being because of the sacrifices they make to protect us all and the COMFORT Act provides one mechanism through which we can help them maintain their well-being and that of their immediate family members. I strongly support this groundbreaking yet common sense legislation and hope that in time all of our esteemed military personnel will have access to all of the support that they need," said Dr. Michelle Byrd, Licensed Psychologist, Professor Emeritus, Eastern Michigan University.

This announcement comes amid a shortage of counseling professionals nationwide and on military installations. Slotkin's legislation addresses the issue by authorizing license portability, which would expand access to care and enable the Department of Defense to provide counselors to areas where they are most needed.

Our mother, Dorothy Karpenske, was born in Amery, Wisconsin, along with her 15 brothers and sisters. Visiting her hometown and that branch of the family was a yearly vacation that we took most summers. When growing up, I remember that many of the family members residing there were employed at the Stella Cheese & Pea Factory, along with the feed mill in town.

Amery is a small rural town in the northwest part of the state, sixty miles from Minneapolis, Minnesota. It is located in Polk County, along the Apple River. It's called 'City of Lakes' due to its proximity to North and South Twin Lakes, Pike Lake, and the river. The city was named after William Amery, a carpenter who held several public offices in the 1870's. There is a downtown commercial area, plus an industrial area, and a current population of 2,925.

We always had relatives to visit with on their farms, and we'd sit around the table and drink coffee. There were donuts or cake to eat.

Our Aunt Rose would deliver eggs while our Aunt Edith had us collecting eggs on her chicken farm. We would stay at Bub and Clara's farm and Dad would help milk the cows and Clara would fry up chicken. Swann's ice cream would come out in big tubs. It must have been special ordered. We were never starving.

All of those relatives, including Mom, are gone and now those of us remaining have only the memories.

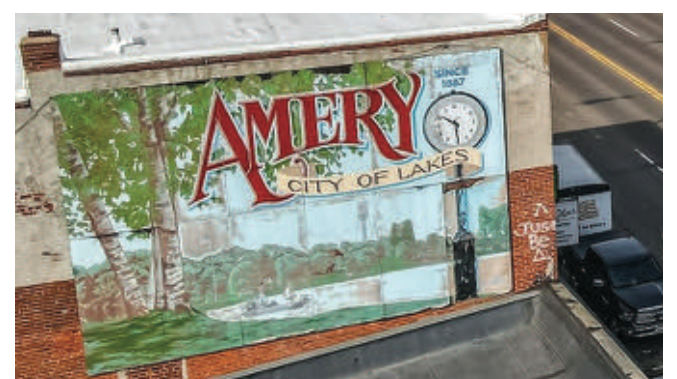

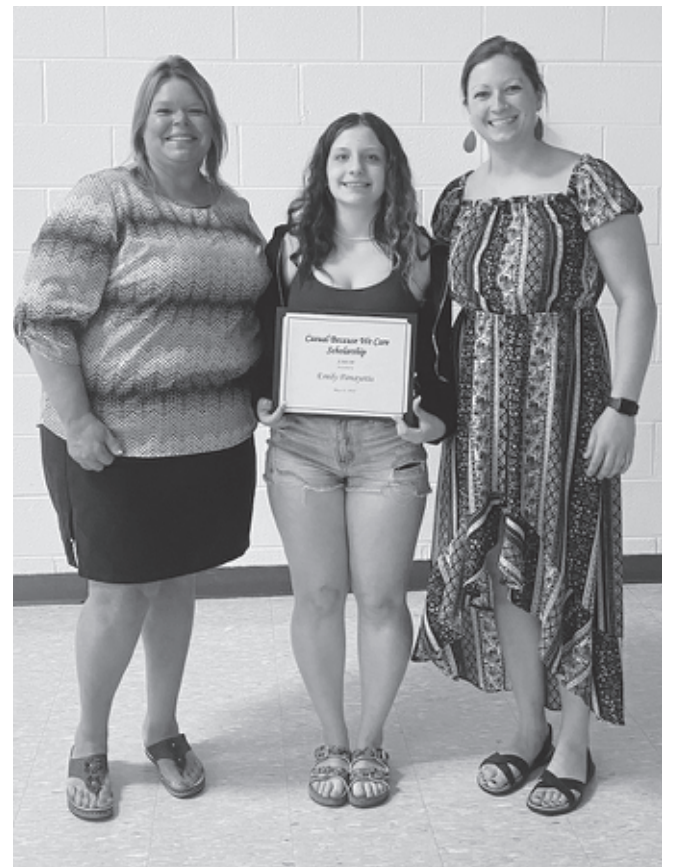

How Medicare Covers Physical Therapy Services

Dear Savvy Senior,

Does Medicare cover physical therapy, and if so, how much coverage do they provide? My 66-year-old husband was recently diagnosed with Parkinson's disease and will need ongoing physical therapy to help keep him moving.

Worried Wife

Dear Worried,

Yes, Medicare does indeed pay for physical therapy along with occupational and speech therapy too, if he needs it, as long as it's prescribed by his doctor. You'll also be happy to know that Medicare has no limits on how much it will pay for therapy services, but there is an annual coverage threshold you should be aware of. Here's what you should know.

Outpatient Therapy

To get Medicare Part B – which covers outpatient care – to help cover your husband's physical therapy, it must be considered medically necessary and will need to be ordered by his doctor. The same holds true for occupational and speech therapy.

He can get these services as an outpatient at a number of places like a doctor or therapist office; in a hospital outpatient department; at an outpatient rehabilitation facility; at skilled nursing facilities if he is being treated as an outpatient; and at home through a therapist connected with a home health agency when he is ineligible for Medicare's home health benefit.

For outpatient therapy, Medicare will pay 80 percent of the Medicare-approved amount after you meet your Part B deductible (\$226 in 2023). You will be responsible for the remaining 20 percent unless you have supplemental insurance.

But be aware that if his therapy costs reach \$2,230 in a calendar year (2023), Medicare will require his provider to confirm that his therapy is still medically necessary. Medicare used to set annual limits on what it would pay for outpatient therapeutic services, but the cap was eliminated a few years back.

You also need to know that treatment recommended by a physical therapy provider but not ordered by a doctor is not covered. In this situation, the therapist is required to give your husband a written notice, called an Advance Beneficiary Notice of Noncoverage or ABN, that Medicare may not pay for the service. If he chooses to proceed with the therapy, he is agreeing to pay in full.

Inpatient Therapy

If your husband happens to need physical therapy at an inpatient rehabilitation facility like at a skilled nursing facility or at your home after a hospitalization lasting at least three days, Medicare Part A – which provides hospital coverage – will pick up the tab.

To be eligible, his doctor will need to certify that he has a medical condition that requires rehabilitation, continued medical supervision, and coordinated care that comes from his doctors and therapists working together.

Whether you incur out-of-pocket costs such as deductibles and coinsurance, and how much they are, will depend on the setting for the treatment and how long it lasts. For more information on inpatient therapy out-of-pocket costs see Medicare.gov/coverage/inpatient-rehabilitation-care.

Medicare Advantage Coverage

If your husband is enrolled in a Medicare Advantage plan (like an HMO or PPO), these plans must cover everything that's included in original Medicare Part A and Part B coverage. However, some Advantage plans may require a person to use services from physical therapy practices within an agreed network. If he has an Advantage plan, you'll need to contact his specific plan before selecting a physical therapy provider to confirm they're within the network.

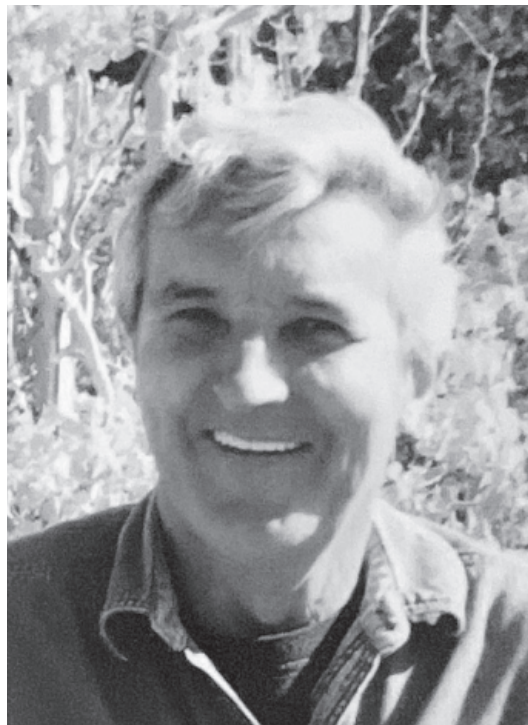

Michigan House Report

The House Criminal Justice Committee recently approved a bipartisan plan I am working on to restore arbitration rights for sheriff’s deputies who work as corrections officers in Michigan.

A labor strike involving public safety officials would pose a serious threat to community safety –which is why our state laws provide police officers and firefighters with the ability to quickly resolve their workplace concerns with mandatory arbitration after a grievance is filed.

At the time the law was passed in 1969, the phrase “public police or fire department employee” was assumed by the Legislature to include corrections officers who are employed by sheriff’s departments. In 1980, the Michigan Court of Appeals decided that sheriff’s deputies who work as corrections officers in county jails were not going to be included in the meaning of that phrase. Since that time, sheriff’s deputies who are assigned to work in county jails are not required to be given arbitration to resolve their workplace concerns.

I’ve been trying to get this changed because none of the sheriff’s deputies in Michigan should be reduced to a second-class status due to the division where they are assigned to work.

As sheriff, I was able to witness how our county corrections officers have become a specialized group of

individuals dealing with a multitude of criminal activity and technology that needs constant monitoring for the safety of everyone within the walls of our jails. Their jobs are absolutely critical.

I’m deeply concerned about another measure under consideration by the Criminal Justice Committee that would make Oxford High School shooter Ethan Crumbley and other dangerous murderers eligible for parole after serving just 10 years in prison.

I serve on this committee and continue to raise alarms about House Bills 4160-64, which would allow an individual sentenced to life in prison without eligibility for parole to be released on parole after serving 10 years if they were younger than 19 when they committed murder.

When an individual becomes eligible for parole under these bills, the parole board would be required to consider the individual’s age and immaturity at the time of the offense; the individual’s family and home environment at the time of the offense; and the circumstances surrounding the offense, including the influence of peer pressure.

Crumbley, who was 15 years old when he killed four of his fellow students at Oxford High School in 2021, could become eligible for parole when he is just 25 years old under this plan. Several other dangerous murderers who committed their crimes years ago would be eligible for parole immediately if this proposal became law.

I’m opposed to these bills and have been working hard to make sure the other members of the Criminal Justice Committee understand the horrific implications these bills could have on Michigan families, especially crime victims and their loved ones who will be forced to participate in the parole process to make sure their perpetrators remain behind bars.

Next week we celebrate Memorial Day and the lives of the selfless heroes who gave their lives for our freedom. As we kick off the summer season, please keep these safety tips in mind as you plan get-togethers and road trips with your loved ones:

- If you’re grilling, stay near the grill when it’s in use and make sure kids and pets keep their distance. Don’t overload the grill with food. Excessive fat and grease dripping on flames can ignite large flare-ups.
- Use your grill on a level surface at least 10 feet away from your house or garage, and make sure it’s not below overhanging eaves. Keep grills at least three feet from railings, fences, branches, hanging baskets, and backyard furniture.
- If you plan on drinking alcohol, designate a driver who isn’t going to drink.

Make sure you’re well-rested and alert before you hit the road. Use your seat belts, observe speed limits, and exercise caution in work zones.

Your personal my Social Security account is for every stage in your career

Your personal *my* Social Security account is here for you at every stage of your career. You don’t have to be retired or even close to retirement to take advantage of it. With an account, you can conduct much of your Social Security business online. For example, you can request a replacement Social Security card (in most states and the District of Columbia) whether you receive benefits or not.

If you are not currently receiving benefits, you can use your personal *my* Social Security account to:

- Review your earnings history.
- Estimate your future benefits to help plan for retirement.
- Get instant proof that you do not receive benefits.
- Check the status of your Social Security application, if you decide to apply for benefits.

If you already receive Social Security benefits, use your account to:

- Change your address.
- Get instant proof that you receive benefits.
- Set up or change your direct deposit.
- Get an instant copy of your Social Security 1099 (SSA-1099) or SSA-1042S.
- Opt out of receiving certain notices by mail and instead receive them in the secure Message Center.

Michigan Governor’s Report

As governor, one of my top priorities is ensuring that every Michigander has access to quality, affordable health insurance. During the federal COVID-19 Public Health Emergency (PHE), extra benefits were provided, such as food assistance and Medicaid. As the PHE comes to an end and the redetermination process plays out, we are building on efforts by the Michigan Department of Health and Human Services (MDHHS) and the Department of Insurance and Financial Services (DIFS) to help families stay covered and save money.

Earlier this month, I issued an executive directive that instructs all state departments to cooperate with and assist MDHHS and DIFS, including working together to distribute information to Michiganders about the redetermination process and how to renew eligibility.

To help Michiganders through this process, the State has:

- Communicated with impacted Michiganders by mail, text message, and targeted advertising campaigns.
- Launched two new websites by MDHHS and DIFS to provide information to consumers about redetermination and alternative health insurance options.
- Added staff to the MI Bridges Help Desk and Customer Service lines to help Michiganders navigate the transition.
- Reached out to employers to help ensure that individuals are informed about their employer-based health insurance options, including the existence of a special enrollment period for those affected by redetermination.

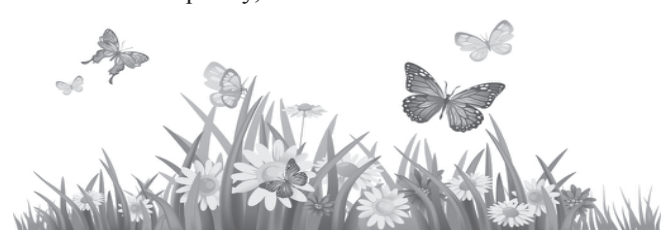
Nationwide, Medicaid beneficiaries will have to renew their coverage to comply with federal legislation. This means that thousands of Michiganders may transition away from Medicaid. In Michigan, annual renewals will begin again in June 2023 and will continue through May 2024. During this time, MDHHS will review the Medicaid eligibility of more than 3.1 million Michiganders, and those who are no longer eligible for benefits must take action to maintain healthcare coverage to protect themselves and their families.

If you receive Medicaid, you should take the following steps to prepare for redetermination:

- Make sure your address, phone number and email address are up to date at www.michigan.gov/MIBridges. You can also call your local MDHHS office. If you do not have an online account for MI Bridges to access your Medicaid case or report changes, visit www.michigan.gov/MIBridges to sign up for an account. You can also locate organizations that can help you by searching for community partners.
- Report any changes to your household or income at www.michigan.gov/MIBridges or by calling your local MDHHS office.
- If you get a renewal packet, be sure to fill it out, sign the forms and return it by the due date with any proof needed. NOTE: If you do not complete and return the renewal, you may lose Medicaid coverage.

If you receive notice that you or a family member are no longer eligible for Medicaid or MICHild benefits, don’t worry, you have other options, including for low or no-cost coverage. Having health insurance is important, not just for when you are sick or hurt, but also to help you stay healthy and avoid big medical bills. 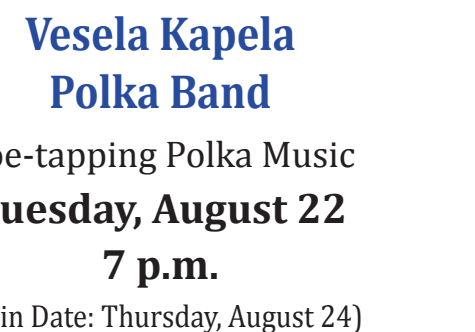
