### **Fowlerville** Wrestling **Team having** championship

#### season

The Fowlerville Wrestling Team is having a championship season. On Wednesday, Jan. 29, the boys won the CAAC Red Division title, then on Saturday, Feb. 1, they won the All-Conference Tournament that included 21 schools in the three divisions. Capping it off was a first-place in the Team Districts this past Wednesday, Feb. 5th.

In all three meets, the Glads defeated top-ranked Mason.

The girls squad, meanwhile, placed first in their All-Conference competition held on Feb. 1st that included 17 schools.

"It was a historical year when both the boys and girls won their respective mega conference tournaments, in addition to the boys winning the league," said Coach Dan Coon. "It could be a long time before that feat is repeated, unless Fowlerville can do it again next year."

The boys earned the Red Division title with a 37-27 win over defending champion Mason, giving them a 5-0 record in duals. The team had previously defeated St. Johns 44-26, Lansing Eastern 65-12, Williamston 49-25, and Haslett 75-4—the other schools in the division.

"The Capital Area Activities Conference is an umbrella conference divided into three groups," noted Coon. "The Blue group comprises the larger schools.




Brayden Packer won 2nd in the recent All-Conference Tournament in the 190 weight class and got a crucial win in the District Championship last Wednesday against Mason.

## God, the Unique Creator

Children, babies... their presence among us older folks often bring out the best in us. With gentle cooing to downright hefty belly laughter, I find that these little people bring a unique type of joy and innocence that overshadows any form of negativity in a room.

Admittedly, I'm not one to gravitate to newborns other than a quick glance and word of congratulations to new parents.

Yet, when it came to welcoming our own two children, and later our four grandchildren, my appreciation for newborns changed with noticeable measure.

For the past several years, I've been serving in children's ministry at our church. Twice a month I'm in a room full of elementary-age children who are ready to shout, sing, and enjoy a Bible teaching through cleverly written videos. I've seen kindergarten age kids grow up and leave our group; they're now part of the middle and high school groups. Being part of their spiritual growth has been a source of great joy and has also given me insight into the unique qualities God places in every person.

Psalm 139: 14 says: "I praise you because I am fearfully and wonderfully made; your works are wonderful, I know that full well".

I remember the very first time I heard all of Psalm 139. We were attending a benefit for a Christian organization, Concerned Women for America. Our guest speaker for the event was Cal Thomas, renowned veteran columnist and commentator who has written for numerous publications. Mr. Thomas' speech that evening focused on looming abortion rates in America and the role we as Christians could take to help save innocent lives. Our event was in the mid-1990s when abortion was making frequent headlines, not unlike our present times.

His speech, his use of Psalm 139 helped to reshape some of my opinions regarding a very sensitive topic, most of which I cannot express with adequate words in a short article. But it was the Psalm itself which burned remaining truths in my mind and heart that every life, every person, is indeed precious to God, created in His image, and with great purpose He is the author and the one who creates the uniqueness we see in everyone we meet.

In my large group of children at church there are the loud noisy ones. Sitting with them on a bench are the more shy, the "let me merely sit here and not be noticed" ones. During worship time I'll see lively kids jumping up and down, doing all the motions that go with each song. Another glance around the room reveals those kids who are happy to stand, hands at their sides, expressionless faces, you know, the ones who "I may be standing but I'm sitting on the inside; you can't MAKE me sing even though I want to but I'm way too cool..."

There are girls decked out in party dresses, some are wearing their comfy leggings. Boys come wearing hoodies, a couple don a button down shirt, maybe one or two will sport a tie. Our kids come in all shapes and sizes, every color of hair and eyes—some need glasses, some need a pair of headsets due to the noise level. Most of them are wiggly squiggly giggly human machines. I love that!

I love that no two people are the same. Even identical twins do not have the same DNA nor do they have the same fingerprint configuration. Though our human eye may not be able to quickly differentiate between a set of twins, by God's design they are unique individuals.

I encourage you to read the entirety of Psalm 139 this week. Take hold of David's words as you discover the power behind God's creation of every person. Marvel in knowing that God knit you together, He knows you and He sees you. You are precious to Him.

Now, I can honestly admit I love being around small children. Their joy is infectious and their antics bring laughter to my spirit. Their love and ability to embrace Jesus and Who He is a beautiful thing to see on a Sunday morning. We've got several little girls who will do cartwheels during worship. We've got girls who sit on a bench holding hands like best friends do... we've got boys who are excited to show off their dance moves when we sing "Church Clap". We've got kids who will ask if they can be the one to say a prayer at the end of our time together.

Jesus' own words offer us a beautiful admonition: "Let the little children come to me, and do not hinder them, for the kingdom of heaven belongs to such as these". (Matthew 19)

I can declare with confidence that children matter to Jesus. Therefore, they can and should hold great significance to us, too.

So, if you need a healthy dose of joy, a measure of hope, an example of innocent jubilation for a beautiful savior, get yourself around some kids at church. And when the music starts, join in for some wild and crazy worship!







# **Livingston Centre Historical Society** planning to restore Kirkland House

The Livingston Centre Historical Society members have been hard at work planning a major restoration project for the Kirkland House at the Fowlerville Fairgrounds Historic Village

The 1859 building will undergo structural repairs and lightweight metal roofs will replace the heavy, asphalt shingle roofs. This project will be done in two phases and is made possible because of proceeds from the recent Fall Fest fundraisers. The contract was signed this past week with a local company, C.L.E. Construction, and the structural restoration will begin as soon as weather permits. A historical restoration's expert will oversee the work.

The house was built for the George Kirkland family on Bull Run Road in Iosco Township and was moved to its current site at the Fowlerville Fairground Historic Village in 1991. Multiple generations of the Kirkland family lived in the house until 1957. The last George Kirkland had three daughters and grandchildren of whom have been crucial in the preservation of this building. The family has been very supportive in the planning of this project, providing a generous donation toward the total cost.

The actual roof replacement is slated to begin sometime in March, initiating phase one of the project. Additional local sponsorship is being sought to complete phase two, a new roof on the single-story portion of the home. Both corporate and individual sponsors are needed, so please consider joining in the effort to preserve this structure which is so important to the history of Livingston County.


Sign of Modern Times: Webberville Schools Bids Farewell to Old Message Display While Retaining Tradition

# Errors in Conway Township's tax bills caused by new computer software

By Steve Horton

The Conway Township Board's purchase of new computer software last year has had some unanticipated problems. The update of the office's BS&A software to the most current, web-based version, converting it from .NET to the CLOUD, resulted in errors in some of the Winter Tax bills that were sent to residents.

One of the errors is that the state equalized value and the assessed value—the latter being the number that is used in calculating the tax amount—appear as the same number on the tax bills, which is incorrect. In a letter posted on the township's website, residents who found this error were advised that this did not affect the amount owed by a property owner on their winter taxes. "It was simply a printing error, generated by the new software," it was noted.

It was also discovered that some of the residents who live within the Webberville School District (along Herrington Road), were charged for the Fowlerville District Library millage on their tax bill. This is an error as only township property owners who live within the Fowlerville School District pay this 1.321 mill levy.

Conway Township Supervisor Mike Brown said that the township board's initial remedy for this overcharge, which was stated in the website letter, was to give the owners a credit on their Summer 2025 Taxes, but added "We are looking at the possibility of reimbursing those residents for the overcharge."

He urged patience, though.

"We're trying to figure this out as fast as we can," Brown said, "but it's going to take time to figure out the new system, and we're also in the middle of the tax season, so there's only so much time."

and Local Assistance Programs. Woolford is one of only two first-term representatives in the Michigan House to receive a chairmanship position. Once pre-enrolled the parent/guardian will need to stop in to the office to sign paperwork and copies will need to be made of driver's license, 2 proofs of verification of address, list of immunizations (or waiver), vision screening and a dental record.



#### From the Scrapbook—

# What's Cookin' was early feature of the newspaper What's Cookin' was an early feature of the Fowlerville

What's Cookin' was an early feature of the Fowlerville News & Views, appearing shortly after the paper began publication in the winter of 1985. With one exception, the format was to profile a local lady and at the end of the article publish one of her favorite recipes. The late Royce Ingersoll did the first few articles, but decided to focus on other pursuits. Dawn Horton then took over the feature.

Here are a few of those ladies who appeared in the newspaper.



Barbara Tannar noted that she grew up in Fowlerville, the oldest child of Ken and Virginia Ganton. She married her classmate Tom Tannar—both of them members of the Class of 1965—who at the time was a middle school teacher and also a coach. He later became the principal of the Fowlerville Junior High. She had a teaching degree, but at the time of the interview was busy with the couple's three children, working three days a week at Utter's clothing store, and was chair of the Howell Area Christian Womens Club. Barbara Tannar was shown here with her daughter Amanda and the family pet 'Kizzy'. She also has two sons: Steve and Gregg.



**Diane Smith** grew up in Buckley, a small town south of Traverse City as did her husband Clare. She ended up in Fowlerville when Clare took a job with Tannar Elevator while earning a degree in grain elevator management at Michigan State University. He later became a partner and then a sole owner, with Diane helping the business by doing office work. The Smiths had purchased the Keesler Furniture Store, located in Downtown Fowlerville, in July of 1984 and a few months later Clare sold the elevator. Diane ran the furniture store with help from her daughter-in-law Bridget, while Clare and son Shannon did delivery. Another son, Chad, was an eighth grader at the middle school.



Waneta Dorrance, known as 'Toots', was a natural for the feature as she was operating the restaurant on North Grand Avenue at the time of the interview with her husband Howard. The diner (now known as Olden Days Café) was called Waneta's. She had grown up in Fowlerville, her maiden name being Klein. The Dorrances were already well-known prior to becoming restaurant proprietors, with Howard being the owner of Howard's Market (now Save-On Family Foods) and Waneta helping out in various capacities. One of the tasks she performed was making her homemade potato salad that was sold at the deli. It was a customer favorite. She noted that one summer she made two tons for the store.



Pam Hibbard grew up in Southern California but, while working for All-State Insurance, she met a young serviceman stationed in the area, named Linwood Hibbard, who had grown up in Fowlerville. After their marriage in 1967, they remained in the Los Angeles area and soon welcomed two sons—Michael and Matthew. However, in 1970, the couple decided to relocate to Lin's hometown. He eventually took classes at MSU and earned his bachelor's and then masters degrees and went into Community Education. At the time of the interview, he was the Director of Community & Adult Education at Fowlerville Schools. Pam, meanwhile, continued her career in the insurance business, landing a position at Citizens Insurance Company in Howell and eventually becoming a supervisor.





Bonnie Wise was the oldest of the seven Baughan children who lived with their parents on a farm north of Fowlerville. In the interview she noted that the family was "close knit." She graduated from Fowlerville High School in 1964, then attended Henry Ford School of Nursing for a year before deciding to not continue. She then married her high school sweetheart, Lenny Wise, and they had two daughters—Heather and Heidi. Having a talent and love for sewing, she taught 4-H classes for 13 years and then instructed adults through a store in Fowlerville called the Pin Cushion. Bonnie eventually secured a real estate license in 1979 and worked for the Century 21 office in town. A few years later she secured a broker's license. When the Century 21 office closed, she went to work as an associate broker at Harmon Real Estate.



Marilyn Carson was a receptionist at the Lintemuth-Mason Century 21 Real Estate office when interviewed in mid-December of 1985—a position she'd held for seven years. She was also a Stanley Home Products demonstrator and was nearing her 25th year with the company. Previous work included being a kitchen supervisor at the elementary school and operating a catering business with her friend Frances Cain. She had attended Fowlerville schools and noted that she was living in the South Handy Township home that had been owned by her grandparents, Will and Audrey Sidell. She was married to Glenn Carson on Jan. 1 1944, and noted that a month later he went overseas as a member of the 5th Armored Division and served in the European Theater Operation that began in June with D-Day. Their oldest son Richard was born later that year and was already a year old when his father returned. Their two other sons include Robert and Randy. She noted that, with the real estate office closing, she looked forward to retiring, but added "I will still continue to sell Stanley products and will remain busy with my organizations—the Handy Sunshine Club, the American Legion Auxiliary, the EasternStar, and the local United Methodist Church.

Of the six ladies remembered here from 40 years ago, four of them—Diane, Waneta, Bonnie, and Marilyn—have passed away.
